PLANNING COMMISSIONER APPOINTMENT

City Clerk Juanita Barnett gave a staff report and answered questions from the Council.

By motion made, seconded (Hopkins/Hunt), and carried, the Council appointed Christine Haggard to serve on the Planning Commission for a term concurrent with Councilmember Hopkins' Council term which expires December 2, 2014.

After reviewing the Planning Commission guidelines, the Council directed staff to bring a recommendation back to the Council to consider amending the residency requirement of the guidelines and to postpone advertising for the vacant commissioner position until amendment of the guidelines may be considered.

FINANCE DEPARTMENT

MID-YEAR BUDGET AMENDMENT; RESOLUTION NO. 11-07

City Manager Dana Shigley gave a staff report and, together with Finance Office Manager Liz Cottrell, answered questions from the Council.

Kim Chamberlain, Anderson resident and veteran's advocate, gave an overview of the history of the Veterans' Park, stating that the property was originally donated to the City of Anderson by Shasta County for veteran housing and that after many years of non-use, the City created a park to honor veterans. She further stated that as an advocate for veterans, she feels that at least part of the proceeds from the sale of the property should be dedicated to honoring veterans since that was its original purpose.

By motion made, seconded (Yarbrough/Hopkins), and carried by a 4-1 vote, the Council adopted Resolution No. 11-07 amending the City's adopted 2010-2011 Budget and adding a single line item transferring one-half (1/2) of the proceeds from the sale of the Veterans' Park to the Anderson Veterans' Walk of Honor (501C), and directed the City Manager to

amend the City's contract with the Anderson Veteran's Walk of Honor (501C) to reflect said change.
