# ANDERSON CITY COUNCIL MINUTES Regular Meeting

## August 20, 2013

#### **REGULAR SESSION**

The regular session of the City Council was called to order at 6:01 p.m.

## **PLEDGE OF ALLEGIANCE**

Councilmember Baugh led the Pledge of Allegiance.

## **INTRODUCTIONS**

Police Chief Michael Johnson introduced new Community Service Officer Dave Coates.

Mr. Coates' son David pinned on his badge, and Mr. Coates thanked the Council for the privilege and opportunity to serve the community.

Assistant City Manager/Finance Director Liz Cottrell introduced new Account Clerk II Tonja King.

Ms. King thanked the Council for the opportunity to serve Anderson.

City Manager/Public Works Director Jeff Kiser introduced new part-time Maintenance Worker Aaron Haley.

Mr. Haley thanked the Council for the opportunity to work for the City.

#### **PROCLAMATION**

Councilmember Baugh read a proclamation recognizing "See the Vision...Live the Dream" 50<sup>th</sup> Anniversary Commemoration of Martin Luther King's 1963 "I Have a Dream..." Speech, and Mayor Yarbrough presented the proclamation to Serena Holmes, Anderson resident and Vice President of the Board of Directors of the Shasta County Multicultural Board.

Ms. Holmes thanked the Council for their support and announced activities scheduled for their August  $24^{th}$  celebration.

## SCHEDULED CITIZEN REQUEST TO ADDRESS THE CITY COUNCIL

Keith Webster addressed the Council representing concerned citizens on East Bailey Drive regarding a drug house in their neighborhood and expressed frustration with the Police Department for not being actively involved in resolving the problem.

Tami Baudizzon expressed appreciation for the Council's willingness to hear their concerns, and expressed her own concerns regarding having a meth house in her neighborhood and for the type of people now hanging out in the neighborhood. She expressed concern for her children and others' children who live and play there. Ms. Baudizzon expressed frustration with the Anderson Police Department for saying "it's not their problem and that residents should contact SINTF." Ms. Baudizzon further stated that this is an Anderson problem and should be treated as such, that Anderson PD is responsible because the thefts and violence this brings affects us all. Ms. Baudizzon encouraged Anderson PD should be proactive in this area and to provide protection for the residents of the neighborhood. Some neighbors have not come forward because they are afraid of retaliation.

Wayne Leonhardt, stated that he lives next door to a meth house that has been there for two years and asked Council if something can be done to change the circumstances.

Chief Johnson apologized to the residents for the impression that they are not being heard and gave a report on what is being done to address this issue and answered questions from the Council.

City Attorney Ann Siprelle informed the Council there is a legal way to shut down proven drug houses by ordinance.

Chief Johnson encouraged residents to call directly to SHASCOM to report problems in this area in order to create a record, and Officer Modin provided the number for SHASCOM as 245-6526.

Chief Johnson further stated he would research the matter brought up by these residents and get back to the Council with an update.

## PUBLIC COMMENT ON ITEMS NOT ON THE AGENDA

Donna Day addressed the Council regarding the release of 10,000 more prisoners into the State of California due to AB109 prison population reduction mandates, expressed her appreciation to Chief Johnson for staying in Anderson, and encouraged citizens to protect themselves through self-defense and preparedness.
