



WHEREAS, it is a pleasure to pay special tribute to Alice D. Evans on the occasion of her 30th anniversary as an on-air personality at WFLT-AM 1420, Gospel Radio; and

WHEREAS, Ms. Evans was born in Flint Michigan on May 5, 1954 weighing a mere 2 lbs. 11 ounces. Soon after birth, Ms. Evans lost her vision. She is the daughter of the late Edmond C. and Minister Adelaide Evans; and

WHEREAS, Ms. Evans attended Durant Turri-Mott Elementary School, Holmes Junior High School and graduated in 1973 from Flint Northwestern High School, 16th in her class of 545 students. In 1977, she graduated from Michigan State University with a Bachelor of Arts degree in Telecommunications; and

WHEREAS, Ms. Evans began her broadcasting career at Flint Central's WFBE-FM as a volunteer. She was also an intern for the show *Soul Spot Light*, which she produced, edited and conducted interviews. While at Michigan State University, she interned for WMSN-AM, and also for one summer at WAMM-AM Urban Radio, in Flint. Her first job was at WWWS-FM in Saginaw, Michigan. While at WWWS, she became known as Alice D "The Soul Dean". She was one of the original staff announcers at 92.7 WDZZ-FM, Flint urban contemporary format. She was also an on-air announcer for five years at WFUM-TV28. She has been at WFLT since February 16, 1987; and

WHEREAS, Ms. Evans has broken through many barriers. Even though she is totally blind, her vision has been clear. She was the first completely blind African American to graduate from Flint Schools, work for General Motors, to graduate from Michigan State University Department of Telecommunications, among many other accomplishments.

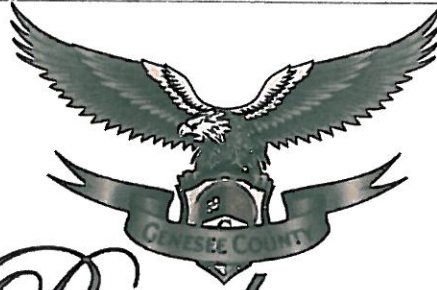
