WHEREAS, a request has been filed by ET Rover Pipeline, LLC ("ET Rover"), with the Federal Energy Regulatory Commission ("FERC") to approve the construction of a natural gas pipeline from processing facilities located in Pennsylvania, West Virginia, and Ohio through Michigan and ultimately to the Union Gas Hub, near Sarnia, Canada; and

WHEREAS, the proposed pipeline route travels through the townships of Atlas, Grand Blanc, Mundy, Fenton, Gaines, and Argentine in southern Genesee County; and

WHEREAS, the proposed pipeline project raises significant questions regarding the effects it would have on the safety and health of County citizens, and on the important and valuable natural resources of Genesee County; and

WHEREAS, this Board recognizes the vital role that the citizens and leaders of the affected townships have in ensuring that the interests of their citizens are protected throughout the evaluation of the ET Rover pipeline proposal by FERC.

NOW THEREFORE, BE IT RESOLVED, by this Board of Commissioners of Genesee County, Michigan, that, in order to ensure that the interests of the citizens of the townships of Atlas, Grand Blanc, Mundy, Fenton, Gaines, and Argentine are adequately considered throughout the evaluation process for the ET Rover Pipeline, this Board urges FERC and ET Rover to ensure that the leaders of the affected townships
