2017 PROCEDURES APPLICABLE TO THE GENESEE COUNTY BOARD OF COMMISSIONERS AND THE BOARD'S STANDING COMMITTEES

GENERAL INSTRUCTIONS

- 1. Standing Committees. As a general rule, items submitted for action by the Board of Commissioners (BOC), other than approving minutes, making an appointment, electing an officer, accepting a report, or adopting a laudatory resolution, should first be considered, and then be referred to the Board, by one of the Board's Standing Committees. The Standing Committees are Finance (FIN), Governmental Operations (GOC), Human Services (HSC), Public Works (PW) and Community & Economic Development (C/ED). All County Commissioners are members of each Standing Committee. These Procedures are designed to require consideration of an item by only one Standing Committee.
- 2. Parent Committees. "Departments" in these Procedures means County budgetary centers and other organizations listed below as having a "Parent Committee." Each Department has a Parent Committee. A Parent Committee is the Standing Committee to which matters regarding that Department are to be submitted if, under these Procedures, that matter does not fall within the responsibilities of any other Standing Committee.
- 3. Submission Due Dates. Agenda items are due by 4:00 p.m. on the Tuesday prior to the Committee meeting.
- 4. Controller or Prosecuting Attorney Approval. Items requiring Controller review, that is, items requiring an appropriation or a budget transfer, or items requiring Corporation Counsel review are due to the Controller or Corporation Counsel by 12:00 Noon ten calendar days prior to the Committee meeting. It remains the Department's responsibility to submit the item to the Board Office for Committee meeting submission upon approval by the Controller or Corporation Counsel.
- 5. Other Appropriate Approvals. Departments must inform appropriate support departments (e.g., Human Resources Department, Purchasing Department, Controllers Office, and Prosecuting Attorney Civil Division) and obtain the support department's approval, when necessary, regarding a proposal prior to submitting it to Committee. For example, Departments must contact the Human Resources Department and the Controller's Office if a new position is to be created or a position is to be reclassified. The item must then be taken to the Finance Committee. Usually the memorandum request is prepared by the HR Department or Controller.
- 6. Failure to Obtain Approval. Failure to obtain approval from the appropriate support department/s may result in removal of the item from the agenda if the item has been placed on the agenda without the necessary approval. For example, failure to obtain review and approval of a contract by the Prosecuting Attorney Civil Division prior to placement on the agenda may result in removal of the item from the agenda until the Prosecuting Attorney Civil Division is able to review and approve the document.
- Cover Memoranda. Agenda items must include a cover memorandum, addressed to the Chairperson of the Committee, stating what action is needed from the Committee. The cover memorandum must include the following information.

- A detailed description of the proposal.
- For travel requests, the purpose of the trip, the dates of the trip, the location of the trip, and the name of any class, seminar, or event that will be attended during the trip.
- The cost to the County under any contract to be approved.
- The funding source, including fund numbers, for payment of any costs to the County.
- If employee related, a single request for each job classification requested (multiple requests for same classification maybe on a single request).

Copies of any documents for which approval is sought must be attached to the memorandum.

- 8. Electronic Submission. All agenda items submitted to the Board Office shall be submitted electronically, either in Adobe PDF or Microsoft Word format.
- Board Approval Not Required. The following items do not require Board or Committee approval:
 - a. Purchases with an annual value under \$5,000.00 made in accordance with Sections 3-104 and 3-105 of the Genesee County Purchasing Regulations.
 - b. Line item transfers authorized by the Controller, <u>not involving overtime or travel</u> workshop, and not exceeding \$5,000. (Resolution 95-224)
 - c. Line item transfers authorized by the Controller, from a line item or items not involving salary, fringes or capital equipment accounts, to a travel workshop line item, provided that such transfers not approved by the Board or a Committee shall not exceed \$5,000 per year in the department's budget. (Resolution 08-480)
 - d. Specific travel that was approved as part of the department's budget in the annual budget process.
- 10. Original Contracts Not to Be Submitted. Original contracts requiring the Chairperson's signature are not to be included with agenda items. Departments should keep the original documents requiring signature until final approval by the Board of Commissioners. Upon approval, documents may be submitted to the Board Office for signature by Chairperson. The requesting department is responsible for the collection of necessary signatures. If a roll call vote is taken at a Standing Committee approving the document and authorizing the Chairperson's signature, documents may be signed the same day of the Committee Meeting and submitted to another entity. Any such signature and submission, however, does not constitute final Board action until ratified by the Board, as distinguished from a Committee.
- 11. Waiver Through Committee and Add Ons. Waiver of items through to the BOC (bypassing the Committee) or to a non-parent Committee and late add-ons to a Committee agenda should be rare. Ideally, requests for waivers and add-ons will be granted only if the requesting department or Genesee County will lose funding if the item is not dealt with at the requested meeting.

If a waiver or add-on is deemed necessary, the Department must:

 Request from the Chairperson of the Committee to be bypassed permission to waive through that Committee.

- b. Obtain approval from the Chairperson of the Committee to which the item will be referred, or from the Board Chairperson if the item is to be presented directly to the Board without having been considered by a Committee.
- c. Notify the Committee Secretary or Board Secretary that permission to waive/add-on has been granted by the relevant Chairpersons, and provide 11 copies of the agenda item to be passed out at the accepting Committee or Board meeting.
- 12. Expedited Action and Roll Call Votes. A Standing Committee may take expedited action on an item by taking a roll call vote. Additionally, roll call votes at Board of Commissioners or Committee Meetings shall occur pursuant to Board of Commissioners Bylaws Rule 6(e) when:
 - a. Voting on ordinances, appointments or elections at Board meetings; or
 - b. Ordered by Chairperson; or
 - c. Requested by 1/3 of Commissioners (Committee Meetings) or 1/5 of Commissioners (Board Meetings).

Approval by ROLL CALL VOTE by a Standing Committee authorizes a Department to take immediate action prior to final ratification by the Board of Commissioners at the next regularly scheduled meeting of the Board of Commissioners. Such expedited action is not considered final until ratification by the Board of Commissioners because the vote may change. The roll call vote does permit internal action to commence, such as posting positions, and, as noted in section 10, obtaining contract signatures.

- 13. Weekly Board Schedule. Departments should refer to the Weekly Board Schedule notice, which is posted on the Board of Commissioners web site each Friday, to ascertain meeting dates, times, and locations. The yearly schedule is a <u>tentative</u> schedule, and subject to change.
- 14. Agenda Availability. Board and Committee agendas with supporting materials are to be available for county commissioners by 5:00 p.m. on the Thursday before the applicable meetings.

GENESEE COUNTY

REGULATION TO PROHIBIT THE SALE OF TOBACCO PRODUCTS TO INDIVIDUALS UNDER 21 YEARS OF AGE

SECTION 1000 - TITLE

This Regulation shall be known as the Regulation to Prohibit the Sale of Tobacco Products to Individuals Under 21 Years of Age.

SECTION 1001 - AUTHORITY

This Regulation is adopted pursuant to authority conferred upon local health departments by Section 2441 of the Michigan Public Health Code, Act 368, P.A. of 1978 as amended, Mich. Comp. Laws § 333.2441.

SECTION 1002 - JURISDICTION AND ADMINISTRATION

1002.1	This Regulation shall have effect throughout Genesee County in all areas incorporated and unincorporated, which includes cities, villages and townships.				
1002.2	The Health Officer shall have responsibility for administering and enforcing this Regulation, including all amendments hereafter adopted unless otherwise specifically stated.				

Nothing in this Regulation shall be construed to restrict or abrogate the authority of any 1002.3 municipality in Genesee County to adopt more restrictive regulations or ordinances.

SECTION 1003 - PURPOSE AND FINDINGS

Genesee County does hereby find:

That tobacco use is the number one cause of preventable death¹ in Michigan² and continues to be an urgent public health challenge, as evidenced by the following:

- 16,200 Michigan adults die from smoking-related diseases every year;³
- Nearly one in ten Michigan youth who are alive today will die from early from smoking-related diseases;4,5,6

According to the Campaign for Tobacco Free Kids, 213,000 kids now under 18 and alive in Michigan will die prematurely from smoking. The U.S. Census estimates that in 2014 there were approximately 2,344,068 Michigan youth under age 18. More than

 Tobacco use can cause disease in nearly all organ systems and is responsible for 87% of lung cancer deaths, 79% of all chronic obstructive pulmonary disease deaths, and 32% of coronary heart disease deaths;7 and

That every year, smoking costs Michigan nearly \$9.4 billion dollars in direct healthcare expenses and lost productivity:8 and

That a Community Health Needs Assessment for Genesee County identified Tobacco Free Living (Anti-Smoking) as one of the 6 major health needs for residents of Genesee County;9 and

That in a survey conducted between 2013 and 2014, 29.4% of residents in Genesee County reported that they smoked every day; 10 and

That in 2014, 22% of mothers in Genesee County smoked during pregnancy compared to 18% of mothers generally in Michigan; 11 and

That nearly 95% of people who smoke start by age 21;12 and

That individuals who begin smoking at an early age are more likely to develop a severe addiction to nicotine than those who start at a later age; 13, 14 and

That the younger people start smoking, the greater their risk of many adverse health outcomes, such as hospitalizations and lifetime risk of respiratory disease, chronic obstructive pulmonary disease, and lung cancer;15 and

one in ten was calculated by dividing the number of youth who will die prematurely (213,000) by the number of youth under age 18 in Michigan (2,344,068).

That Genesee County has the 5th highest number of public schools in Michigan, with 147 public schools altogether serving 68,768 youth;16 and

That tobacco use continues to be a significant public health concern for high school students as evidenced by:

35.8% of Michigan high school students who report they have tried cigarettes;17 and

That the majority of youth under age 18 obtain tobacco through social sources 18 as evidenced by:

- 48.0% of Genesee County high school students, including 58.9% of 11th graders, who report easy access to cigarettes;19
- 15.6% of Genesee County high school students who smoke usually give someone money to purchase their cigarettes;20
- 26.2% of Genesee County high school students who smoke usually receive their cigarettes by asking someone they know for them;21
- 8.4% of Genesee County high school students who smoke usually get their cigarettes from someone 18 years or older;²² and

That youth obtain cigarettes in two ways: commercially (from a store or vending machine) and socially (borrowing, buying, or stealing them from other youth or adults);²³ and

That Genesee County's black and Latino high school students are more likely than white students to buy their cigarettes from stores (27.3% of black students and 35.3% of Latino students versus 18.4% of white students);24 and

That the closer youth are to age 18, the easier it is for them to buy tobacco products from retailers²⁵ as evidenced by:

The percentage of Genesee County high school students who usually buy their cigarettes from stores more than triples between 9th and 11th grade (8.9% of 9th graders usually buy their cigarettes from stores versus 28.8% of 11th graders);26 and

That studies have shown that young adults between ages 18 and 20 are more likely than adults over the age of 21 to purchase tobacco for minors; 27, 28 and

That raising the minimum legal age of access reduces the ability for youth under age 18 to appear legally old enough to buy tobacco products and decreases the probability that nonsmoking youth will have social contact and networks that contain smokers;29 and

That the Institute of Medicine found that raising the minimum legal age of access to 21 will likely delay initiation and reduce tobacco prevalence across all ages with the largest proportionate reduction in initiation likely occurring among adolescents of ages 15-17;30 and

That most individuals transition from experimental to regular smoking before age 21;^{31, 32} and

That tobacco companies target young adults between the ages of 18 to 24 to increase the frequency with which they use tobacco products to encourage them to transition into habitual users;33 and

That studies by tobacco companies have recognized that if "a man has never smoked by the age of 18, the odds are three-to-one he never will. By age 24, the odds are twenty-to-one;"34 and

That studies by tobacco companies have acknowledged that if they do not capture new users by their early 20s, it is unlikely that they ever will;35 and

That the tobacco industry knows that raising the minimum age to 21 will hurt sales and has historically worked to lower tobacco minimum legal age laws from 21 to 18;36 and

That a Philip Morris report has concluded that "[r]aising the legal minimum age for cigarette purchaser to 21 could gut our key young adult market;"37 and

That research has repeatedly found that raising the minimum age of access is an effective strategy for reducing tobacco use among youth and young adults as evidenced by:

- Research that overwhelmingly demonstrated minimum legal drinking age laws decreased alcohol consumption rates in the United States, especially among youth and young adults;³⁸
- An evaluation of Needham, MA's law raising the minimum tobacco sales age to 21 found that within five years the prevalence of youth smoking reduced by nearly half (12.9% in 2006 versus 6.7% in 2010);39
- The Institute of Medicine found that a nationwide law raising the minimum age of legal access to 21 would save almost a quarter of a million lives of people born between 2000 and 2019;⁴⁰ and

That raising the minimum age of purchase may also address racial and ethnic inequities as communities of color are more likely to begin smoking after age 18,41,42,43 and

That fines are one way to increase retailers' awareness of tobacco control policies, which may make it more likely they will comply with the law and increase the number of retailers who refuse to sell tobacco to youth;44 and

That as of September 27, 2016, at least 200 jurisdictions in 14 states have laws raising the minimum legal sale age for tobacco products to 21;45 and

That nationally, 70.5% of people, including 57.8% of people who currently smoke, support raising the minimum age of legal access to 21;46 and

That the minimum sale age for alcohol in Michigan is 21 years of age, and persons under 21 years of age have visibly different drivers' licenses. 47 Raising the minimum sale age for tobacco would streamline identification checks and would establish a uniform age for the purchase of both products; and That tobacco use is a particularly important public health problem facing Genesee County, especially tobacco use among youth, as evidenced by local data; and

That a prohibition on the sale of tobacco products to individuals under 21 is a local solution to the public health problems facing Genesee County; and

That solutions to public health problems can effectively be addressed at the local level, and in many cases local control advances the protection of public health in the local community; and

That the Michigan Supreme Court has ruled that "the [Michigan] Legislature has expressly placed the affirmative duty on local health departments to take measures to safeguard human health;"48 and

That the Michigan Supreme Court has held that local health departments may adopt regulations to properly safeguard public health; 49 and

That the Michigan Supreme Court has emphasized that the Public Health Code is to be "liberally construed for the protection of the health, safety, and welfare of the people of this state."50

Therefore, this Regulation is adopted to safeguard the public health by prohibiting the sale of tobacco products to individuals under 21 years of age.

SECTION 1004 - DEFINITIONS

- "Person" means an individual, partnership, corporation, governmental entity, receiver, trustee, assignee, or any other legal entity.
- 1004.2 "Public Health Code" means the Public Health Code of Michigan, Act 368, P.A. 1978, as amended (Mich. Comp. Laws § 333.1101 et seq.).
- "Tobacco License and Sales to Minors Regulation" means that certain Regulation to Require License for Retail Sale of Tobacco and to Prohibit the Sale of Tobacco to Minors, adopted by Genesee County on November 16, 1993 and made effective on February 14, 1994.
- "Tobacco Paraphernalia" means any item designed for the consumption, use, or preparation of tobacco products.
- 1004.5 "Tobacco Product" means
 - (a) any product containing, made, or derived from tobacco or nicotine that is intended for human consumption, whether smoked, heated, chewed, absorbed, dissolved, inhaled, snorted, sniffed, or ingested by any other means, including, but not limited to cigarettes, cigars, little cigars, chewing tobacco, pipe tobacco, snuff; and
 - (b) any electronic device that delivers nicotine or other substances to the person inhaling from the device, including, but not limited to an electronic cigarette, electronic cigar, electronic pipe, or electronic hookah.
 - (c) Notwithstanding any provision of subsections (a) and (b) to the contrary, "tobacco product" includes any component, part, or accessory of a tobacco product, whether or not sold separately. "Tobacco product" does not include any product that has been approved by the United States Food and Drug Administration for sale as a tobacco cessation product or for other therapeutic purposes where such product is marketed and sold solely for such an approved purpose.

SECTION 1005 – PROHIBITION OF THE SALE OF TOBACCO PRODUCTS AND TOBACCO PARAPHERNALIA TO INDIVIDUALS UNDER 21 YEARS OF AGE

- No person shall sell, give, or furnish any tobacco product or tobacco paraphernalia to an individual under 21 years of age.
- 1005.2 Subsection 1005.1 shall not apply to:
 - (a) A transportation company as defined in Public Act 327 of 1993 as amended (Mich. Comp. Laws § 205.422), provided the transportation company holds a

- valid state license issued pursuant to Public Act 327 of 1993 as amended (Mich. Comp. Laws § 205.421 et seq.)
- (b) A vending machine operator as defined in Public Act 327 of 1993 as amended (Mich. Comp. Laws § 205.422), provided the vending machine operator holds a valid state license issued pursuant to Public Act 327 of 1993 as amended (Mich. Comp. Laws § 205.421 et seq.)
- Any person who is not subject to the restrictions in Subsection 1005.1 (pursuant to Subsection 1005.2) shall not sell, give, or furnish any tobacco paraphernalia to an individual under 18 years of age.

SECTION 1006 - SIGN REQUIREMENT

- Any person who sells tobacco products or tobacco paraphernalia at retail, and who is subject to the sign requirement set forth in Public Act 31 of 1915 as amended (Mich. Comp. Laws § 722.641 et seq.), shall post the sign required by that Act.
- in addition to any applicable sign requirement in Subsection 1006.1, a person who sells tobacco products or tobacco paraphernalia at retail shall post a sign which includes the following statement:

"Genesee County prohibits the sale of tobacco products to any person under 21 years of age."

This sign shall be posted in a conspicuous place:

- (1) Adjacent to any sign required by Subsection 1006.1 if applicable; or
- (2) At or near every point of sale and every display of tobacco products or tobacco paraphernalia if the sign requirement in Subsection 1006.1 does not apply.
- The sign required under Subsection 1006.2 shall be at least 5- ½ inches by 8- ½ inches. The statement required under Subsection 1006.2 shall be clear and conspicuous and shall be printed in boldfaced type no smaller than 36-point.

SECTION 1007 - IDENTIFICATION REQUIREMENT

A person shall not sell, give, or furnish a tobacco product or tobacco paraphernalia to an individual who appears to be under 27 years of age without first examining the identification of the individual to confirm that the individual is at least 21 years of age. The identification must be a document issued by a federal, state, or municipal government, or subdivision or agency thereof, that includes a photo and the date of birth of the individual.

SECTION 1008 - ENFORCEMENT GENERALLY

A person shall not be assessed a penalty under both this Regulation and the Tobacco License and Sales to Minors Regulation for a single, specific violation of this Regulation based on the same facts or specific incident.

SECTION 1009 - PENALTY FOR VIOLATION

A person who violates any provision of this Regulation is guilty of a misdemeanor, as provided in Section 2443 of the Public Health Code, Mich. Comp. Laws § 333.2443. In the case of continuing violations, each day's violation shall constitute a separate offense.

SECTION 1010 - SCHEDULE OF MONETARY CIVIL PENALTIES

- 1010.1 Under authority of Section 2461 of the Public Health Code, the following schedule of monetary civil penalties is adopted:
 - (1) Any person who violates any provision of this Regulation shall be assessed a monetary civil penalty of Fifty Dollars (\$50.00) for the first violation within the tobacco retailer license period.
 - (2) Any person who violates any provision of this Regulation shall be assessed a monetary civil penalty of One Hundred Dollars (\$100.00) for the second violation within the tobacco retailer license period.
 - (3) Any person who violates any provision of this Regulation shall be assessed a monetary civil penalty of Two Hundred Dollars (\$200.00) for the third violation within the tobacco retailer license period.
 - (4) Each day that a violation exists shall be deemed as a separate violation.
- A civil penalty may be appealed to the Health Department within 20 days of receipt of the citation, in accordance with Section 2462 of the Public Health Code. A civil penalty is payable to the Genesee County Health Department and shall be deposited with the Genesee County Treasurer.
- 1010.3 If applicable, an unpaid civil penalty shall be assessed against a tobacco retailer in addition to the regular license fee for the next licensing period.

SECTION 1011 – APPEARANCE TICKETS

The Health Officer and his/her designees are hereby designated as public servants authorized to issue and serve appearance tickets, in accordance with Section 2463 of the Public Health Code, for violations of this Regulation.

SECTION 1012 - INJUNCTIVE PROCEEDINGS

Notwithstanding the existence and pursuit of any other remedy, the Health Officer or his/her designee, without posting bond, may maintain an action in a court of competent jurisdiction for an injunction or other process against any person to restrain or prevent a violation of this Regulation.

SECTION 1013 - OTHER LAWS; CONFLICT

To the extent that any provision in Sections 1006 or 1007 of this Regulation is more restrictive than or in conflict with Sections 1006 or 1007 of the Tobacco License and Sales to Minors Regulation, the provision in this Regulation shall apply.

SECTION 1014 - SEVERABILITY

If any provision, clause, sentence, or paragraph of this Regulation or the application thereof to any person or circumstance shall be held to be invalid, such invalidity shall not affect the provisions of this Regulation which can be given effect without the invalid provision or application, and to this end the provisions are declared to be severable.

SECTION 1015 - EFFECTIVE DATE

This Regulation shall take effect ninety (90) days from and after the date of its approval by the Genesee County Board of Commissioners.

RESOLUTION RE: Misteguay Creek Intercounty Drain Note, Series 2015

WHEREAS, proceedings have been taken by the Drainage Board for the Misteguay Creek Intercounty Drain for improvements to the Misteguay Creek Intercounty Drain (the "Project") pursuant to a petition filed with the Saginaw County Public Works Commissioner under the provisions of Chapter 8 of the Drain Code of 1956, as amended (the "Drain Code"); and

WHEREAS, in order to refinance a note previously issued by the Misteguay Creek Intercounty Drain Drainage District (the "Drainage District") in the principal amount of \$800,000 to pay for certain preliminary costs of acquiring and constructing the Project, the Drainage District issued a note on October 14, 2015 designated "Misteguay Creek Intercounty Drain Note, Series 2015" (the "Note") in the principal amount of \$800,000, bearing interest at a rate of 1.49% per annum, and now maturing on March 1, 2017, in anticipation of bonds (the "Bonds") to be issued by the Drainage District to provide the permanent financing for the Project; and

WHEREAS, 17.0% of the cost of the Project has been apportioned by the Drainage Board to the County of Genesee (the "County"), 43.0% of such cost has been apportioned by the Drainage Board to the County of Saginaw and 40.0% of such cost has been apportioned by the Drainage Board to the County of Shiawassee; and

WHEREAS, by resolution adopted by the Board of Commissioners of the County of Genesee on July 20, 2015, the County of Genesee pledged its limited tax full faith and credit to the prompt payment of 17% of the principal of and interest on the Note when due; and

WHEREAS, the Bonds will not be issued on or before March 1, 2017 and as a result, at the request of the Drainage Board, the purchaser of the Note has agreed to extend the maturity date of the Note from March 1, 2017 to September 1, 2018, bearing interest at a new rate of 1.89% per annum, provided that the County of Genesee, the County of Saginaw and the County of Shiawassee each pledge its limited tax full faith and credit to the Note as extended to the extent that the cost of the Project has been apportioned to each such county; and

WHEREAS, the Project is necessary to protect and preserve the public health and it is in the best interest of the County of Genesee that the maturity date of the Note be extended to September 1, 2018.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF GENESEE:

1. Pursuant to the authorization provided in Section 434 of the Drain Code, the Genesee County Board of Commissioners, by a 2/3 vote of its members, does hereby irrevocably pledge the limited tax full faith and credit of the County of Genesee for the prompt payment of 17.0% of the principal of and interest on the Note when due on September 1, 2018, and does agree that in the event that the Bonds are not issued prior to September 1, 2018 and that moneys are not otherwise available to the Drainage District on such date to pay such principal and interest, the County Treasurer is directed to immediately make such advancement from general funds of the County to the extent necessary to pay the County's share of the principal of and interest on the Note when due. The ability of the County to levy taxes to pay its share of the

principal of and interest on the Note shall be subject to constitutional and statutory limitations on the taxing power of the County.

- 2. In the event that, pursuant to said pledge of full faith and credit, the County of Genesee advances out of County funds, any part of the principal of and interest due on the Note, it shall be the duty of the County Treasurer, for and on behalf of the County of Genesee, to take all actions and proceedings and pursue all remedies permitted or authorized by law for the reimbursement of such sums so paid.
- 3. This resolution shall become effective only if the Board of Commissioners of the County of Saginaw and the Board of Commissioners of the County of Shiawassee each adopt a resolution substantially in the form of this resolution that pledges the limited tax full faith and credit of each respective county to the payment of the principal of and interest on the Note when due on September 1, 2018 to the extent of its apportioned share of the cost of the Project.
- 4 All resolutions and part of resolutions, insofar as the same may be in conflict with the provisions of this resolution, are hereby rescinded.
