COMMUNICATIONS:

Commissioner Henry asked for Sheriff Robert J. Pickell to address the Board to give an update regarding the funding for the Flint City Lock-up facility.

Sheriff Pickell stated that State Representative, Joe Graves, advised him that the legislators took the appropriation out of the budget for the Flint City Lock-Up. He further stated that Mr. Graves was able to get back 1 million in the budget and that there may be another million forthcoming. He urged the Board to try to get the Lock-Up funded by either writing a letter to the Governor or passing a resolution to address the issue.

Discussion ensued.

Commissioner Bryant W. Nolden moved to authorize the Board of Commissioners to send a letter to any and all necessary state government officials, including Dan Kildee, to seek sufficient funds to keep the Flint City Lock-Up open and to authorize the Board Chair to sign a letter on behalf of Genesee County.

Commissioner Clack stated that she was disturbed that Mr. Stair felt comfortable saying those words and she wondered what other Land Bank employees had those same feelings.

Ms. Wildman stated that there will be a staff meeting in the afternoon to address the issue with employees. She stated that Mr. Stair's action doesn't reflect the sentiments of the other staff at the Land Bank.

Discussion ensued.

PUBLIC ADDRESS:

Arthur Woodson, 402 Stewart Ave, Flint, MI, addressed the Board regarding his disapproval of the Land Bank practices and the decision by the Board to declare the water emergency in October for the City of Flint, which he considered to be late.

Timothy Abdul-Matin, 3618 Providence St, Flint, MI, addressed the Board regarding the Land Bank statement.

Commissioner Nolden stated that not all of the Commissioners had the information regarding the Land Bank employee and, therefore, they were not comfortable speaking on the issue because they didn't have the full picture.

Claire McClinton, 129 W. Jamieson, Flint, MI, addressed the Board regarding the Land Bank statement.

Gertrude Marshall, 1408 Walnut Tier Dr., Flint, MI addressed the Board, complaining about the amount of time it took for the Board to declare the water emergency in the City of Flint.
