#### RESOLUTION (17-275)

TO THE HONORABLE CHAIRPERSON AND MEMBERS OF THE GENESEE COUNTY BOARD OF COMMISSIONERS, GENESEE COUNTY, MICHIGAN

#### LADIES AND GENTLEMEN:

WHEREAS, Flint received finished water from the Detroit Water and Sewerage Department ("DWSD") in the proximity of Baxter Road and Potter Road, which was thereafter transmitted through a meter pit and westerly through a 50+ year old seventy-two inch (72") water transmission pipeline, and associated appurtenances to the Flint Water Treatment Plant ("Flint WTP"); and

WHEREAS, in 2010, the county of Genesee along with the counties of Lapeer and Sanilac and the cities of Lapeer and Flint formed the Karegnondi Water Authority ("KWA"); and

WHEREAS, in April 2013, DWSD provided the city of Flint ("Flint") notice that it was terminating Flint's water contract with DWSD; and

WHEREAS, in May 2014, Flint began pumping water from the Flint River to produce finished water at the Flint WTP for delivery to Flint's water customers; and

WHEREAS, either using the Flint River or KWA untreated water as a water source, Flint no longer needed a portion of the seventy-two inch (72") water transmission pipeline from the meter pit located in the proximity of Baxter Road and Potter Road to the KWA connection proposed at Center and Pierson Road; and

WHEREAS, in June 2014, Flint conveyed to the Genesee County Drain Commissioner, as County Agency, pursuant to 1939 PA 342 ("GCDC"), a portion of the seventy-two inch (72") water transmission pipeline, meter pit, and associated appurtenances that begins and includes a meter pit located at the intersection of Potter Road and Baxter Road and proceeds westerly to the approximate location of Center Road and Pierson Road ("Pipeline"); and

WHEREAS, in 2015 Flint, the Michigan Department of Environmental Quality ("MDEQ") and the United States Environmental Protection Agency ("EPA") discovered that the water being provided to Flint residents from the Flint River contained levels of lead which threatened their health and safety;

WHEREAS, in October 2015, as a result of the elevated lead levels in the Flint's water, Flint connected to the Great Lakes Water Authority for the delivery of finished water via a license to transmit water through the Pipeline granted by GCDC; and

WHEREAS, in April 2017, Flint's administration recommended that Flint permanently connect to the GLWA for finished water; and

WHEREAS, Flint now needs the Pipeline conveyed by GCDC to permanently receive water from GLWA; and

WHEREAS, to allow Flint to permanently connect to the GLWA and ensure the reliable delivery of water, GCDC is constructing a forty-two inch (42") water transmission pipeline that parallels the 72" Pipeline to transmit GCDC finished water to GCDC's water customers; and

WHEREAS, once the forty-two inch (42") transmission pipeline is complete, GCDC has no use for the 72" Pipeline.

NOW, THEREFORE, BE IT RESOLVED that this Board of County Commissioners of Genesee County, Michigan, authorizes the Genesee County Drain Commissioner to convey to the city of Flint the 72" pipeline previously acquired by GCDC from Flint, contingent upon successful negotiations with all parties involved in ongoing discussions moving Flint towards a permanent water supply, including as a condition of the conveyance a continued commitment to the debt payment for the KWA pipeline by the city of Flint and/or the GLWA.
