Citizenship

What does it mean to be a “citizen”? What are the rights and responsibilities that go along with being a citizen?

Voting is important, but it is only one small part of being a citizen. Being a good citizen, means, among other things:

- ❑ Caring about your community, state, and country.
- ❑ Understanding your community and its history.
- ❑ Obeying the laws.
- ❑ Paying attention to what is going on. Being well-informed.
- ❑ Understanding your government and how the political system works.
- ❑ Consider running for office and/or working for others who do.
- ❑ Understanding how to treat others with respect.
- ❑ Contributing to society in meaningful ways. In other words: Living a good life, not just making a good living.
- ❑ Giving of one's time, creativity, and money to community, by participating/volunteering in
 - ◆ Government
 - ◆ Civic organizations
 - ◆ Faith-based organizations
 - ◆ Other charitable institutions
 - ◆ Other parts of society
- ❑ Identifying issues and opportunities making them known
- ❑ Identifying assets and solutions to problems, challenges and opportunities.
- ❑ Be a living example for others to emulate.





How to Analyze Issues

What should you do -- and avoid doing -- as a citizen while identifying and analyzing issues?

- ❑ Consider how **your** perspective and background (age, gender, race, ethnicity, religious beliefs, place of origin, residence, income level, experience, etc.) influence how you think about this issue.
- ❑ Consider how other people's perspectives influence how they think about the issue.
- ❑ Don't confuse SYMPTOMS of problems with its causes.
- ❑ Don't jump to conclusions.
- ❑ Don't develop conclusions from limited observations or failing to look at the total situation.
- ❑ Don't distort conclusions beyond the factual base.
- ❑ Don't assume what is true of the piece is also true of the whole
- ❑ Don't judge the ideas being presented simply based on the person representing them.

About the Genesee County 4-H Citizenship Academy

The Genesee County 4-H Citizenship Academy is a collaborative program sponsored by the Genesee County Board of Commissioners and the 4-H Youth Program of Michigan State University Extension in Genesee County. Nine high school aged students, one from each county commissioner district, can be selected to participate in the extensive "hands-on" government/citizenship event. Expenses are provided through Michigan State University Extension.

The academy provides the opportunity for Genesee County youth to develop a better understanding of the role and purpose of local and state government with their commissioner serving as a local mentor.

They complete four three hour meetings learning about local county government, complete an intensive issues identification process, have dinner with the commissioners to present the identified issues, and complete a detailed evaluation of the program. Participants take one full day off from school to sit next to their respective commissioner during an official meeting of the Genesee County Board of Commissioners and then visit up to twelve county departments to question staff and department heads.

Participants also spend four consecutive days in Lansing with approximately 100 other students attending Michigan 4-H Capitol Experience. They attend a legislative breakfast, participate in issue groups, visit with state agencies, lobbyists, and work on mock legislation at the state capitol.
