Jamie W. Curtis, Chairperson of the Genesee County Board of Commissioners, announced that the Board will be taking up the issue of filling vacancies to the following Boards/Commissions, at its regular meeting on September 21, 2015.

For the Senior Citizen Services Advisory Committee, please state your age, whether you have significant experience in direct delivery of services to seniors, and whether you have significant experience in dealing with budgets and financial statements of private, non-profit organizations. Note that, pursuant to the "Plan for Genesee County Senior Citizen Services Millage," individuals who are employees or members of the Board of Directors of any organization receiving or seeking support from the millage are not eligible for appointment to the Committee.

Further, the Board of Commissioners adopted a policy regarding applicants for appointment by the Board of Commissioners to boards and commissions. The Board's appointment policy requires that applicants certify the following:

1. Applicant is a resident of Genesee County and has been a resident of Genesee County for one year prior to consideration for appointment by the Board of Commissioners.
2. Applicant shall be a citizen of the United States, and shall be a registered voter in Genesee County and the State of Michigan.
3. Applicant shall not have been convicted of a crime involving deceit, fraud, or dishonesty.
4. If appointed, applicant may be removed from the appointed position by the concurring vote of six (6) members of the Board of Commissioners if:
 - a. The Board determines that the appointee did not possess all of the qualifications for appointment as stated above, and at the time of appointment, the Board did not know of the appointee's lack of qualifications.
 - b. The Board determines that appointee has ceased to possess all of the qualifications as stated above.
 - c. For any other reason as determined by six (6) members of the Board of Commissioners.

In applying for appointment by the County Board of Commissioners to a position as advertised herein, you certify that you meet the qualifications as specified in the County appointment policy.
