#### LADIES AND GENTLEMEN:

WHEREAS, the State of Michigan and Genesee County received advance notice to expect significant snow fall for the period commencing Wednesday, February 24, 2016 through Thursday, February 25, 2016, and again commencing Tuesday, March 1, 2016, through Wednesday, March 2, 2106; and

WHEREAS, upon consultation with the Chief Judge of the Seventh Circuit Court and the Director of the Genesee County Road Commission, this Board's Chairperson declared a countywide snow emergency commencing at noon, Wednesday, February 24, 2016, through 6:00 p.m., Thursday, February 25, 2016, and on Tuesday, March 1, 2016, commencing at 3:00 p.m. through 6:00 p.m., Wednesday, March 2, 2016, with instruction and notification that all non-essential county personnel were to leave work due to county building closures; and

WHEREAS, the County Policy for Closure of County Facilities adopted July 7, 2015, states as follows:

Employees Excused from Work. If the Chairperson determines that employees are excused from their regularly scheduled work shifts pursuant to this policy:

- Employees subject to a collective bargaining agreement shall be treated in accordance with the terms of the applicable collective bargaining agreement.
- ii. Other employees shall be paid for four (4) hours (including time actually worked) if they were scheduled to work. Employees excused from work shall be credited with four (4) hours pay. (This credit shall not be added to time actually worked). These employees may elect to have the remainder of their shift as unpaid, or paid from their banked Personal Time, Vacation Time or Comp Time. Employees who were not scheduled to be at work because of approved Personal, Vacation, or Comp time will be paid in accordance with that

approved time off, and their Personal, Vacation, or Comptime bank shall be reduced accordingly.

said section thus authorizing payment in accordance with the applicable collective bargaining agreement ("CBA") or, in the case of employees not covered by a CBA, a payment of only 4 hours for the time they were scheduled to work; and

WHEREAS, it is the desire of this Board to pay employees for Thursday, February 25, 2016, and Wednesday, March 2, 2016, in this instance, given that the snow emergency was declared for the full day.

NOW, THEREFORE, BE IT RESOLVED, by this Board of County Commissioners of Genesee County, Michigan, that this Board authorizes and directs the payment to employees not covered by a CBA for the hours the employee was scheduled to work on Thursday, February 25, 2016, and Wednesday, March 2, 2016, but did not work due to the snow emergency declared by this Board's Chairperson, said hours to be straight time hours and not considered hours worked for purposes of calculating overtime.

BE IT FURTHER RESOLVED, that the Director of Human Resources is directed to pursue discussions with each union to provide similar payments to employees covered by a CBA, and authorize the execution of any resulting Letters of Agreement containing a similar provision.

BE IT FURTHER RESOLVED, that the decision of this Board to authorize compensating employees in this instance has been made in this instance only, and shall not serve as precedent for future payments during declared emergencies or closures.
