Genesee Health Plan Facts

Genesee Health Plan has provided life-saving health care to 60,000 people. Dollars raised locally generate millions of dollars in federal funding for health care in Genesee County.

100% of local millage funds go to direct health care. Administration is covered by state revenues, hospital payments and grant funds. Every millage dollar stays in Genesee County.

Administration is extremely efficient. Michigan county health plans average \$5 per member per month for administration; Genesee Health Plan costs are \$3 per member per month.

GHP coordinates an urgent dental program to help the most serious cases. 371 people were helped during 2011. GHP also provides a limited mental health program funded by Genesee County Community Mental Health. Over the past four years 4,688 people have received 42,140 mental health visits.

GHP provides disease prevention, disease management and health navigators for all county residents, resulting in an 82% improvement in healthy behaviors.

GHP coordinates services with Genesee County Health Department. Mammograms for low-income women have quadrupled.

GHP provides prescription drug assistance to all county residents. Free durable medical equipment and low-cost eyeglasses for county residents are also provided.

GHP provides veterans help with access to health care and links all county residents to community resources.

Here are a few of Genesee Health Plan's accomplishments:

- Thanks to the Genesee Health Plan, since 2005, mammograms and preventative screenings for women have quadrupled
- The health plan has provided life-saving health care to 60,000 people over the last 10 years
- Thanks to the Genesee Health Plan, since 2005, the number of uninsured children is down by 25 percent
- Since 2005, emergency room visits by people enrolled in the Genesee Health Plan are down 51%, saving local hospitals millions of dollars in uncompensated emergency room care.

The Genesee Health Plan has won a national quality award for patient care and access There is independent oversight to make sure funds are going directly to patient care and are not being misused

Overview of Genesee Health Plan

The Genesee Health Plan is a non-profit Michigan corporation and one of the 27 county health plans covering 79 Michigan counties. In all 79 of these counties, the county health plans provide services to low-income, uninsured individuals enrolled in the State of Michigan's Adult Medical Program (also known as the Adult Benefits Waiver, or ABW).

GHP's "Plan A" covers residents with incomes from 0-35% of the federal poverty level. GHP's "Plan B" provides primary care and other ambulatory health care to low income residents of Genesee County with incomes from 36%-175% of the FPL. Plan B is funded through the Health Services Millage, which Genesee County voters passed in 2006.

One role of the County Health Plans is to partner with local hospitals. GHP has agreements with local hospitals that make the hospitals qualified to receive additional funding from a special component of Michigan's Medicaid program through the state Department of Community Health. This special program is financed by eligible county funds electronically transferred to MDCH and by matching federal dollars. These funds support hospitals that serve Medicaid and uninsured individuals. This program brings federal dollars to the community that would otherwise stay in Washington or go to other states or communities. Because of GHP's contracts with area hospitals and its participation in this program, area hospitals have additional funds they would not otherwise have to cover the costs of serving low-income residents. Dollars raised by the county will generate millions of dollars in additional federal funding for health care in Genesee County.

Genesee County has benefitted greatly from this financial arrangement. As hospitals receive the special funding, they see GHP as a good place to invest money in primary and preventive health care that can keep uninsured county residents healthier. This in turn reduces unnecessary or preventable use of emergency rooms and helps prevent costly hospitalizations.

Through its relationships with local hospitals, GHP also satisfies the County's Resident County Hospitalization obligation by providing funding to local hospitals for their uncompensated inpatient care.

This millage is not a tax increase. This millage will continue what is already in place.

Health Services Millage Renewal

The Genesee County Health Care Services Millage will expire at the end of this calendar year. Corporation Counsel, in cooperation with the Genesee Health Plan Steering Committee, has developed the attached draft resolution and ballot language for use by the Board of Commissioners in its deliberations as to whether to place the question of renewing the Health Care Services Millage onto the ballot.

Background

On November 7, 2006, the Genesee County electorate authorized the levy of the Genesee County Health Care Services Millage, a 1.0 mill property tax increase for the purpose of providing an affordable health care services delivery system. The millage was authorized for a period of 7 years, 2006 through 2012, inclusive, and the Board's authorization to levy the millage will expire at the end of 2012.

The Health Care Services Millage provides funding for health care for low income residents in Genesee County. It does this in three ways: First, the millage is used to fund direct uncompensated health care provided through clinics operated by the Genesee County Health Department. Second, the Health Care Services Millage funds primary care and other ambulatory health care to low income residents of Genesee County through a contract with the Genesee Health Plan. Finally, some portion of Health Care Services Millage funds are reserved for the Indigent Trust Fund, which is used by the State, along with funding from other sources, as matching funds for federal Medicaid grants to County hospitals to fund uncompensated health care.

Next Steps

If the Board of Commissioners determines to seek renewal of the Health Care Services Millage, the Board must place the question of authorizing renewal of the millage on the ballot at a special election.

Corporation Counsel advises that the Board of Commissioners must certify the ballot question to the Clerk on or before August 28, 2012, in order to place the question on the November 6 General Election ballot. The attached draft resolution calls for a special election on November 6, 2012, and specifies the ballot question language.

WHEREAS, Public Act 375 of 2010, MCL § 333.13101, et seq ("Public Act 375"), effective January 1, 2011, provided a comprehensive statewide regulatory scheme for the regulation of body art establishments; and

WHEREAS, the provisions of the County Body Art Regulation are inconsistent with the provisions of Public Act 375; and

WHEREAS, the Health Department conducted a public hearing concerning rescission of the County Body Art Regulation on April 4, 2012, with notice to the public of the hearing published in the Flint Journal, a newspaper of general circulation within Genesee County, on March 20, 2012, and March 22, 2012; and

WHEREAS, the Health Department has determined, based on the inconsistency between the County Body Art Regulation and Public Act 375, and the comments and information received at the public hearing held on April 4, 2012, to rescind the County Body Art Regulation.
