ACCOMMODATION TAX REVENUE MANAGEMENT MEMORANDUM OF UNDERSTANDING BETWEEN GENESEE COUNTY AND

GENESEE COUNTY PARKS AND RECREATION COMMISSION JULY 1, 2015 THROUGH JUNE 30, 2020

This Memorandum of Understanding is entered into as of the 1st day of July, 2015, between the County of Genesee, Michigan, 1101 Beach Street, Flint, Michigan 48502 (hereinafter "County"), and the Genesee County Parks and Recreation Commission, 5045 Stanley Road, Flint, Michigan 48506 (hereinafter "Commission") (together, the "Parties").

WHEREAS, the County wishes to promote and encourage tourists and convention business in the County; and

WHEREAS, the County is in receipt of accommodation tax ordinance revenue to be spent for the financing of the acquisition, construction, improvement, enlargement, repair, or maintenance of convention and entertainment facilities; and

WHEREAS, the Commission is the custodian and operator of Historic Crossroads Village and Huckleberry Railroad, and it is to the mutual advantage of both the County and Commission to provide for maintenance of these facilities; and

WHEREAS, the Parties have previously entered a Memorandum of Understanding ("MOU") for the services that are the subject of this agreement, and the Commission has demonstrated it is able to operate and maintain the Historic Crossroads Village and Huckleberry Railroad.

NOW THEREFORE, the parties do mutually agree as follows:

- 1. The services to be rendered by the Commission to the County under this MOU include repair and maintenance of the County-owned and Commission operated facilities known as the Historic Crossroad Village and Huckleberry Railroad.
- 2. Payment by the County to the Commission for the aforementioned services shall be 25% of the accommodation tax revenue net, calculated after subtracting the \$20,000.00 per fiscal year revenue to be retained by the County for administration expenses, for the period of July 1, 2015 through June 30, 2020, payable on a quarterly basis.
- 3. Said quarterly payments will be made by the Genesee County Controller within the month following the end of the respective quarter.
- 4. The Commission agrees that the County Controller may, at any time, request a report from the Commission specifying how the funds are being spent or committed. The Commission agrees to submit a full report concerning the expenditures of sums paid pursuant to the contract, said report to be filed with the County controller no later than March 1st for the preceding year.
- Within 60 days after the close of the fiscal year of the Commission that said funds shall be used solely for the services called for in this MOU.

- 6. It is expressly understood and agreed by the County and Commission that said funds shall be used solely for the services called for in this MOU.
- 7. It is agreed that the County, through its Controller, may have access to the books and accounts of the Commission at all times.
- 8. The allocation of revenue will be coordinated with the fiscal year of both the County and the Commission.
- 9. The Commission hereby agrees it will at all times indemnify and hold the County harmless from and against every claim, demand, liability, loss damage, cost, charge, counsel fee, expense, suit, order, judgment and adjudication whatsoever hereafter the County in consequence of any act or omission by the Commission in the performance of this contract and the Commission will provide the County with funds to meet same before the County shall be required to make payment.
- 10. This MOU is for the period of July 1, 2015 through June 30, 2020.

MARKETING AGREEMENT BETWEEN GENESEE COUNTY AND

FLINT & GENESEE CHAMBER OF COMMERCE

for the term
JULY 1, 2015 through JUNE 30, 2020

THIS AGREEMENT, by and between the COUNTY OF GENESEE, Michigan, a municipal corporation (hereinafter referred to as the "County"), 1101 Beach Street, Flint, Michigan 48502, and the FLINT and GENESEE CHAMBER OF COMMERCE, a Michigan nonprofit corporation (hereinafter referred to as the "Chamber"), is effective as of the 1st day of July, 2015.

WITNESSETH:

WHEREAS, the Chamber was organized to enhance community development, economic vitality, and quality of life throughout the County of Genesee, Michigan; and WHEREAS, the County desires to avail itself of the services of the Chamber for the benefit and prosperity of its inhabitants.

NOW THEREFORE, for and in consideration of the mutual covenants hereinafter contained, it is hereby agreed as follows:

FIRST: The County hereby hires and the Chamber to provide marketing support for attractions within Genesee County, and to promote tourism and convention business within Genesee County as detailed herein, and the Chamber accepts such employment and agrees to discharge such duties all in accordance with the terms and conditions herein set forth.

SECOND: The Chamber is hired as an independent contractor and is not an employee or agent of the County. All employees shall be employees of the Chamber which shall be solely responsible for all income and social security tax withholdings and the provisions for workers' compensation and unemployment compensation benefits. No employee, agent, or servant of the Chamber shall hold himself or herself out as a representative of the County.

THIRD: The marketing support and promotion services to be rendered by the Chamber to the County under this contract include, but are not limited to, the following:

- A. To conduct an aggressive marketing, promotion and sales campaign stressing Genesee County's attributes as a convention and tourism destination.
- B. To prepare and distribute as widely as possible, printed material and other promotional tools regarding convention and tourism opportunities in Genesee County.
- C. To solicit and secure conventions, business meetings, group tours and other group functions for Genesee County, and to assist groups in making local arrangements, and to operate a hotel room-available clearinghouse.

- D. To define and promote various tourism attractions, activities and points of interest throughout Genesee County.
- E. To coordinate an ongoing relations effort informing Genesee County residents of the importance and value of convention and tourism activity in their County.
- FOURTH: Within thirty days after January 1, 2016, July 1, 2016, January 1, 2017, July 1, 2017, January 1, 2018, July 1, 2018, January 1, 2019, July 1, 2018, January 1, 2019, July 1, 2019, January 1, 2020, and July 1, 2020, the Chamber shall submit in writing to the Genesee County Board of Commissioners a report detailing the marketing support and promotion services provided by the Chamber pursuant to this Agreement for the six month period immediately preceding the specified dates. At a minimum, the biannual report shall include:
 - A. A summary of the marketing support and promotion services provided by the Chamber during the preceding six months.
 - B. A description of each item of printed material published by the Chamber as a part of the marketing support and promotion services during the preceding six months, the number of copies that were distributed, and the method of distribution. A copy of each item must be attached to the report.
 - C. A description of each advertising item, whether print, audio, or video, produced or commissioned by the Chamber pursuant to this Agreement. A copy of each advertising item so described must be provided with the report.
 - D. A description of each public event, sporting event, convention, business meeting, or group tour scheduled by the Chamber pursuant to this Agreement. The description must include the nature of the event, the number of persons attending, the location of the event, and the date of the event.
 - E. A summary of hotel bookings arranged by the Chamber pursuant to this Agreement.
 - F. A summary of any changes or upgrades made to the Chamber's website and relating to the services provided pursuant to this Agreement, with an emphasis on an increase in the features or capacity of the Chamber's website.
 - G. Any other information related to the Chamber's performance of this Agreement reasonably requested by the Genesee County Board of County Commissioners in writing.
- FIFTH: Upon written notification from the County Treasurer that a person (as defined in subsection 2(d) of the Accommodation Ordinance adopted by the County of Genesee pursuant to 1974 PA 263 (MCL 141.861 et seq.), and attached hereto as Exhibit 1 (the "Accommodation Ordinance") engaged in the business of providing rooms for dwelling, lodging, or sleeping purposes to transient guests, is more than sixty (60) days delinquent in payment to the County Treasurer of the revenues levied and assessed to that person under the Accommodation Ordinance, the

Chamber shall not further provide for the benefit of that person, any of the services required by this Agreement, until further notice by the Treasurer that the person has cured the delinquency by payment of the revenues due to the County by that person.

SIXTH: Within sixty (60) days after the close of the fiscal year of the Chamber, the Chamber will deliver to the County, a financial operating statement of the business of the Chamber related to the services provided pursuant to this Agreement, in such detail and with such supporting documents as the County may reasonably request.

SEVENTH: The County Controller shall, upon reasonable notice, have access to the books and records of the Chamber reasonably necessary to enable the County Controller to determine the financial condition of the Chamber related to the services provided pursuant to this Agreement.

EIGHTH: It is expressly understood and agreed by the County and the Chamber that such funds as are issued to the Chamber by the County pursuant to this Agreement shall be used by the Chamber solely for the purpose of fostering tourism in Genesee County and securing conventions to be held in Genesee County. The Chamber shall use every reasonable effort to promote all regions of Genesee County and to assist such Genesee County communities as request assistance in promoting their affairs and activities. In all events, services of the Chamber shall be available to all areas of Genesee County.

NINTH: It is understood and agreed that this Agreement may be terminated by either party for Cause. For this purpose "Cause" for termination shall mean:

A. For the County to terminate – the Chamber's willful and continued failure to substantially perform its duties pursuant to this Agreement, after a written demand for performance is delivered to the Chamber by the County, which demand specifically identifies the manner in which the County believes the Chamber has not substantially performed its duties pursuant to this Agreement, and the Chamber has not cured such nonperformance in all material respects within sixty (60) days after the Chamber's receipt of that notice.

B. For the Chamber to terminate – failure of the County to timely remit accommodation tax revenue collected pursuant to the Accommodation Ordinance within five (5) days of the due date provided in the paragraph captioned tenth hereof, or the Accommodation Ordinance shall be modified in any way materially adverse to the Chamber or shall cease to be effective.

TENTH: It is understood and agreed that this Agreement may be terminated by the County upon ninety (90) days written notice if the County Board of Commissioners determines that such termination is in the best interests of the County.

ELEVENTH: As compensation for the aforementioned services, the Chamber shall receive seventy-five percent (75%) of the revenues collected by the Genesee County Treasurer pursuant to the Accommodation Ordinance,

calculated after annual administrative expenses of collection in the amount of Twenty thousand (\$20,000) dollars are subtracted from gross accommodation tax revenues, for the time period from July 1, 2015 through June 30, 2020. The County shall remit said collections (including late payment charges, interest, and penalties as provided in the Accommodation Ordinance) of accommodation tax revenue, quarterly, during each calendar year, to the Chamber on or before the thirtieth (30) day of the month following the end of the preceding quarter.

TWELFTH: No later than ninety (90) days after the close of the Chamber's fiscal year, the Chamber shall provide to the County an audited financial statement for the preceding fiscal year and a proposed budget relating to the services to be provided pursuant to this Agreement for the ensuing fiscal year.

THIRTEENTH: The term of the Agreement shall be from July 1, 2015 through June 30, 2020, unless terminated in accordance with the provisions of paragraphs captioned NINTH or TENTH hereof.

FOURTEENTH: All other agreements between these parties regarding Accommodation Tax revenues and marketing services are hereby rescinded.
