Resolution Creating a Community Mental Health Authority

Resolution	#	

WHEREAS the Genesee County Board of Commissioners desires to improve the quality of mental health services provided to its residents; and

WHEREAS, pursuant to the Mental Health Code, MCL 330.1001 et seq.

(hereinafter referred to as the "Code") there is an option to create a Community

Mental Health Authority with powers and duties set out in Section 205, MCL 330.1205;

and

WHEREAS the Genesee County Board of Commissioners has determined that the Mental Health Authority structure provided in MCL 330.1205 would better serve the County's residents by enhancing the effectiveness of mental health services; and

WHEREAS the Genesee County Board of Commissioners has conducted three (3) separate public hearings on July 25, 2012, August 1, 2012, and August 15, 2012, on the issue of the creation of a Community Mental Health Authority, with notice of the hearings given pursuant to the Open Meetings Act, being MCL 15.275 *et seq*.

NOW, THEREFORE, BE IT RESOLVED that:

A. <u>Creation.</u> There is hereby created a Genesee County Community Mental Health Authority (hereinafter "Community Mental Health Authority" or "Authority") pursuant to the Code, Section 205, MCL §330.1205 to carry out the requirements under the Code. The existing Genesee County Community Mental Health Services program (hereinafter "CMH" or "CMH Agency") is dissolved upon the effective date of

the creation of the Authority. The proposed effective date for the creation of the new authority is September 30, 2012.

- B. Board Member Composition.
- (1) The Community Mental Health Board will consist of twelve (12) members.
 - (2) The composition of the Board shall be representative of:
 - Providers of mental health services
 - Recipient or primary consumers of mental health services
 - Agencies and occupations having a working involvement with mental health services, and
 - The general public
 At least one-third (1/3) of the membership shall be primary consumers
 or family members, and of that one-third (1/3) at least two (2) members
 shall be primary consumers. All Board members shall be 18 years of age
 or older.
 - (3) Not more than four (4) members may be County Commissioners. No more than one-half of the total Board members may be state, county, or local public officials. For purposes of this section, public officials are defined as persons serving in an elected or appointed public office or employment more than twenty (20) hours per week by an agency of federal, state, city or local government.
 - (4) A Board member shall have his/her place of residence in Genesee County.

- (5) No employee of the Michigan Department of Community Health (MDCH) or the Authority, or an employee or representative of an agency having a contractual relationship with the Authority may not be appointed, nor shall he/she serve on the Board.
- (6) The following persons are hereby appointed as Board Members of the Genesee County Community Mental Health Authority and shall serve in accordance with the provisions of the Act for the terms noted.

- (7) The Genesee County Community Mental Health Authority Board may recommend prospective appointments to the Genesee County Board of Commissioners for consideration.
- C. <u>Term of Board Membership</u>, Vacancies, Removal from Office.
- (1) The term of an Authority Board member shall be three (3) years from April 1 of the year of appointment. Current members shall continue to serve the remainder of the appointed terms upon the terms and conditions set forth herein.

- (2) Vacancies shall be filled for unexpired terms in the same manner as original appointments.
- (3) A board member may be removed from office by the Genesee County

 Board of Commissioners for either neglect of official duty or misconduct
 in office after being given a written statement of reasons and an
 opportunity to be heard on the removal.
- D. <u>Board Members Compensation/Reimbursement.</u>
- (1) Per Diem
 - (a) A Board member shall be paid a per diem no larger than the highest per diem for members of other county advisory boards set by the Genesee County Board of Commissioners and be reimbursed for necessary travel expenses for each meeting attended.
 - (b) A Board member shall not receive more than one (1) per diem payment per day regardless of the number of meetings scheduled by the Board for that day.
 - (c) The Authority Board shall seek reimbursement from the MDCH subject to its rules and regulations for per diem payments made to the members of the Authority Board pursuant to the Code, Section 224, MCL §330.1224.
- (2) Mileage Reimbursement. The mileage expenses shall not exceed the mileage reimbursement as determined by the State Officers

 Compensation Commission.

- (3) The Authority Board members shall be eligible for necessary other expenses and reimbursements which shall not exceed those received by the Genesee County Board of Commissioners with respect to conferences, seminars and other Authority Board related activities.
- E. <u>Purpose and Power</u>. The purpose and the power to be exercised by the Authority shall be to comply with and carry out the provisions of the Code. The Authority shall provide a comprehensive array of mental health services appropriate to conditions of individuals who are located within its geographic service area, regardless of an individual's ability to pay. The array of mental health services shall include, at a minimum, all of the following:
 - (1) Crisis stabilization and response including a 24-hour, 7-day per week, crisis emergency service that is prepared to respond to persons experiencing acute emotional, behavior, or social dysfunctions, and the provision of inpatient or other protective environment for treatment;
 - (2) Identification, assessment, and diagnosis to determine the specific needs of the recipient and to develop an individual plan of service;
 - (3) Planning, linking, coordinating, follow-up, and monitoring to assist the recipient in gaining access to services;
 - (4) Specialized mental health recipient training, treatment, and support, including therapeutic clinical interactions, socialization and adaptive skill and coping skill training, health and rehabilitative services, and prevocational and vocational services;
 - (5) Recipient rights services;

- (6) Mental health advocacy;
- (7) Prevention activities that serve to inform and educate with the intent of reducing the risk of severe recipient dysfunction;
- (8) Services designed to divert persons with serious mental health illness, serious emotional disturbance, or developmental disability from possible jail incarceration when appropriate. These services shall be consistent with policy established by the department; and
- (9) Any other service approved by the MDCH.

Services shall promote the best interests of the individual and shall be designated to increase independence, improve quality of life, and support community integration and inclusion. Services for children and families shall promote the best interests of the individual receiving services and shall be designated to strengthen and preserve the family unit if appropriate. The community mental health services program shall deliver services in a manner that demonstrates they are based upon recipient choice and involvement, and shall include wraparound services when appropriate.

- F. Duration and Termination.
- (1) The duration of the Authority shall be perpetual unless terminated as hereinafter provided.
- (2) Termination may be accomplished by a resolution passed by a majority of the Genesee County Board of Commissioners. The date of termination shall be set by the County Board of Commissioners' terminating resolution. In the event the terminating resolution made by the County

Board of Commissioners would result in a termination of Genesee County's participation in any community mental health services program, then the date of termination shall be no sooner than one (1) year following receipt of notification by the Michigan Department of Community Health, unless the Director of that Department consents to an earlier termination date. In the interim between notification and official termination, the Authority shall be maintained in good faith subject to the requirements of the Code.

- G. <u>Dissolution and Return of Net Financial Assets.</u>
- (1) In the event of termination of the Authority, all net financial assets originally made available to the Authority by Genesee County shall be returned to Genesee County.
- (2) All assets not returned to Genesee County shall be transferred to the community mental health services program or programs that replace the Authority.
- (3) It is understood that neither the County nor the CMH Agency owns any property currently used by the CMH Agency. All CMH property is owned and maintained by the Greater Flint Mental Health Facilities Board, a section 501(c)(3) organization incorporated under the applicable Michigan laws. If the Authority is terminated, all property used by the Authority will remain under the ownership and control of the Facilities Board.

- H. Assumption of County Liability.
- (1) The Authority shall be liable for any and all costs, liabilities and expenses associated with real or personal property purchased or leased by Genesee County for use by the Genesee County Community Mental Health Services program to the extent necessary to wholly discharge Genesee County's financial liability unless otherwise provided for in a negotiated agreement between Genesee County and the Authority.
- (2) In keeping with the Mental Health Code (MCL §330.1205) the Genesee County CMH's audit liability identified and addressed in the settlement agreement of November 2003, automatically transfers to the Genesee County CMH Authority upon its creation. This routine transfer in no way violates any of the terms and conditions of the settlement agreement previously entered into between the State, the County, and CMH.
- I. <u>County Annual Local Match</u>. For so long as State law requires an annual match of local funds to support a County Community Mental Health Services Program, Genesee County shall appropriate in its annual budget a single allocation to the Authority in an amount which shall not exceed the amount of funds statutorily required to be provided by Genesee County to the Genesee County Community Mental Health Services program as county match.
 - J. <u>Employees of the Community Mental Health Authority</u>.
 - (1) Employees of the Authority are public employees. The Authority and its employees shall be subject to PERA, Act No. 336 of the Public Acts of 1947, being MCL §§ 423.201 to 423.317.

- Upon the creation of the Authority, the employees of CMH shall be transferred to the Authority and appointed as employees subject to all rights and benefits to which they are entitled. Further, their seniority at the Authority shall include all seniority acquired under the applicable contract or policy while employed at CMH and shall be measured as of their last day of employment at CMH.
- Such employees of the Authority shall not be placed in a worse position by reason of the transfer for a period of one (1) year with respect to workers' compensation, pension, seniority, wages, sick leave, vacation, health and welfare insurance, or any other benefit that the employees enjoyed as employees of the Genesee County Community Mental Health Services program. Employees who are transferred shall not by reason of the transfer have their accrued pension benefits or credits diminished.
- (4) Upon creation of the Authority, the collective bargaining agreements currently covering the employees of CMH shall be assumed by the Authority and the Authority shall be bound by the provisions of those collective bargaining agreements. The formation of the Authority shall not adversely affect any existing rights and obligations contained in the existing collective bargaining agreements.
- (5) An employee of the Authority is not a Genesee County employee. The Authority is the employer with regard to all laws pertaining to employee and employer rights, benefits and responsibilities.

- K. <u>Transfer of Assets</u>.
- (1) Upon the effective date of the creation of the Authority, all assets, debts and obligations of the existing CMH including, but not limited to, equipment, furnishings, supplies, cash, and other personal property, shall be transferred to the Authority. Notwithstanding the foregoing, the Authority agrees to continue to maintain for three years following the effective date of Authority status its cash assets in the Genesee County bank account. The Authority shall indemnify and hold harmless the County from any and all liability in regard thereto.
- (2) Satisfaction of the preceding paragraph K (1) of this Resolution, with respect to motor vehicles and insurance on those vehicles, shall be as provided in the remaining provisions of this paragraph. "Insurance", for this purpose means coverage provided through the Genesee County Self Funded Property/Casualty Program Trust (hereinafter "the Property/Casualty Trust"), irrespective of the degree to which such coverage is through retention of risk rather than obtaining insurance. A list of motor vehicles (hereinafter referred to as "the Vehicle List") being all of the motor vehicles which, as of the adoption of this Resolution, are assets of the Community Mental Health Agency within the meaning of Section 205(3)(a) and this Resolution, and being a list titled "ATTACHMENT A CMH VEHICLE LIST", is attached to this Resolution. (The Vehicle List also includes an entry for a utility trailer, which is not a motor vehicle. A "motor vehicle" for purposes of this

paragraph, refers to a vehicle for which a State of Michigan motor vehicle title has bee or could be obtained.) Genesee County, the Authority and CMH shall sign and deliver any documents necessary to transfer to the Authority title to all of these vehicles, and of any motor vehicles subsequently purchased by Genesee County or the Agency for use by the Agency, to the extent such vehicles have not been sold by the County or the Agency prior to the date on which the Authority comes into existence, such title transfers to be effective however no earlier than that date. The Authority shall deliver to the Genesee County Risk Coordinator copies of the titles in which the Authority is designated as the owner, as to all vehicles transferred from the County or CMH to the Authority. The Genesee County Controller shall calculate the Fiscal Year 2011-2012, and/or as applicable, Fiscal Year 2012-2013 allocations to CMH of the respective costs of the Self-Insured Trust Pool for motor vehicle liability insurance and of the Property/Casualty Trust for motor vehicle physical damage in the same manner as allocations are calculated for other Genesee County agencies and budgetary departments. The allocations will be initially calculated and charged for the entire fiscal year(s), as if CMH would continue in existence through that year. If CMH has satisfied those charges, the Property/Casualty Trust and the Self-Insured Trust Pool will remit to the Authority respective portions of those allocations which have the same proportion to the total allocations as does the portion of the 2011-2012 fiscal year

remaining upon, and commencing with, delivery to the Risk Coordinator of the copies of the titles designating the Authority as owner, to the entire fiscal year. If to any extent the Trusts do not make any remittances provided for in the immediately preceding sentence, Genesee County will instead provide those remittances to the Authority. If the Agency had not satisfied those initial allocations, and the Authority has come into existence, the Authority will promptly pay to the Genesee County Treasurer the respective portions, of the initially allocated amounts, that would not have been remitted to the Authority had those allocations been satisfied by CMH. (As an informational item, it is noted that the fiscal year 2011-2012 allocations to CMH were \$19,905 for motor vehicle liability and \$10,453 for motor vehicle physical damage.)

- (3) The fixed assets to be transferred to the Authority are valued at approximately \$1,848,430.00 as stated in the Fiscal Year 2010-2011 audited Financial Statement, with documentation of individual asset valuations attached to this resolution as Attachment B, which shall be incorporated into and made a part of this resolution by reference. This fixed assets total will be adjusted to reflect the appraisal amounts for assets currently not valued.
- L. All contracts regarding mental health services will be transferred to the Authority. The Authority may obtain a novation of contracts.

- M. Privilege and Immunities from Liability. All the privileges and immunities from liability and exemptions from laws, ordinances, and rules that are applicable to county community mental health agencies or community mental health organizations and their board members, officers, and administrators, and county elected officials and employees of county government are retained by the Authority and the board members, officers, agents, and employees of an Authority created under Section 205 of the Code.
- N. <u>Powers of the Community Mental Health Authority</u>. In addition to other powers of a Community Mental Health Services program as set forth in the Code, the Authority has all of the following powers:
 - (1) To fix and collect charges, rates, fees or other charges and to collect interest;
 - (2) To make purchases and contracts;
 - (3) To transfer, divide, or distribute assets, liabilities, or contingent liabilities;
 - (4) To accept gifts, grants, or bequests that determine the manner in which those gifts, grants, or bequests may be used consistent with the donor's request;
 - (5) To acquire, own, operate, maintain, lease or sell real or personal property, including the power to determine the location of property purchased, leased, and/or operated. Before taking official action to sell residential property, however, the Authority shall implement a plan for

- alternative housing arrangements, subject to the requirements of MCL §330.1205(4)(e)(ii) and (iii);
- (6) To enter into contracts and agreements in the Authority's name;
- (7) To employ staff in the Authority's name;
- (8) To acquire, construct, manage, maintain, or operate buildings or improvements in the Authority's name;
- (9) To acquire, own, operate, maintain, lease or dispose of real or personal property in the Authority's name;
- (10) To incur debts, liabilities, or obligations in the Authority's name that do not constitute the debts, liabilities, or obligations of Genesee County;
- (11) To commence litigation and defend itself in litigation;
- (12) To receive and expend funds for the purposes of the Authority;
- (13) To invest funds in accordance with statutes regarding investments;
- (14) To set up reserve accounts utilizing state funds in the same proportion that state funds relate to all revenue sources to cover vested employee benefits, including but not limited to accrued vacation, health benefits, the employee payout portion of accrued sick leave, if any, and Worker's Compensation. In addition, the Authority may set up reserve accounts for depreciation of capital assets and for expected future expenditures for an organizational retirement plan.
- (15) To develop a charge schedule for services provided to the public and utilize the charge schedule for first and third-party payers. The charge schedule may include charges that are higher than cost for some service

- units by spreading non-revenue service unit costs to revenue-producing service unit costs with total charges not exceeding total cost. All revenue over cost generated in this manner shall be utilized to provide services to priority populations; and
- (16) To secure and maintain insurances, including but not limited to self-insurance and re-insurance.
- O. <u>Duties and Responsibilities of the Authority</u>. In addition to other duties and responsibilities of the Authority as set forth in the Act, the Authority shall do all of the following:
 - (1) Examine and evaluate the mental health needs of Genesee County and the public and the public services necessary to meet those needs;
 - (2) Provide to Genesee County and to the MDCH a copy of an annual independent audit performed by a Certified Public Accountant in accordance with Governmental Auditing Standards issued by the Comptroller of the United States;
 - (3) Be responsible for all executive administration, personnel administration, finance, accounting, and management information system functions. The Authority may discharge the responsibility through direct staff or by contracting for services;
 - (4) Provide to the Genesee County Board of Commissioners ninety (90) days advance written notice and/or obtain the approval by the Genesee County Board of Commissioners to enter into any agreement which would create a new legal entity pursuant to the Urban Cooperation Act,

- Public Act 7 of 1967 being MCL §124.501 et seq., and shall send any such proposed agreement to the Genesee County Board of Commissioners; and
- (5) Provide to the Genesee County Board of Commissioners, as requested, any information related to the operations of the Authority and the Authority Board on a timely basis, unless prohibited from disclosure by law.
- P. Applicability of Open Meetings Act and Freedom of Information Act. To the extent required by law, the Authority, as a public governmental body, shall be subject to the Open Meetings Act, Public Act 267 of 1976, being MCL §15.261 *et seq.*, and the Freedom of Information Act, Public Act 442 of 1976, being MCL §15.231 *et seq.*, except for those documents produced as a part of the Peer Review Process required by the Code, Section 143a, MCL §330.1153a and made confidential by the Code, Section 748(9), MCL §330.1748(9).
- Q. <u>Conflict</u>. If any provisions of this Resolution conflict with the Act, the Act shall supersede.
- R. <u>Additional Powers</u>. All powers, duties, obligations, rights and protections not mentioned herein but otherwise provided by the Act are included herein by reference.
- S. <u>Liability</u>. Genesee County is not liable for any intentional, negligent, or grossly negligent act or omission, for any financial affairs, or for any obligation of the Authority, its Board, employees, representatives, or agents.
