# Prosecutor Leyton Charges Four Related to Sunday Night's Flint Twp. Carjacking Murder at Mobil Station

**FLINT** - Genesee County Prosecutor has charged four individuals related to the murder of a Grand Blanc woman Sunday night in Flint Township.

On Sunday evening, March 4<sup>th</sup>, at about 9:00 PM, Leslie Mills, 55 of Grand Blanc, was shot and killed in her car while getting gas at the Mobil gas station on Corunna Rd. in Flint Township. Mills was shoved out of her car which was then driven away by her assailants. An ambulance was dispatched to the gas station and Mills died while en route to the hospital. Mills' car was found by police a short time later at the Economy Motel on Corunna Road, police surveillance was set up, and suspects were arrested a short time later.

Four persons have been charged related to this incident:

Count 1: Felony Murder (life without parole)
