#### VIII. OTHER BUSINESS

Commissioner Henry asked Mark Valacak and Corporation Counsel how would we move forward and do we have the authority to move forward on a county wide mosquito project. Commissioner Henry is concerned about the Zika virus for the County and he feels we need to look at this as a County wide project.

Mark Valacak advised that we are not in an area where the mosquito that carries the Zika virus can not survive. Based upon current knowledge, it is a disease that can be sexually transmitted so they are working on appropriate testing and possible additional community education.

Commissioner Henry requested we get an estimate on the cost to have the county sprayed for mosquitos.

Discussion ensued.

Commissioner Henry asked Corporation Counsel if they have looked at the new law that the Governor signed on the plastic bag band. Celeste Bell, Corporation Counsel advised that she has not. Commissioner Young advised that you cannot band plastic bags on a local level.
