#### 1095 / ACA / IRS Penalties

It is important when adding a spouse or dependent to your insurance that you give the correct social security number and legal name as it appears on their social security card. If you are married and your spouse does not change their name with the Social Security Administration, the ACA files **will not match** and there could be penalties assessed by the IRS for failure to have healthcare. It is important to only give legal names on enrollment forms, NO NICKNAMES. Also, if a name is hyphenated with social security, your benefits records should reflect that name.

### **Notice: Important Tax Form for the 2016 Tax Year**

In January some employees will receive a tax form called the 1095-C that will contain important information about their health care coverage in 2016. Employees who will receive the form include those who:

- Were enrolled in health care coverage with Genesee County at any point in 2016
- Worked an average of 30 hours or more per week, or were considered a full-time employee in 2016

If you receive a 1095-C, keep it for your records. Information from the form may be needed to complete your tax return, and also to help determine your eligibility for a premium tax credit.
