On November 3, 1987 the Genesee County electorate approved a levy of property taxes to be used by the Authority for acquisition, construction, expansion, maintenance and operation of airport facilities.

The Board of Commissioners is the governing board and policy-making body of County government. While many of its powers, duties and responsibilities are prescribed by law, and diffused through the wide-spread use of commissions, boards, committees and independently elected county officers, the Board is in charge of developing and approving County policy including setting the County budget.

Nine Commissioners are elected to two-year terms on a partisan basis from single member districts. Regular sessions of the Board are usually held on the second and fourth Wednesdays of each month at 9:00 a.m., and at such other times and days as may be established. Committee meetings of the Board are held on Tuesdays and Wednesdays of each week, and subcommittees meet throughout the week.

A schedule of all board and committee meetings is available from the office of the Board Coordinator. All meetings are held in the Willard Harris Auditorium, on the Third Floor of the Genesee County Administration Building, 1101 Beach Street, in Flint. Board and committee meetings are open to the public, and the public is given an opportunity to speak at each meeting.

The Michigan Constitution provides that the voters of each county shall elect a Clerk on a partisan basis every four years. The Clerk's duties are prescribed by law and include being the Clerk of the Genesee County Circuit Court, Family Court Division of Circuit Court, the County Board of Commissioners, the Board of Canvassers, the County Election Commission, the County Plat Board, the Election Scheduling Committee, the County Apportionment Board, Concealed Weapons Licensing Board, and the County Road Commission.

The Clerk's duties also include the handling and processing of Personal Protection Orders (PPOs).

In addition, the Clerk maintains birth and death records, assumed business names and partnership certificates, concealed weapons permits, veterans' discharge records, marriage licenses and notary licenses.

The County Clerk is the chief election official of the County and, therefore, supervises all national, state, and local elections. Administration of the Michigan Campaign Finance Reporting Act is also the responsibility of the Clerk.



The Commissioner is elected by state law every four years on a partisan basis and is responsible for the administration of the Drain Code of 1956, as amended. The duties of the Drain Commissioner include the construction and maintenance of drains; determining drainage districts; apportioning costs of drains among property owners; Local Units of Government receiving bids and awarding contracts for drain construction.

The Commissioner, by action of the Board of Commissioners, is the County Agency, pursuant to Act 342 Michigan P.A. of 1939 as amended, for water supply, wastewater collection and treatment.

In addition, the Commissioner works with state and federal agencies to enforce flood plain and pollution laws, and assists in coordinating federal, state, and regional flood control and water quality plans. The Commissioner, by law, is a member of the County Parks and Recreation Commission.

Genesee County Economic Development Corporation (EDC) financing programs provide gap financing to businesses located in Genesee County. Gap financing is the amount of financing needed by the business that cannot be provided by conventional lenders. By participating with conventional lenders, the EDC can allow for new business start-ups and expansions to be adequately capitalized. Eligibility

The following types of businesses are eligible: existing manufacturing, commercial, and service businesses looking to expand or to start-up in Genesee County. Job creation is required. The loan amount cannot exceed 20% of the total project cost, not to exceed \$300,000.

The Director is appointed by the Board of Commissioners on an indefinite basis, and is responsible to the Board of Commissioners for administration of the property tax statutes within the County. Duties include preparation of an Equalization Report which is intended to assure that assessments are maintained at comparable levels throughout the County; preparation of a Millage Reduction Report which reflects the millage reductions fractions for all tax levying jurisdictions within the County and maintenance of all property descriptions records within the County, with the exception of those in the City of Flint.

The Genesee County Metropolitan Planning Commission (GCMPC) was organized in 1963, and consists of eleven members appointed to three-year terms by the Chairman of the Genesee County Board of Commissioners. The primary responsibility of the GCMPC is to provide the staff to administer the Community Development Block Grant Program and the Transportation Planning Program and includes the monitoring of the overall development for the County. The Commission provides technical planning assistance to local units of government, the Board of Commissioners and various other agencies and reviews applications for federal assistance for projects or programs proposed by the County. GCMPC also provides staff for the designated planning committee responsible for the update and implementation of Genesee County's Solid Waste Management Plan.







The Circuit Court of Genesee County is the trial court of general jurisdiction for Genesee County. It is the Court of original jurisdiction for all civil actions, claims and remedies arising within the County, except for matters specifically designated to be handled by the courts of limited jurisdiction (District and Probate Courts). The Circuit Court is the appellate-level court for courts of limited jurisdiction.

The 7th Judicial Circuit Court is comprised of two divisions, Civil/Criminal and Family Division. Civil cases with amounts in controversy of \$25,000 or more and criminal cases with a maximum punishment of one year or more are assigned to the Civil/Criminal Division. Cases involving family issues, such as divorce, paternity, child support, neglect/abuse and delinquencies are assigned to the Family Division.

Civil/Criminal Division Judges

Through the Chief Judge, the Court has oversight responsibility for other departments which serve as extensions of the Court including the Friend of the Court, the Defender Program, Criminal Appellate Assignments, Jury Commission and the county Law Library. Judges are elected, on a staggered basis, for six-year terms, on a non-partisan basis.





COUNTY COMMISSIONER DISTRICTS

GENESEE COUNTY FAST FACTS

INTRODUCTION

Genesee County is one of 83 counties in Michigan. It has 637 sq. miles in land area and a population of 418,408. The County's median household income is \$40,854 (2011). The largest city in Genesee County is the City of Flint.

EDUCATION

- Flint and Genesee County are home to four top colleges and universities and eight satellite campuses. These institutions have more than 30,000 students pursuing degrees in or near the downtown area helping the region become one of the fastest growing college towns in America.
- Baker College is one of Michigan's largest independent colleges. The institution not only provides a high quality education but prepares students for successful careers upon graduation. Baker graduates enjoy a 98 percent employment rate.
- Kettering University, formerly General Motors Institute is ranked number one in the country for industrial and manufacturing engineering and number two for mechanical engineering by U.S. News & World Report.
- University of Michigan-Flint (UM-Flint) is part of the world renown University of Michigan system. The university's School of Management is located in downtown Flint. Dubbed the "Wall Street" business school, it includes a stock trading center.
- Mott Community College was recognized by the Aspen Institute in a 2011 national competition as one of the 10 best community colleges in the nation.
- Michigan State University's College of Human Medicine will soon bring its public health program and 100 third- and fourth-year students to downtown Flint.

ECONOMIC DEVELOPMENT

- Genesee County is home to more than 7,248 businesses and over 417,000 residents, and serves as a regional hub for employment and education.
- The Flint and Genesee County Comprehensive Economic Development Strategy suggests that through a focused approach to economic development, up to 9,000 new jobs could be created in the next decade.
- Through the Flint & Genesee Chamber of Commerce, the county offers a variety of services to businesses and entrepreneurs such as expansion support, government contracting and export assistance, green solutions and financial packaging as well as workforce and entrepreneur services.
- Genesee County is a partner in the I-69 International Trade Corridor, a Michigan-based collaborative partnership among agencies, authorities, municipalities, and businesses along I-69 including Shiawassee, Genesee, Lapeer and St. Clair counties. The Corridor partners work to market the region's assets to drive investment and create jobs.

LABOR FORCE

- More than 165,000 people work in Genesee County's 7,248 private sector businesses.
- In 2012, Genesee County payroll was over \$5 billion for its 165,000 employees.
- Employment levels grew by 2.1 percent in 2012 for Genesee County with a number of business sectors reporting job growth.

BUSINESS DEVELOPMENT

- Known for automotive manufacturing, the economic character of Genesee County is changing...becoming more diverse by growing in health care, advanced manufacturing, electronics, IT, alternative energy, and medical technology.
- Genesee County offers a low cost of doing business, diverse supply chain, and numerous economic incentives.
- The area's infrastructure surpasses most regions of its size. The county is well positioned to support growth with our strong network of transportation assets. This includes Bishop International Airport, I-69 International Trade Corridor, I-75 and U.S. 23, CSX and CN rail systems, major redevelopment sites (Buick City, Flint East and Grand Blanc Weld Tool), and Karegnondi Water Authority.
- The freight industry in Genesee County is forecasted to grow from \$10 billion to approximately \$17 billion by 2030, which will result in growing supply chain opportunities.
