



NOTICE OF AVAILABILITY OF SURPLUS LAND

RE: **Notice of Availability of Surplus Land in the City of Adelanto Pursuant to Government Code §§ 54220, et seq.**

Pursuant to the provisions of California Government Code section 54220,¹ et seq., (the "Act"), the City of Adelanto ("City") hereby notifies those entities designated in Section 54222 of the availability for disposition of the following City-owned land identified below (collectively, "Property") for the purposes authorized in the Act:

The Property is located at 11600 Air Expressway, Adelanto CA 92301 (APN 0459-221-20 and APN 0459-221-04). The Property totals approximately 7.67 acres, and is improved with parking lots and fields. The Property is currently zoned Mixed Use. See Attachment 1 for an overhead photo and map of the Property.

The City has declared the above-identified Property surplus and will take action to dispose of it consistent with the Act and the City's policies or procedures.

In accordance with section 54222, you have sixty (60) days from the date of this letter sent via electronic mail to notify the City of your interest in acquiring the Property. However, this offer shall not obligate the City to dispose of the Property to you. Instead, the City would enter into at least ninety (90) days of negotiations with you pursuant to section 54223. If no agreement is reached on price and terms of the disposition, the City may market the Property to the general public.

As required by section 54227, if the City receives more than one letter of interest during this 60-day period, it will give first priority to entities proposing to develop housing where at least 25% of the units will be affordable to lower income households. If more than one such proposal is received, priority will be given to the proposal with the greatest number of affordable units. If more than one proposal specifies the same number of affordable units, priority will be given to the proposal that has the lowest average affordability level.

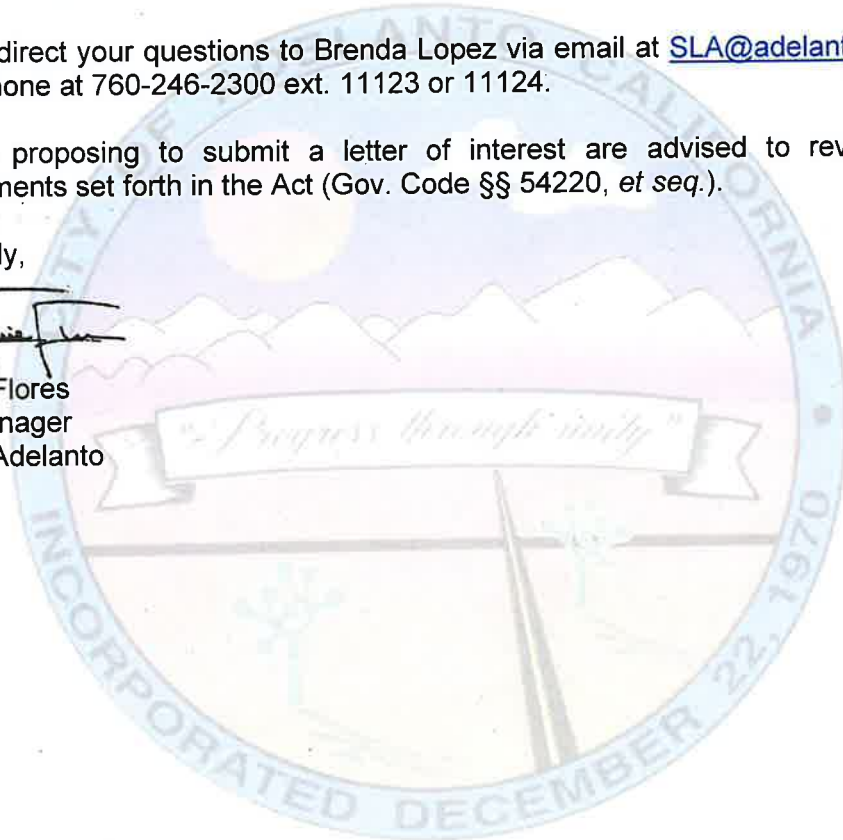

(APN 0459-221-20 and APN 0459-221-04)

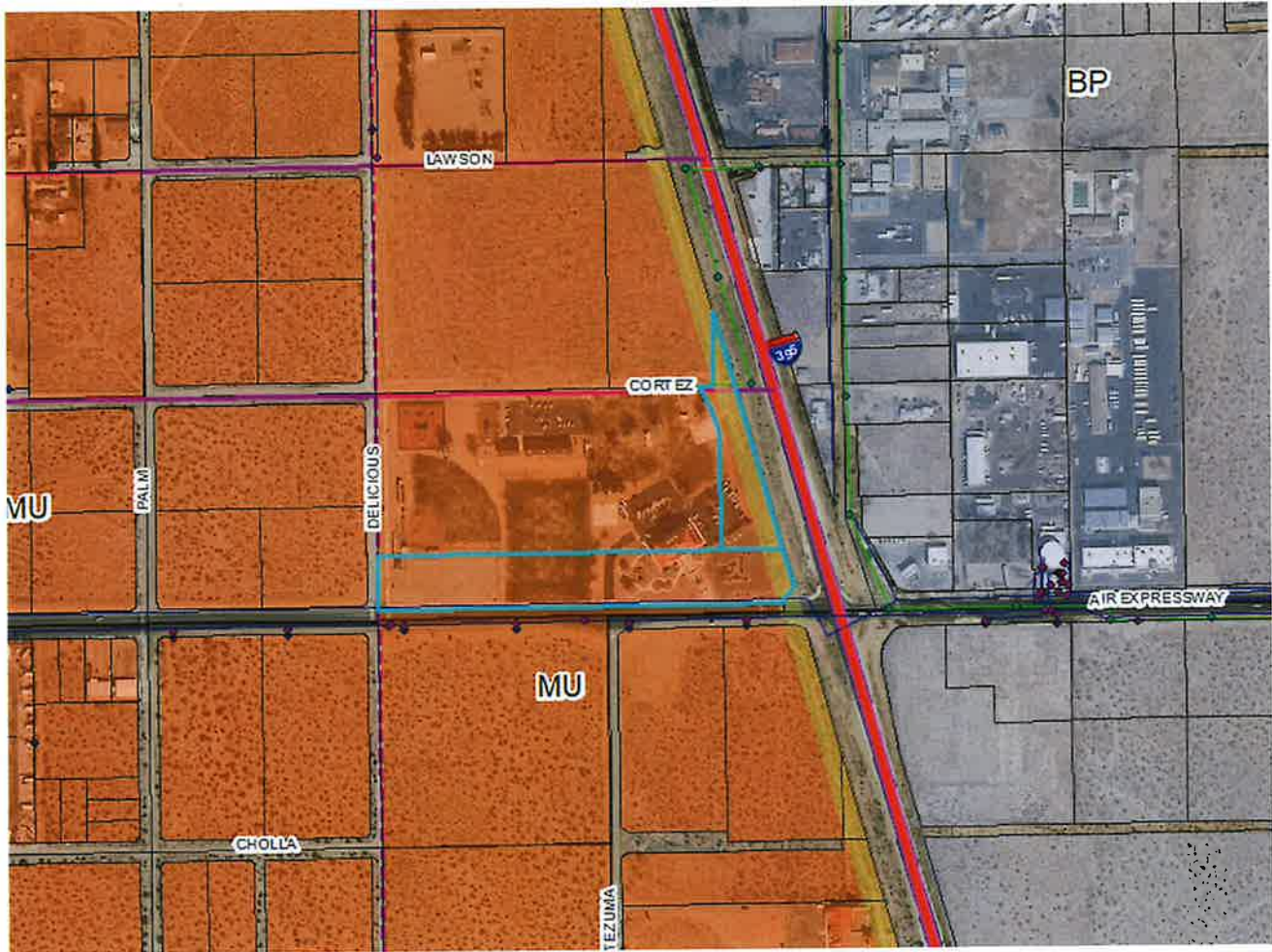
