Subject: Hope Network PILOT-Bingham School

Hope Network, a non-profit based out of Grand Rapids has requested to remodel and add on to the vacant building (former Bingham School) located at 555 W Fifth Avenue. As part of this request their subsidiary; Bingham Limited Dividend Housing Association Limited Partnership has requested a Payment In Lieu Of Taxes (PILOT). The proposed development would consist of 35 units reserved for income restricted independent senior living.

The proposed project would rely on the use of Low-Income Housing Tax Credits (LIHTC), which require the establishment to obtain a PILOT to provide assurance that the tax burden will remain in line with the income and affordable nature of the proposed development for the life of the loan, in this case 40 years. The PILOT ordinance would restrict the primary residence to 55-years of age or older and allow them to have someone else living with them that could be 50 years of age or older. Any units containing someone that does not meet the age or income requirements would be taxed at the full amount of ad valorem taxes.

Previously, a PILOT was approved via Ordinance 19-449 by City Council authorizing an annual service charge in lieu of taxes at 10% of actual shelter rents collected less utilities. Unfortunately, the project was delayed due to the COVID-19 pandemic and the PILOT expired in January 2021. As you may be aware, construction costs have risen over the past few months and the developer anticipates an increased construction cost of \$586, 360. If the PILOT is reduced, the developer can afford higher debt payments and additional debt and therefore close the financial gap on the project.

The proposed PILOT request is to establish at a rate of 4% of the annual shelter rents less the cost of furnished utilities and will continue over the term of the financing and MSHDA regulatory oversight (40 years). At 4%, the expected annual PILOT is calculated at \$8,460 by the applicants, roughly 30% (\$2,538) of that amount would remain at the City, while the other 70% (\$5,922) would

be divided among the other taxing jurisdictions. The applicant has estimated the total project cost to be \$8.251 million, of which \$5.492 million represents hard construction costs and the remainder includes items such as property acquisition cost, 10% construction contingency, professional services, financing costs, and various reserves required by MSHDA. The applicant estimates the taxable value to be \$4.125 million. The ad valorem tax for that taxable value is calculated at \$237,989.

As noted in 2019, City staff is cautious of developments that require a PILOT as they are often either utilizing property that could be used for market rate housingthat would generate full ad valorem tax amounts or they are attempting to convert an existing property that generates ad valorem taxes. This is not simply to build tax base, but additional residential units inthe City require additional services to be provided which utilize City resources. In this instance, the building in question has been a school for most of its history, which did not generate any revenue for the City. It was utilized as a charter school for several years and has been vacant and in private ownership the last few years. While utilized as a charter school, the building had a taxable value between \$147,000 and \$150,000 and when the building was vacant in 2018 and 2019 that taxable value has dropped to about \$88,000. Old school buildings are often difficult to develop due to specific architectural features such as wide hallways and standalone classrooms. In addition, most school systems prefer new construction as they indicate it is cheaper than trying to retrofit an old school with modern equipment. Because it is doubtful a school will relocate into this building and the difficultly developing this school for market rate housing, along with the fact for most of its history it did not generate revenue for the City; staff would not be opposed to a development that requires a PILOT at this location.

The proposed \$8.251 million investment in this development will provide work for local contractors and improve the overall quality and quantity of low/mod housing stock available to seniors in the City od Alpena. Although the development will be tax exempt, it is the intent of the federal government and MSHDA for them to remain so, so long as there is a need for low/mod housing within the City. Based on Census data and anecdotal information from the City's Rental programs, it is apparent that the demand for such housing is still present and will continue to increase for the foreseeable future.

Staff supports the rehabilitation of the 35 rental housing units by Bingham Limited Dividend Housing Association Limited Partnership and the approval of a new 4% PILOT covering the development as part of the firm's LIHTC application. If Council concurs, staff will prepare an ordinance to receive first reading at the next Council meeting.

Dear City Manager Smolinski,

Thank you for the recent opportunity to speak with you about our project to build 35 new senior apartments at the historic Bingham School. This property, located at 555 S 5<sup>th</sup> Avenue in Alpena, has been vacant for a several years. We hope that by rehabilitating it and nominating it for registration on the National Historic Register, we will be helping to preserve a part of Alpena's past while simultaneously providing affordable downtown living for Alpena's seniors.

As you know, the City of Alpena has been very supportive of this project in the past. The City enacted a 10% PILOT (payment in lieu of taxes) to help ensure the financial viability of the project. Since that time, the cost of the building has increased. As you are probably aware, construction costs are up across the country, and this project has not been immune to increasing prices. Between the time the original PILOT was approved and June of this year, our construction costs went up by \$586,360.

In order to ensure that the project remains financially viable, we are respectfully requesting a reduction in the PILOT. We are proposing a new 4% PILOT. A 4% PILOT would mean that the property would pay approximately \$8,460 in annual property tax. The PILOT reduction would increase cash flow, which would allow the project to take out a larger loan, which would in turn allow the project to cover the additional cost of construction. The proposed 4% PILOT is also higher than the 3% PILOT paid by the Alpena Village Senior Housing Project.

We hope that you and the City Council see the value of this project and continue to support it by lowering the PILOT rate. A lower rate will help ensure that financial viability of the project. Should you have any questions regarding this project, please don't hesitate to contact me.

Appearance and protest at the hearing held for the purpose of confirming the roll is required in order to appeal the amount of the special assessment to the State Tax Tribunal.
