

On December 21, 2020, the City received and opened bids for the installation portion of the Water Treatment Plant Filters 5-7 Valve Repair Project. This project replaces fifteen valves and actuators on filters 5 through 7 in the Water Production Plant. The installation award is the second of the two part bid for this project with the materials awarded on December 7, 2020, in the amount of \$65,643.99.

Bid documents were sent to 6 (six) contractors, plan rooms and also posted on the City's Website with two proposal received as listed below:

Meridian Contracting \$33,120 Alpena, MI Johnson & Wood, LLC \$39,000 Alpena, MI

Meridian Contracting attended the required pre-bid walkthrough and are knowledgeable about the scope of work, limitations and expectations that were discussed. They have completed other projects at both the Water Production and Water Recycling Plant with satisfactory results and, therefore, we believe they are capable of completing the work proposed without issue.

Additionally, the City received a quote from Tempest Enterprises, LLC in the amount of \$10,751.93, for integrating the fifteen new valves into the existing plant control system. The operation software is proprietary and therefore, Tempest Enterprises is the sole source for incorporating the new valves into the plant's operational system.

Funding has been established in the water fund in the amount of \$140,000, for completion of this project. Including the previous awarded materials, the project total is \$109,515.92 which is well within the proposed budget.

It is my recommendation, as City Engineer, to award the project to Meridian Contracting for the Water Treatment Plant Filters 5-7 Valve – Installation for the proposed amount of \$33,120, and approve a purchase order with Tempest Enterprises, LLC, for completion of the control's integration in the amount of \$10,751.93.

Subject: HMA Patching Program Contract Renewal Recommendation

In December 2020, the City received the attached request from Everett Goodrich Trucking, Inc. to renew the HMA (Hot Mixed Asphalt) Patching Program Contract for the 2021 construction season. This contract provides bituminous asphalt services to the City as needed with costs billed to the appropriate line item where the work is performed. The contract for the period of January 1, 2020 – December 31, 2020 contains language which allows for the renewal of the contract for up to 1 (one) additional one-year period, providing both parties can agree on any pricing adjustments. In no case shall the contract be extended beyond December 31, 2021.

Bruce Goodrich, of Everett Goodrich Trucking Inc., has requested a 2.69 % increase overall to offset an increase in material cost. The proposed changes would show a net increase of \$2,297.50, to the contract. 2020 unit prices, as well as the 2021 requested unit prices are outlined on the attached bid comparison spreadsheet for review.

It is my recommendation, as City Engineer, that City Council approve the renewal of the 2020 HMA Patching Program Contract for 2021 with Everett Goodrich Trucking, Inc., for the unit prices proposed.
