Dear City of Alpena Council Members:

It is with great excitement that more sculptures along the Alpena Bi-Path continue to materialize. **Over the last three** years now, City of Alpena support helped leverage nearly \$150,000 in cash and in-kind contributions for 11 sculptures along the Alpena Bi-Path – three new installations in 2019 alone – about \$52,000 over the previous year.

Additional support came from an array of local and state government agencies, grants, private business contributions, nonprofit philanthropic organizations and a wide array of individuals in the community, both traditional supporters of the arts and newcomers. It is amazing when you think about it. So many interests are coming together for common cause, public sculptures, and it is making a difference in our community.

The Alpena Letters Sculpture (2019) will be installed this spring, and together last year we witnessed installation of the American Dogs Sculptures (2019) and refurbishment of the Alpena Yacht Club stone.



We write to ask for continued support of the sculptures along the Alpena Bi-Path in the form of a \$5,000 budget allocation by the City of Alpena for the upcoming year - 2020.

The next sculpture will be located at Washington Avenue Park at a major entry point into our community - M-32/Washington Ave.. The sculpture is titled, *The River Intertwined* (2020). More details will be unveiled at the March 2 meeting. We are very excited to bring this very modern large-scale contribution to the collection.

Besser Foundation has committed \$5,000 of matching money for each year/sculpture of the long-range plan for three years as a starting point. This will be our second year of the Besser Foundation matching grant. A City of Alpena contribution again will help secure these funds and further bolster the support needed from other organizations and individuals in order for the intended sculptures to materialize on schedule each year. Included with this letter is a brochure further detailing Art Vision Alpena, a project of the Thunder Bay Arts Council, Inc..

The City of Alpena has been involved as a steadfast partner in the overall development of the Alpena Bi-Path and sculptures since the original 1974/76 concept of the Alpena Sculptured Bikeway and Walkway. City of Alpena contributions have helped facilitate both the pathway's original construction and then again the first sculpture in 1978, Sculptured Fountain at Besser Museum. The total cost for this sculpture in 1978 was some \$50,000. It is now valued at well over double its original cost.

Given the success and public support of the earliest sculptures (*Departure of the Great Blue Herons* (2017), *Global Collaboration Awareness* (2017), and the *History of Industry* series (2018), Art Vision Alpena was created in 2018. Working within the guise of Thunder Bay Arts Council, Inc., the plan provides a long-term vision and a blueprint for proceeding further with the resuscitation of the sculptured Bi-Path. Sculptures are scheduled leading up to the 250th anniversary of our country in 2026, our nation's Sestercentennial. What a testament to perseverance given the original plan celebrating our nation's Bicentennial and the dream of a (Bi)centennial-Path in our community populated by sculptures, this despite the hiatus of 39-40 years.

The momentum and community support for the agenda are evident. These sculptures provide value added to our community, its aesthetics and the opportunity for experiential engagement. We have no doubt that Art Vision Alpena is



yet one more iteration of a long-term strategy to further beautify our community and make it more attractive for work and pleasure by locals and visitors alike – further fostering a sense of place where people want to live, work and play. It is the very basis of inspiring tourism and community interaction. It has great promise for economic returns to our remote part of the state where arts and culture are becoming a foundational component of a vibrant, sustainable 21st century community and economy.

By virtue of drawing attention to our little Sanctuary, our Bi-Path and our growing collection of public art and sculptures in one of the most idyllic and beautiful settings one can image, we are reinterpreting our community from it foundations, merging art with nature, our surroundings, and encouraging people to recreate with the arts and culture of our community. This will surely contribute to the economic dynamism necessary for our community to continue to flourish in the 21st century.

The City of Alpena has worked hard to maintain a good working relationship with the Michigan Economic Development Corporation (MEDC) as well as our many community partners including the Friends of the Thunder Bay National Marine Sanctuary (FTBNMS). To that end, FTBNMS has been in the development of a long-term plan for the land surrounding the Great Lakes Maritime Heritage Center which included various public recreational amenities including trail improvements, pavilions, a kayak launch, an amphitheater, and sports courts. The plan meets the goals of the Comprehensive Plan for the City of Alpena as it expands our waterfront assets and expands recreational opportunities available to the public. City staff has kept the MEDC informed on this planning process for the possibility of potential grant funding in the future. City Engineering staff was able to generate the information required and a proposal was submitted to the MEDC on behalf of the FTBNMS, the City, and the property owner. The MEDC generated a Letter of Interest effectively reserving \$3,897,342 for these public improvements which requires a 10% match (\$433,038) which the FTBNMS has worked with various community partners to raise.

Part of the grant application process is to hold a public hearing to allow the citizen participation, with emphasis on participation by persons of low and moderate income status to comment on the grant application. Once that hearing occurs the attached resolution 2020-02 will need to be approved.

Subject: MDOT Trunkline Utility Replacement Project

Beginning this spring, the Michigan Department of Transportation will be resurfacing portions of their routes within the City of Alpena. The affected streets within the city limits are as follows:

State Street (US-23) from the city limits at Mason Street to Richardson Street Washington Avenue (M-32) from the city limits at Bagley Street to Second Ave Second Avenue (M-32) from Washington Avenue to Chisholm Street Third Avenue (M-32) from Washington Avenue to Chisholm Street

In preparation of this project, staff in coordination with Suez have evaluated the sanitary services under these streets and have identified six services which have an ongoing maintenance history and are in need of repair.

In an effort to coordinate with the tight schedule for the project, the city has solicited quotes from the contractor performing the work for the MDOT project. A quote was also solicited from a contractor MDOT has used in the past to repair utilities without the need to open cut the street by utilizing a liner system to seal and repair the existing services.

Based on estimated quantities, the results of these quotes are as follows:

Team Elmer's Hillman	<u>Amount</u> \$50,025	Method of Construction Replace Services by Open Cutting the street
Monchilov Sewer Services, LLC. Fairgrove	\$38,600	Liner system to repair Existing services in place

If Team Elmer's open cut method is used, there will be some added cost for inspection required by MDOT for these services to be replaced which should not exceed \$2,500. If this method is selected, the streets will need to be closed to facilitate the open cut method

which will require detours for the duration of the repairs. The above price includes the detour signage required.

If Monchilov liner method is used, there will also be additional cost for City crews to excavate access points for Monchilov, which is not anticipated to exceed \$9,000. It is expected that the roads will remain open for the duration of these repairs and instead, traffic will be shifted over allowing our crews to complete the work.

Due to the short window we are allowed for the repair of these services and MDOT's desire not to close the street or cut open the road to install the services, it is my recommendation as City Engineer to award this work to Monchilov Sewer Services, LLC. for the as quoted unit prices totaling \$38,600.
