Mayor Waligora and Members of Council,

In order to support the revitalization efforts of downtown areas in Michigan, in 2006 a new Public Act was created relative to a new type of on-premises liquor licenses for a redevelopment project area. Public Act 501 of 2006 provides that in addition to the number of licenses available in cities under section 531(1), they may issue special licenses to establishments that are located in a redevelopment project area meeting certain criteria.

At this time, the DDA is working closely with one business hoping to open in downtown, but needing one of these special licenses, as no licenses are otherwise available. In order for this to occur, the City and the DDA must take several steps, the first of which is before you at the September 8, 2015, Council meeting. In order to proceed, City Council must pass a resolution recommending this new license application. The DDA District was established as a Redevelopment Area pursuant to Act 501 of Public Acts of 2006, by the Alpena City Council in 2009.

The DDA supports this action, and is looking forward to continue working with the City to complete all of the documentation needed in order to facilitate the liquor license application of this new downtown entrepreneur.

The DDA is requesting that this resolution be passed at the September 8, 2015, meeting, so that we can then move forward with this project.

In the end, it is within our City Master Plan and DDA Strategic Plan to foster nighttime venues within the downtown district. The above mentioned resolution simply lets the Liquor Control Commission know that we agree to allowing one our special licenses to be allocated to this particular applicant – only if they meet all of the requirements any other liquor license applicant must meet. Once received by the LLC, they will begin their usual investigation. Passing the resolution does not imply that the applicant meets these guidelines. That is still the role of the LCC.





Subject: Woodward Avenue Trailhead Bids

On August 31, 2015, the City of Alpena received and opened bids for the Woodward Avenue Trailhead Project. The City previously bid this project out with bids due on June 29, 2015. The bids received at that time, 3 bidders, were significantly over budget causing the City to redesign and phase the project. In the current bid opening, the City sent the bid announcement to 29 entities including the three bidders from the first bid opening, and received two bids as follows:

The City of Alpena was to make up the balance of the originally estimated \$350,000 project. When the original bids were received and the City elected to redesign the project, we set it up so it could be phased while still meeting the MDNR Grant Agreement requirements. To meet these minimum requirements, the City would need to construct the bathroom facilities, hard surfaced area around the bathroom building, hard surfaced barrier free parking area, and surfaced access pathway to the Northeast State Trail and connection to the existing City bike path system. The other elements could be constructed

as follow-up activities to complete the overall project. These would include construction of the pavilion, paving of the balance of the parking lot, construction of the overflow gravel parking area and additional site amenities.

The cost to complete the required elements to comply with the MDNR Grant Agreement would be \$346,625.48 based on the bids received. The balance of the work could be budgeted and constructed utilizing City funding in the 2016-2017 fiscal year and would be \$152,624.70. The City has \$348,828 remaining in the current budget for this project.

It is my recommendation, as City Engineer, to award the Woodward Avenue Trailhead project to Meridian Contracting Services in the amount of \$499,250.18, conditional upon MDNR approval, and that the project be phased with the remaining funds budgeted in the 2016-2017 fiscal year. As an alternative, if Council so desired, the funding to complete the entire project could be taken from fund balance.

Mayor Waligora and Councilmembers,

In 2011, the City of Alpena, Green Township, Long Rapids Township, Maple Ridge Township, Ossineke Township, Sanborn Township, the Township of Alpena, Wellington Township, and Wilson Township entered into an Interlocal Agreement with the County of Alpena to provide a Solid Waste Management Program. A major component of the agreement was the offering of a county-wide recycling program. Pursuant to the authority of 1989 PA 138, all parties agreed there would be a surcharge of \$10.00 per household, but those who choose not to utilize the recycling program could opt out each year. This program has been in effect for the past five years.

The surcharge also afforded citizens the opportunity to drop off household goods, tires, construction materials, etc. An annual Cleanup Day has also proven to be beneficial and has expanded each year. It has helped to free area properties, ditches, fields and streams of junk and debris, and the Recycling Center pays for the disposal of those materials.

The recycling program has been extremely successful. In 2011, there were 381 recycling containers emptied, and by 2014, usage had grown to 772 container shipments to the Recovery Center. Usage of the recycling containers placed at Habitat for Humanity and Neiman's, accounts for the majority of the 2014 figures. Of the 772 containers emptied, 532 were from the above locations. The recycling program has experienced an annual increase of 20% or more in materials for processing. This is well over 100% increase in the volume of materials processed at the transfer station/recycling center over the past 5 years. The \$10.00 per household fee no longer meets the cost of covering the recycling and Cleanup Day operations. The current revenues for program operations will not meet this year's expenditures, and the extremely cold past winter causing unexpected and expensive equipment repair added to this deficit.

The Recycling Board is asking each entity to amend the Interlocal Agreement to assess \$20.00 per household. If approved by City Council, the amended agreement will be forwarded to the County for their consideration, and if the Commissioners amend the Interlocal Agreement, the new surcharge will take effect on January 1, 2016.

The Alpena Recycling Board is being proactive in an effort to address the deficit we are facing this year: we were awarded a tire grant for \$6,000 for our annual cleanup day, but it fell short of covering the disposal cost of the hundreds of tires that were brought in, NEMCOG is actively seeking grants the Alpena Recycling Board may apply for, and businesses do not pay a surcharge to use our service and Eric Smith of Panel Processing, is spearheading a sponsorship program from the business community. We are asking all governmental entities to pay their portion of Cleanup Day. Many townships have already submitted their share: Alpena Township \$7,000, Green Township \$1,200, Long Rapids \$800, Maple Ridge \$1,000, Ossineke \$1,600, Sanborn \$1,400, Wellington \$400, Wilson \$1,400 and the City of Alpena \$5,200. These numbers were based on the amounts paid in the past by each township/city for their share of Cleanup Day.

The recycling board was awarded an education grant through the State of Michigan which will enable me to attend a presentation by the Northeast Michigan Regional Education Initiative this month with Diane Rekowski from NEMCOG and Stan Mischley from the Recycling Center. We will learn from communities who have developed successful programs informing their citizens of the how, why, and what of recycling. For example, the recycling center has to pay to dispose of materials that can't be recycled, but are put into the bins. Reducing man-hours by teaching people to do something as simple as removing the caps of plastic bottles, crushing the bottles and recapping them, would reduce the workload at the recycling center. Our intent is to make recycling user-friendly in our community.

The Alpena Recycling Board is requesting the Alpena City Council approve the amended Interlocal Agreement with the County of Alpena from \$10.00 to \$20.00 per household.

INTERLOCAL AGREEMENT

THIS AGREEMENT is entered into this _____ day of ______ 2015, by and between the COUNTY OF ALPENA, a municipal corporation and political subdivision of the State of Michigan (hereafter, "the County"), and the CITY OF ALPENA (hereafter, "the local unit"), pursuant to the authority of 1989 PA 138, as amended, being MCL 124.508a.

WHEREAS, Alpena County has adopted a Solid Waste Management Plan, as required under Part 115 of 1994 PA 451, as amended; and

WHEREAS, a major component of the Solid Waste Management Plan is the County's Recycling Program, which encompasses waste reduction and collection of consumer source separated services and related educational programs; and

WHEREAS, 1989 PA 138, as amended, allows the County Board of Commissioners, by resolution, to impose a surcharge not to exceed \$25.00 per year, per household, for waste reduction programs and for the collection of consumer source separated materials, as defined in Part 115 of 1994 PA 451, household hazardous wastes, tires, batteries and yard clippings; and

WHEREAS, 1989 PA 138, as amended, requires the County to defer the imposition and collection of a surcharge in a local unit of government within the County until the County has entered into an interlocal agreement relating to the collection and disposition of the surcharge with the local units of government.

NOW, THEREFORE, THE PARTIES AGREE:

I. Surcharge

By entering this Agreement, the local units agree with the County's authorization of the imposition and collection of a surcharge of up to **\$20.00** per year, per household, in the local units for the collection of consumer source separated materials for recycling and related educational programs.

II. Billing and Collection of Surcharge

The surcharge shall be assessed to all households in the local units, and property owners shall receive notification of the surcharge with the local unit's winter ad valorem property tax bills. The local unit's Treasurer shall collect the surcharge at the time the local unit's winter ad valorem property taxes are collected. If a winter ad valorem property tax bill becomes delinquent, applicable fees or penalties will be applied to the surcharge.

III. Disposition of Surcharge Revenues

The local unit's Treasurer shall account for and remit to the Alpena County Treasurer the surcharges collected. All surcharges not collected by the local unit's Treasurer shall be collected

by the Alpena County Treasurer, as directed by the Alpena County Board of Commissioners. All funds collected shall be administered through the Alpena Recycling Board, as established by this agreement and used solely for purposes as stated in I. Surcharge.

IV. Administrative and Management Process for Surcharge

The Alpena County Recycling Board is hereby established to administer the county recycling program. The Alpena Recycling Board will be comprised of 6 representatives from the following: 2 representatives of the City of Alpena Council; 2 representatives from Alpena Township Board; 2 representatives from other township boards providing a geographic distribution to ensure representation from outlying areas. Operation and management of the day-to-day operations will be through a contract between Alpena County and the Northeast MI Council of Governments (NEMCOG). The Alpena Recycling Board will oversee the recycling program operations and management, establish the annual budget and set forth policies.

V. Opt-Out Provision

A household in the local unit shall have the option to petition its Township Board to be exempted from the surcharge, except that such exemption shall not be granted unless the exemption procedures set forth by the Township are followed.

If a household validly opts out of the surcharge, the local unit shall be responsible for (1) ensuring that the household is not made subject to the surcharge, and that the household does not use recycling services covered by the surcharge, and (2) maintaining records of households that have validly opted out.

VI. <u>Term</u>

This Agreement shall be for an initial term of three (3) years from the effective date, with an auto-renewal for (3) subsequent years.

This Agreement may be terminated by either the County or the local unit by the 1st of September of each year, or no later than sixty (60) days prior to the printing of the local unit's winter ad valorem property tax bills. All fees collected shall be used for the prior and/or current waste reduction and collection of consumer source separated services. Termination of this Agreement shall not result in a reimbursement of any funds collected pursuant to this Agreement.

VII. Effective Date

This Agreement shall be effective on December 1, 2015 through November 30, 2018 with an auto-renewal for 3 subsequent years.

VIII. Non-Discrimination

The parties to this Agreement agree not to discriminate against any employee or applicant for employment with respect to hire, tenure, terms, conditions, or privileges of employment, or any matter directly or indirectly related to employment, because of race, color, religion, national origin, ancestry, sex, height, weight, marital status, age, disability that is unrelated to the individuals' ability to perform the duties of a particular job or position, or political affiliation. Both parties, and any contractor with whom the parties shall enter into an agreement for recycling collection and disposal services, shall adhere to all applicable Federal, State and local laws, ordinances, rules, regulations, and policies prohibiting discrimination. Breach of this section shall be regarded as a material breach of this Agreement.

IX. <u>Amendments</u>

This Agreement may not be amended, modified or changed in whole or in part in any manner other than by an agreement in writing duly signed by the authorized representatives of both parties.

X. Authority to Sign Agreement

The persons signing this Agreement on behalf of the parties certify by their signatures that they are duly authorized to sign on behalf of the parties, and that this Agreement has been authorized by the parties.

Dear Mr. Sundin,

As you may know, the Alpena Fishery Research Station is building a replacement vessel for the RV Chinook and the Chinook is to be retired at the end of this season. The Chinook was built in 1947 for the old Conservation Department and has served the DNR for 68 years with its last 47 years being stationed here in Alpena.

As part of a group of Alpena citizens who are interested in having the Chinook's final resting place here in Alpena, we believe the preservation and display of the Chinook in the Alpena area would be a valuable attraction and enhance existing historical efforts on the Sunrise Side of our State. Such efforts currently include the US 23 Maritime Trail, the Thunder Bay National Marine Sanctuary, State Underwater Preserve and the emerging Historical Commercial Fishing Heritage Trail.

We are concerned that should no group commit to protecting and preserving the Chinook and her rich maritime heritage to our state, and particularly the Sunrise Side, she will end up deteriorating in some unforgotten place and possibly even being demolished for scrap. We are attempting to prevent this from happening to this historical vessel and if we are successful in our efforts to display the Chinook in our area, as her final resting place, commit to her preservation and the telling of her story to all who would listen.

A source of long-term funding for the display and maintenance of the Chinook is a critical element if this endeavor is to be successful. We will only have 6-8 months to pursue establishing Alpena as the Chinook's final resting place, and securing long-term funding for this endeavor.

The Alpena community, through its citizens and organizations, has a proven track record of willing and capable investment in undertakings such as we have described for the Chinook's final resting place. Our community

demonstrated such a worthy effort and investment by the successful saving of the Katherine V.

In conclusion, we are seeking the support of the City of Alpena, through the Alpena City Council, in our endeavors to protect, preserve and exhibit the Chinook in the Alpena area.

DNR awards construction contract for new Lake Huron fisheries research vessel

The Department of Natural Resources has announced that the construction of its new Lake Huron fisheries research vessel, the Research Vessel (R/V) Tanner, has started with the award of a contract to Andersen Boat Works of Saugatuck, Michigan.

"The R/V Tanner will replace the aging R/V Chinook, which has been operating on the Great Lakes since 1947," said Jeff Diemond, DNR Fisheries Division boat captain. "The R/V Chinook



is the senior citizen of our Great Lakes fisheries research vessel fleet, designed and built by Marinette Marine in Marinette, Wisconsin, in 1947 and needs to be replaced with a modern vessel to improve safety for the vessel's crew and significantly upgrade our research capabilities."

The 50-foot, steel-hulled R/V Chinook, previously known as Patrol Boat #3, was first commissioned as a Department of Conservation Great Lakes Law Enforcement vessel. She gained her present name in 1968 when she was transferred to the Fisheries Division's Alpena Great Lakes Station, where she has served as the department's research platform for all of Lake Huron and the St. Marys River.

"Data collected by the R/V Chinook over the last 46 years have been instrumental in measuring impacts of sea lampreys on trout and salmon, invasive species, and the effects of fish stocking and fishery management on Lake Huron's fish stocks," said Dr. David Fielder, DNR research biologist.

The new vessel, R/V Tanner, is named after former Fisheries Division Chief and DNR Director Dr. Howard A. Tanner and was designed by Seacraft Design of Sturgeon Bay, Wisconsin. It will be a 57-foot, aluminum-hulled vessel closely modeled after the R/V Lake Char, the DNR's Lake Superior fisheries research vessel launched in 2007.

"The R/V Tanner will allow staff at the Alpena Fisheries Research Station to continue their work on Lake Huron and the St. Marys River with tremendous improvements in safety, flexibility and dependability over its projected 50-plus-year life span," said Diemond. "Crew safety is greatly improved with a state-of-the-art navigational system and a compartmental hull design, which maximizes the ability of the vessel to stay afloat in the event of an emergency."

Unlike the R/V Chinook, which is powered by a single engine, the R/V Tanner will be powered by twin engines and will have a greater cruising range and speed. Similar to the R/V Chinook, the R/V Tanner will be rigged for sampling with nets and trawls, using a crew of five to six while under way. The R/V Tanner also will be equipped with the latest in hydroacoustic survey equipment to expand its fisheries assessment capabilities.

"In addition to supporting continued scientific management of Lake Huron's economically important lake trout, walleye and yellow perch fisheries, the R/V Tanner will be an integral component of the DNR's invasive species surveillance efforts across the basin," said Todd Wills, area fisheries research manager with the DNR.

Construction will take place over the next year, with delivery scheduled for April 2016. A final resting place, including an educational display, is being explored for the R/V Chinook after its decommissioning.

Memorandum

The City has received the attached pricing bulletin for installation and implementation of a new control system to monitor and regulate the HVAC system at the Public Safety Facility (PSF). As previously mentioned in presentation to City Council, the existing control system for the HVAC system at the PSF is a proprietary system, TRANE, which is difficult to monitor and manipulate, and requires a technician out of Saginaw to facilitate any programming changes needed.

To address the inefficiencies with that system, we have requested that AKT Peerless and their subcontractor, Nealis Engineering, develop a new control system package for the HVAC system, which was open source or non-proprietary. They looked to the same entity, Control Solutions, who developed the controls for the Alpena County Upgrade conducted a few years ago. They elected to utilize the services of Control Solutions to develop the control system. Control Solutions has a web based access portal allowing the system to be monitored from off site and modified by Control Solutions, if needed, without a site visit. Per the Alpena County Maintenance Director, they are very satisfied, have saved energy costs with the system, and being intuitive, they can manipulate it without the need to call Control Solutions for direction

Mike Kieliszewski, has reviewed the control package proposal and discussed the Alpena County project with their Maintenance Director. Based on his review and evaluation, we recommend that City Council authorize a Contract Modification with Wise Heating and Cooling, the contractor performing the current HVAC improvements at the PSF, in the amount of \$39,064 to install and implement a new control system at the facility. Funding is available within the PSF Construction Fund to facilitate this work with City Council approval.

The following is a summary of the pricing and temperature control work described in Bulletin #3 and pricing provided by Control Solutions and Wise Plumbing and Heating.

During the pricing of Bulletin #3 it was becoming evident to Control Solutions Inc. that the cost was going to be significantly more than the original target price of \$20,000. For this reason the cost of the work has been broken into Bulletin #3: Base Bid, and Alternate #1, #2, & #3.

The Base Bid work includes the new temperature control front-end Tridium Vykon control system, and the work required to interconnect the (2) air handlers, (2) condensing units, and (2) new boilers to the new control system, and provide graphics, training, etc.. A complete list of the scope of work can be found in the quote from Control Solutions Inc. Note that Wise Plumbing and Heating provided additional cost for installation of the control valves, dampers, etc. to the Base Bid cost.

Add: \$26,186.00

Alternate #1 includes pricing for new variable frequency drives (VFDs) for the (2) air handler supply air fans. The pricing for this was included in the original budget by AKT Peerless and should have been planned for.

Add: \$5482.00

Alternate #2 includes pricing for new VFDs for the (2) air handler return air fans. The pricing for this was also budgeted by AKT Peerless. An option to postpone this work exists.

Add: \$3989.00

Alternate #3 includes the integration of the existing VAV boxes into the new control system. Integration of the existing VAV boxes will allow Control Solutions Inc. to control the existing VAV boxes to the fullest extent possible.

Add: \$3407.00

The total price to do all work is:

City of Alpena Bulletin #3 Pricing Summary

The original budget developed by AKT Peerless for the Alpena Public Safety Building HVAC upgrades was \$212,835.00. This budget did not include temperature control work, but AKT Peerless did list an additional \$100,000 budget for a total building temperature control system upgrade.

To date the contracted costs for all HVAC upgrade work to the Alpena Public Safety Building is \$184,499.40, which brings the project in \$28,335.60 under the originally estimated budget. Taking this into consideration, the cost of Bulletin #3 may be more easily accepted.

It should be understood that the temperature control work included in Bulletin #3 is essentially the minimum required to transition from the proprietary Trane temperature control system with expensive service agreements, to the new non-proprietary, Tridium Vykon control system.

There are not many options to reduce the cost that will not have a significant impact on the controllability of the existing equipment. Although there are three Alternates listed, there are significant disadvantages to not accepting the Alternates.

Alternate #1 could be omitted but AHU-1 would remain a constant volume system, and energy savings would not be realized. AHU-2 has an older existing VFD that could remain in place.

Alternate #2 could be omitted, but since the original system was designed with return air fans the extent of the need of the fans to overcome the return air static pressure is unknown. If VFDs were not installed, a new sequence of operations would need to be employed to ensure proper system airflow and relief air.

Elimination of Alternate #3 will remove all controllability of the existing VAV boxes. There are several VAV box zones within the building that struggle with overheating and poor ventilation, and acceptance of Alternate #3 is the first and most important step in improving building comfort.

In closing, and as a reminder, it is important to understand that the temperature control work included in Bulletin #3 is the first step in upgrading the building's temperature control system. Additional work with significant costs including VAV box control board replacement, VAV box control valve upgrade, and variable speed pumping are needed to fully upgrade the existing systems.

- 2. All work is to be provided in accordance with applicable codes.
- 3. The contractor is to insert the amount of the cost change in the appropriate blank space following each item.
- 4. The contractor shall submit pricing approval of Bulletin to AKT Peerless, the City of Alpena Engineering Office, and Nealis Engineering.

Changes to the original contract documents

M1 Reference Mechanical Plans and Specifications:

Install new 100% non-proprietary Tridium Vykon with Niagara AX Platform Building Control System (BCS). A general Tridium Vykon based temperature control specification is included as part of this Bulletin. See Digital Control


- A. Tridium Vykon with Niagara AX Platform front end control system.
- B. Tridium-based, native Bacnet controllers.
- C. All software, firmware, and hardware licenses shall be held by the City of Alpena.
- D. Graphics package shall be limited to the equipment and points listed below, but shall be expandable to include future control expansion.
- E. Include Smart-Phone HTML-5 temperature control system application.

In general, the scope of the temperature control work shall be limited to the minimum required to operate the areas served by existing VAV air-handlers AHU-1 and AHU-2 including the condensing units and VAV boxes. The new boilers and existing system pumps shall also be included. At this time, all of the existing HVAC equipment located in the apparatus bays, garages, equipment rooms, locker rooms, mezzanine, etc., including make-up air unit, infra-red tube heaters, unit heaters, exhaust fans, etc., shall remain stand-alone, and are not budgeted to be included in this scope.

A summary of the systems and components that require integration into the new BCS are listed below and include the following:

- 1. Full control of existing air handlers including OA, RA, and relief air dampers.
 - a. Install new Demand Control Ventilation CO2 control sequences into Ex. AHU-1 and Ex. AHU-2.
- Supply and return air fan modulation. Include new Yaskawa Z1000 (or equal) variable frequency drives (VFDs) for existing AHU-1 and AHU-2 air handlers supply air fans and return air fans (total of 4). Replace existing VFD on supply fan of AHU-2. Existing inlet vanes shall be locked in the 100% open position. Field verify fan horsepower. 208/3-phase.
- 3. Install new static pressure controllers on Ex. AHU-1 and Ex. AHU-2. If the budget is exceeded, reuse of the existing is approved.
- Provide new Belimo 3-way modulating control valves and actuators for new hot water coils for existing AHU-1 and AHU-2. Total of (2). HW Coil #1 Cv = 35/1.7 = 20.6; HW Coil #2 Cv = 54/2.6 = 20.8.
- 5. Include new Belimo modulating damper actuators as needed to control air handler dampers. Reuse existing actuators if possible to save initial cost. Coordinate with Engineer.
- 6. Provide new master OA sensor, and discharge air, and mixed air sensors.
- 7. Provide new freezestats (independent of new BCS) for Ex. AHU-1 and Ex. AHU-2.
- 8. Provide new control points for the following:
 - a. Ex. AHU-1 and Ex. AHU-2 fan, DAT, MAT, VFD frequency,
 - b. New CU-1 and CU-2 system status.
 - c. Boilers B-1 and B-2, monitoring of boilers only. TCC shall add a Modbus to Bacnet interface control board for each boiler to pull standard points from the Lochinvar Smart System controllers into the new TCS:
 - i. Boiler status
 - ii. Firing Rate
 - iii. Boiler pump status (total of 2)
 - iv. EWT (adjustable)
 - v. LWT
 - vi. Alarms
 - d. Existing system pump status (total of two motor status points)
- Integration of the existing VAV box control boards into the new TCS is not required unless absolutely necessary to ensure proper operation. Reuse existing Trane control trunk if possible to pull VAV box points and control VAV boxes and pull room set-points.
- 10. Provide additional control points as needed to ensure all critical control requirements are met. Provide line items for additional work scope as deemed necessary to keep previously arranged budget.
