City of Alpena Ordinance No. 22-472

An ordinance to amend the City of Alpena Zoning Ordinance Article 3 (General Provisions), Article 4 (Signs), Article 5 (Zoning Districts) and Article 7 (Supplemental Development Regulations).

City of Alpena, Alpena County, Michigan ordains:

SECTION 1: AMENDMENT TO THE CITY OF ALPENA ZONING ORDINANCE

That the City of Alpena Zoning Ordinance, Article 3 (General Provisions) is hereby amended to read as follows:

Section 3.28 Fences and Walls

B. Commercial and Industrial Fences and Walls: Fences and walls which are not part of an approved site plan require a Zoning Permit from the Zoning Administrator. All fences and walls shall comply with the following regulations and requirements:

Table 3.28B: Add footnote to Front Yard: Front yard fence setbacks do not apply to the Downtown Overlay District.

That the City of Alpena Zoning Ordinance, Article 4 (Signs) is hereby amended to read as follows:

Section 4.5 Regulations by Zoning Districts: Office, Business and Industrial Districts

E. Temporary Signs

- 1. **Number and Size of Temporary Signs**: No more than two (2) temporary signs shall be allowed per commercial or industrial establishment for a total of thirty (30) square feet in sum. The larger of any one (1) temporary sign shall be no greater than twenty (20) square feet.
- 2. **Portable Signs**: One (1) portable sign shall be considered the same as two (2) temporary signs and shall be no greater than thirty (30) square feet. The portable signs shall be permitted as a temporary sign for a period not to exceed fourteen (14) days in a one (1) year period. In no instance shall such sign be located so as to obstruct automobile or pedestrian travel lanes. Such signs shall neither be illuminated nor connected to an energy source. Such signs shall not constitute a safety hazard to the public.

3. A-Frame Signs:

- (1) Shall be permitted by right in the DOD, CBD, WD, CCD, OS-1, B-1, B-2, B-3, P-1, I-1, I-2, and PUD districts.
- (2) No more than one (1) sign per business per street frontage shall be allowed.
- (3) No permit is required.

- (4) Must be constructed of durable materials
- (5) Sign shall be removed when business is closed.
- (6) Maximum size 2' wide by 4' in total height for each panel with a maximum of 2 panels per sign. A-frame signs located entirely on private property may be a maximum of 3' in width.
- (7) Must be located on or adjacent to the lot in which the business is located. Exception: If a building has no front yard the sign may be located on the sidewalk. Signs located on the sidewalk shall provide at least three (3) feet of continuous pedestrian clearance.
- (8) Off-Premise A-Frame Signs: Sign may be located in a right-of-way as a directional off-premise sign upon approval by the Zoning Administrator. DDA Director approval is also required if the sign is proposed within the DOD.
- 4. Non-rigid material which is used to cover an existing permanent sign shall be placed on the sign on a temporary basis not to exceed six (6) months. Such material shall not be considered a temporary sign and shall not be affixed permanently to the sign.

That the City of Alpena Zoning Ordinance, Article 5 (Zoning Districts) is hereby amended to read as follows:

Section 5.13 Downtown Overlay District

B. Design Standards

14. Sidewalk Encroachment

- a. **Outdoor Seating**: See Section 7.28 (Outdoor Seating and Dining Service).
- b. Awnings: First floor awnings may encroach upon the frontage line and public sidewalk but must avoid street trees. At least eight (8) feet of clearance must be provided above the sidewalk and set back a minimum of two (2) feet from the curb.
- c. Street Furniture: Benches and trash receptacles may be permitted in areas where feasible.

That the City of Alpena Zoning Ordinance, Article 7 (Supplemental Development Regulations) is hereby amended to read as follows:













Section 7.28 Outdoor Seating and Dining Service

Outdoor seating or dining service operated by a restaurant or other food or drinking establishment which sells food for immediate consumption may be permitted, subject to the following conditions:

A. Private Property and Public Right-of-Way:

- 1. The request for outdoor seating or dining service may be included as part of the original site plan review for the business. If the request is made subsequent to the original site plan approval, a review and approval of a plot plan (at no cost to the applicant) is required prior to placement of any fixtures.
- 2. A zoning permit and/or building permit may be required, depending on the plot plan
- 3. The exterior of the premises shall be kept clean, orderly, safe, and maintained
- 4. Exterior food preparation may be permitted if approved by the Health Department
- 5. Outdoor seating and service shall be allowed during normal operating hours of the establishment
- 6. Outdoor seating and service may not be in operation on property adjacent to a residentially zoned district between the hours of 12:00 a.m. and 7:00 a.m. unless otherwise approved by City Council.

B. Additional Requirements for Outdoor Seating and Service on the Public Right-of-Way:

- 1. Requests for outdoor seating on a public right-of-way (e.g. sidewalk, alley) may require review by City Council as determined by City Staff
- 2. Fences or railings are prohibited on sidewalks unless approved as part of a plot plan application.
- 3. A clearance minimum of three (3) continuous feet for pedestrian traffic is required on a public right-of-way
- 4. Business owner shall be required to list the City of Alpena as an additional insured for comprehensive general liability insurance

SECTION 2: SEVERABILITY

If any clause, sentence, paragraph or part of this Ordinance shall for any reason be finally adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance but shall be confined in its operation to the clause, sentence, paragraph or part thereof directly involved in the controversy in which such judgment is rendered.

SECTION 3: SAVING CLAUSE

The City of Alpena Zoning Ordinance, except as herein or heretofore amended, shall remain in full force and effect. The amendments provided herein shall not abrogate or affect any offense or act committed or done, or any penalty or forfeiture incurred, or any pending fee, assessments, litigation, or prosecution of any right established, occurring prior to the effective date hereof.

Subject: 2022 MEDC Water-Related Infrastructure Grant

In April, the Michigan Economic Development Corporation, MEDC issued a grant opportunity under the Water-Related Infrastructure, WRI, program. This program is targeted at assisting low-moderate income communities by proving funding up to \$2,000,000 via competitive grants. The grant has an application deadline of May 13, 2022.

The City applied for this grant in 2021 for North Second Avenue from Carter Street to Hueber Street and was unsuccessful. After a discussion with the grant staff who reviewed our application, the City has decided to reapply for consideration with modifications suggested during this meeting which could strengthen our application.

The proposed project involves replacement of the water and sewer lines in North Second Avenue from the Carter Street to Hueber Street. It will also include replacing the water main under the Thunder Bay River at Second Avenue. The estimated project cost for these improvements is \$4,431,940. This project was included in the CIP spanning two years beginning in 2022 with completion in 2024.

The City will be requesting the grant maximum of \$2,000,000 from MEDC – WRI and will be matched with an estimated \$2,431,940. The project needs to be advertised for bidding by December 31, 2022, under construction by May 2023, and completed by December 31, 2024. The Engineering Department can meet the design and bidding timelines as mandated.

It is therefore my recommendation, as City Engineer, that Council adopt Resolution 2022-06 authorizing the City to apply for these funds, committing the needed match funds, and authorizing Rachel Smolinski as the authorized contact for the City of Alpena.

Subject: 2022 TEDF Category F Grant Application – Long Rapids Road

In March 2022, the Michigan Department of Transportation sent out a call for applications for the 2024 Category F projects. This funding is available to urban areas in rural counties for improvements to secondary all-season access routes within the federal aid system.

The City pursued this grant for resurfacing Long Rapids Road from Bagley Street to Medilodge for the 2021 call for projects but was unsuccessful. Long Rapids Road qualifies for the grant due to the amount of traffic, the increased number of commercial vehicles this section of roadway handles, and because the roadway has begun to deteriorate to the point where a resurfacing project is warranted.

After a discussion with the Category F coordinator for the Michigan Department of Transportation, the City was encouraged to resubmit for the grant this year as the application submitted last year was a strong application and was not selected due to funding availability. In addition, suggestions were made to make this year's application stronger.

The project proposes milling the top six inches off the street, adjusting the manholes and water boxes, replacing the existing sidewalk ramps to meet current ADA requirements, installing a thicker six-inch cross section of asphalt, and restriping. The additional depth of asphalt will increase the strength of the street and allow it to withstand the traffic load. The estimated cost of the project is approximately \$509,435.75. Category F could fund 80% of the project up to \$375,000 leaving a local match of \$134,435.75.

It is my recommendation, as City Engineer, that council adopt the attached resolution 2022-05 to authorize staff to submit a grant application for the TEDF Category F - Urban Areas in Rural Counties program and commit to the local match estimated at \$134,435.75. This amount will be programmed into the 2023-24 budget year. We expect notification for the grant in December of this year.

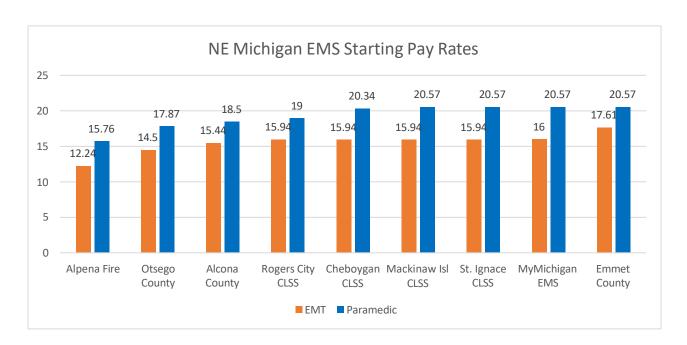

Re: Firefighter pay adjustment

As you are aware, there is a critical shortage of paramedics and other public safety personnel nationwide. COVID-19, coupled with increased education/accreditation requirements and societal changes have dramatically reduced the pool of potential applicants for open positions. At the same time, we have lost at least one existing employee and three new hires to other departments because of low pay and average benefits. I conducted a salary survey of Northeast Michigan ambulance services to verify whether our pay is comparable. I was shocked to learn that even much smaller services pay significantly better than we do. And, to make things worse, none of the surrounding agencies provide fire suppression, ice and water rescue, extrication, hazardous materials, confined space, high or low angle rope, or other technical rescues. Most aren't trained and certified for critical care transport as well. All other agencies surveyed are non-fire; therefore, our personnel have far more responsibility and expectations.



Benefits offered are very similar for most services, yet at one time, the City of Alpena was considered a leader with our benefits package. Over the years, we have made a conscientious effort to be fiscally conservative and responsible; therefore, these benefits have been reduced. We are now having difficulty attracting and retaining employees in today's job market. We need personnel who are highly trained and credentialled to maintain minimum staffing required for the Alpena County ambulance contract. Adequate staffing levels allow our staff to respond to emergencies in a timely manner as well. We currently have three openings, and two employees off on medical leave from injuries or illness. We anticipate additional retirements in the next couple of years. Our staffing is now at a critical level, especially considering the number of runs we are responding to each day.

I believe the right thing to do at this point is to institute a \$1.53/hour pay adjustment for all FD response personnel, except the Fire Chief and Deputy Chief (who are administrative positions). This will put our starting pay for firefighter- EMTs at \$13.77/hour and firefighter-paramedics at 17.29/hour. This would put us within the range of our neighbors, although still in the bottom half of the ambulance services survey overall.

There will likely be requests from other City employee groups. City Manager Smolinski and HR Director Himes will begin to analyze wages and salaries state-wide to determine whether additional adjustments will need to be considered for other employee groups.

The cost of this increase is approximately \$27,000, based on straight-time hours for the balance of this fiscal year. The increase would be approximately \$119,000 based on straight-time hours in the 2022-23 fiscal year.

As Fire Chief, and with the concurrence of management, I recommend that Council approve a \$1.53/hr. wage adjustment for all IAFF-represented employees effective April 5, 2022.
