COUNCIL PROCEEDINGS

October 5, 2017

The Municipal Council of the City of Alpena met in special session upon the call of the City Clerk, at the Long Rapids Township Hall on the above date and was called to order at 7:00 p.m. by the Mayor.

Present: Mayor Waligora, Councilmembers Johnson, Nielsen, and Nowak.

Absent: Sexton.

The Municipal Council met in a special workshop session with the Alpena County Board of Commissioners and Alpena County Township Supervisors to present updates and exchange information on current activities in the community. The facilitator for the meeting was Carlene Przykucki.

Minutes were reviewed for the June 1, 2017, Intergovernmental Council Meeting.

PUBLIC COMMENT

Aaron Weed, Oscoda Township Supervisor, wanted to discuss industrial chemical contamination in Alpena County. Oscoda has the contamination from the Air Force Base. Perfluoroalkyl Acid (PFA's) and Perflourooctanoic Acid (PFO's) are industrial chemicals that were used in firefighting foams, and have health risks that the Environmental Protection Agency (EPA), and local health departments are concerned with, the permissible levels and cleanup contamination are a concern to local residents. Mr. Weed is concerned about the levels that the EPA allows.

GOVERNMENTAL ENTITY REPORTS

Mayor Waligora reported that Second Avenue, between Chisholm and River Street, will remain as a one-way street. The Dog Park has been delayed due to the failure of the North Riverfront walkway. The Mayor and City Manager sit on the Joint Land Use Study Committee, the purpose is to get a better understanding of how military bases affect the residents living and working in those areas. There was a public meeting held on the Joint Land Use Study in Alpena last month, there was a very low turn-out. There will be another public input session at 6:00 p.m. on Wednesday, October 11, 2017, at the Alpena County Library.

City Manager Sundin reported on the current introduction of legislation by the State Senate and House of Representatives that affects short term rentals. The Bill will make short term rentals the same as residential housing. It could eliminate rental inspections and/or zoning requirements.

Alpena County Commissioner Adrian reported on the 800 MH radios and pagers

throughout the County and the need to upgrade the system, which will be more reliable. He gave an update on the airport terminal, and the revisions to the design of the building. Also, enplanements are staying up, and will probably reach the 10,000 benchmark for the 2017 year. On December 1, 2017, the Health Department Building will become County property. He also said that the Director of the Health Department is aware of the dangers of PFA's. Long Lake Park is in the process of constructing a new bathhouse, and possibly a new boat launch. The County is interviewing for a new 911 Coordinator. The jail project is moving along, and tours and presentations on the current jail are being offered.

Long Rapids Township Supervisor Lumsden reported that the clean-up of the Thunder Bay River from Hillman to Alpena will be completed by mid-October. The area will be accessible for kayaking and canoeing. More clean-up will be performed in the spring as well as finishing the park. Howard also announced that there will be a Michigan Township Association (MTA) Chapter Meeting, October 16, 2017, at 7:00 p.m., at Maple Ridge Hall for a presentation on the jail project.

Sanborn Township Supervisor Gauthier reported that they are on their third Clerk this summer. The beach park now has basketball courts, and Beebe Street Park has had a parking area installed, and clean-up of some invasive species.

Green Township Supervisor Smith reported that trees are being pulled out on the back of Manning Hill Park for access to the old sledding hill. The Township has been distracted by the gas industries protests of their property taxes.

PRESENTATION GIVEN BY THE DIRECTOR OF TRAFFIC SAFETY PROGRAM PROSECUTING ATTORNEY'S ASSOCIATION OF MICHIGAN

The Guest Presenter was Ken Stecker, Director of Traffic Safety Training Program Prosecuting Attorney's Association of Michigan. Mr. Stecker presented facts and figures on the laws, fees, and possession limits of the 29 Legal Medical Marihuana States (including Michigan) and Washington DC. The Michigan Medical Marihuana Act can be found in Chapter 333, Section 333.26427 of the MCL.

Michigan will begin officially handing out licenses to growers, testing facilities, transporters, and dispensaries in 2018. The applications for licenses will become available on the Michigan Department of Licensing and Regulatory Affairs (LARA) website December 15, 2017. A person may apply to the Medical Marihuana Licensing Board for licenses in the following categories: Class A, B, or C Grower, Secure Transporter, Process, Provisioning

Center and Safety Compliance Facility. However, a person cannot apply to the State of

Michigan for a license unless a municipality has adopted an ordinance that authorizes that type

of facility.

Municipalities may also limit the number of facilities, and adopt other ordinances

regarding zoning regulations. They cannot impose regulations regarding the purity or pricing of

marihuana, or interfering, or conflicting with statutory regulations for licensing marihuana

facilities.

The medical marihuana business is projected to generate revenues of more than \$700

million, and if a ballot proposal goes to voters in 2018, and the market is opened for recreational

use, those revenues will easily surpass \$1 billion.

Mr. Stecker presented statistics involving the negative effects of marihuana use, including

impaired driving, addiction, and child pot poisoning. In addition, there are odor, health, and

safety issues involved in the production of cannabis. There is also the danger from making

Butane Hash Oil (BHO). There have been fire and explosion incidents recently tied to extracting

tetrahydrocannabinol (THC) from marihuana due to the use of butane, a highly flammable

solvent.

A question and answer period followed the presentation.

PLANNING SESSION

The topic for the next Intergovernmental Meeting will be a discussion of the

contamination in Oscoda Township and their relationship with the State and Federal

Government.

The Alpena Intergovernmental Council will meet again on February 1, 2018, at 7:00 p.m.,

hosted by Maple Ridge Township.

On motion of Councilmember Nowak, seconded by Councilmember Johnson, the Council

adjourned at 9:00 p.m.

Subject: Community Engagement Statement

For the last couple years, the City of Alpena has been engaged in the MEDC's Redevelopment Ready Communities (RRC) program. This program is an effort for participating communities to have consistent standards in place that are assessable and easy to find and allow potential developers easy access to the information that they need to make informed decisions. To that end, there are a number of plans and processes that the City is required to have in place to become RRC Certified. Many of these plans were items the City of Alpena have already been completing, such as having an updated Zoning Ordinance, Comprehensive Plan, and CIP.

One plan required by the RRC program is a public participation plan or Community Engagement Statement. This is a central document that allows anyone to see the efforts and various tools that the City of Alpena utilizes for public outreach. While the City of Alpena has always made efforts to engage the community as much as possible and include the public in the decision making process, a centralized document describing these efforts has never existed. By having these methods of engagement in one location, both public and City staff can better evaluate the current methods used and potential methods of engagement that could be used in the future.

The included plan outlines the objectives of community engagement, the regulations the City has to follow, the key stake holders, the various review bodies within the City, the methods of community participation, and how the City communicates the results of that participation.

The Community Engagement Statement was approved by the Planning Commission at their October meeting and now staff would request that the City Council approves the Community Engagement Statement.



City of Alpena Community Engagement Statement

September 25, 2017

Objectives:

The City of Alpena will continue to involve the entire community as "key stakeholders" in the future development of our City.

- The City of Alpena evaluates each project on an individual basis to determine project scope, stakeholders, project limitations, approving body, points of community impact during the decision making process, internal and external resources, and level of appropriate community involvement.
- The City of Alpena makes information available in a timely manner to enable interested parties to be involved in decisions at various stages of the review and approval process.
- The City of Alpena engages citizens in a transparent manner, making information easy to access for all interested members of the community.
- The City of Alpena seeks public participation for matters involving future development of the City, such as the Comprehensive Plan and Zoning Ordinance update process.
- The City of Alpena seeks creative ways to involve a diverse set of community stakeholders in planning, land use, and development decisions.
- The City of Alpena uses comments and information received from interested members of the community to make decisions regarding planning, land use, and future development.
- The City of Alpena tracks and analyses the results of all public participation to the extent feasible and provide summaries back to the public.

In the City of Alpena, each project will be evaluated on an individual basis to ensure inclusion for all stakeholders in the community. Each will vary according to the project being reviewed. Possible key stakeholders include, but are not limited to:

- Emergency personnel
- Target Alpena Development Corporation
- Alpena Area Chamber of Commerce
- Convention and Visitors Bureau
- Commercial business owners and their employees

- Industrial facilities located in the City
- Neighborhood groups
- Real Estate Professionals
- City Boards and Commissions
- Churches
- Schools
- Municipal Employees
- Michigan Department of Transportation
- Senior groups
- Community visitors and tourists
- Utility providers

Process of Development

There are various times in the planning process when the City Council, Planning Commission, and/or the Zoning Board of Appeals request public input. These processes include public hearings for rezoning of land, development of the Zoning Ordinance, the Comprehensive Plan, requested variances, and Special Land Uses. The flow chart in Appendix 1 outlines the various steps for these processes.

Development Review Bodies

The City of Alpena encourages citizen participation in local government planning and policy decisions. All residents are invited to apply for appointments to City boards and commissions. Vacant positions are advertised on the City's Website at

http://www.alpena.mi.us/human%20resource/board%20app%20form%202010.pdf.

City Council

Alpena's City Council is composed of 5 members. The mayor, and 4 at-large Council members. All City Council positions are voted on by the citizens of Alpena. For many processes (excluding site plan review and variances) Council is the final approving body.

Planning Commission

The Planning Commission is a nine member body. All members are appointed by the Mayor and Council for 3 year terms. Planning Commissioners deal with development issue in the City such as rezoning, special land uses, and site plans. Often times, they are the recommending body to City Council. They are responsible for writing the Zoning Ordinance and updating the Comprehensive Plan.

Zoning Board of Appeals

The Zoning Board of Appeals has 7 members. Each member is appointed by the mayor for a 3 year term. When a resident of the City cannot meet the zoning ordinance requirements, an application for a variance is filed with this body.

There are many other boards and committee's throughout the City. Agendas and dates/times of the meetings and meeting minutes can be found in the government tab of the City's website at www.alpena.mi.us.

Open Meetings

All meetings of the City Council, and its various boards and commissions, shall be open to the public in accordance with the "Open Meetings Act," PA 267 of 1976 as amended, except closed session meetings as provided for in the Act. Public notices for these meetings are printed in the paper and posted at City Hall (as required by the Act). The following processes require that neighbors within 300 feet of a property are personally notified:

- Rezoning of property
- Special Land Use
- Variance requests

Statutes require these processes be noticed in a newspaper of general distribution in the City (The Alpena News) as well as mailed to neighbors within 300 feet at least 15 days prior to the meeting. All meetings are held in a facility accessible to persons with disabilities, and the City will provide reasonable accommodations or services if a request is made to the City Manager's Office.

Interested persons are encouraged to contact the City Clerk or to check the City's website at: www.alpena.mi.us in order to be kept informed of any meeting schedule, agendas, variations, or location changes. Meeting agendas and/or packets are available on the City's website in advance of the meeting.

Methods of Community Participation

Each project's initial evaluation will determine the necessary level of involvement for the project. The following are methods that may be used to reach appropriate level of public participation when taking action on land use or development applications or projects. The City of Alpena will always attempt to use more than one tool or method, depending on the specific project and target audience. This list is flexible and can change based on each project's needs and circumstance.

Inform- Provide information and assist public understanding

- **Website:** <u>www.alpena.mi.us</u> announces meetings, posts packets and agendas, minutes and sometimes will contain pages or links for topics of major interest.
- YouTube: City Council meeting are recorded and placed for worldwide viewing on Youtube.
- **Announcements:** Announcements during meetings of the City Council, Planning Commission, and other boards and commissions.
- **Printed Postings:** Available for viewing at the City Hall lobby board.
- **Press Releases and media:** At various times, the City will issue press releases and information for articles to various media outlets. (Including WBKB TV, TrueNorth Radio, WATZ Radio, and The Alpena News.)
- **Email or Postal Mail:** Interested parties may request to the City Clerk that they be notified personally of meetings/topics for discussion and postal mailings to neighbors within 300 feet, according to statute.

Consult- Obtain public feedback

- **Surveys:** Utilizing online and paper surveys allows for the collection of large amounts of data and opinions from the public.
- **Public Hearings:** Public attendance at meetings is strongly supported and allows for an appropriate venue for public input.

Involve- Work directly with public throughout the process

- **Open houses:** In order to create two-way communication, the City will hold open house events for projects and initiatives as needed.
- **Community Workshops:** Issues that require community feedback can benefit from a noticed workshop.
- **Charrettes:** Multiple day design charrettes and information gathering sessions allow a larger group of people to participate in the community engagement activity.

Collaborate- partner with public in each aspect of decision making

- Advisory Committees: The City uses advisory committees for specialized aspects of our community to enhance collaboration between City staff and the public.
- **Focus Groups:** Bringing together stakeholders to discuss and brainstorm decision making options.

Communicating Results

The City of Alpena will publicly communicate all results of community input on planning and development issues. The City will utilize one or more of the "Inform" methods to relay results back to the public.

Updating the Community Engagement Plan

Like all documents, the City of Alpena understands that the Community Engagement Plan will need to be reviewed and updated on a routine basis. This plan will be updated as needed, at a minimum of every 5 years, in conjunction with the City's Comprehensive Plan. Updates to this plan will be drafted by staff, reviewed and recommended by Planning Commission, and approved by City Council. At least one public input session will be held during the process to gather input to generate new ideas.
