WHEREAS, this Board of Education by resolution of November 10, 2005, determined to impose a summer property tax levy to collect one hundred percent of school property taxes upon property located within the intermediate school district, beginning with 2006 and continuing from year to year until specifically revoked by this Board of Education.

NOW, THEREFORE BE IT RESOLVED THAT:

- 1. This Board of Education, pursuant to 1976 PA 451, as amended (the Revised School Code), hereby invokes for 2019 its previously adopted ongoing resolution imposing a summer property tax levy of one hundred percent of school property taxes upon property located within the educational service district, beginning with 2006 and continuing from year to year until specifically revoked by this Board of Education and requests each city and/or township in which this district is located and in which a local school district or city is concurrently imposing a summer property tax levy to collect those summer taxes.
- 2. The Superintendent or his/her designee is authorized and directed to forward to the governing body of each city and/or township in the County of Alcona, City of Alpena in which this district is located and in which a local school district or city is concurrently imposing a summer property tax levy on an ongoing basis, and a copy of this resolution requesting that each such city and/or township agree to collect the summer tax levy for 2019 in the amount as specified in this resolution. Such forwarding of the resolutions and the request to collect the summer tax levy shall be sent so that they are received by the appropriate governing bodies before January 1, 2019.
- 3. Pursuant to and in accordance with Section 1613(I) of the School Code, the superintendent or his/her designee is authorized and directed to negotiate on behalf of this district with the governing body of each city and/or township in which the district is located for the reasonable expenses for collection of the district's summer property tax levy that the city and/or township may bill under MCLA 380.1611 or MCLA, 380.1612.
- 4. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution be and the same are hereby rescinded.

PERFORMANCE RESOLUTION FOR GOVERNMENTAL AGENCIES

This Performance Resolution is required by the Michigan Department of Transportation for purposes of issuing to a municipal utility an "Individual Permit for Use of State Highway Right of Way", or an "Annual Application and Permit for Miscellaneous Operations within State Highway Right of Way".

RESOLVED WHEREAS, the	City of Alpena
•	(city, village, township, etc.)

hereinafter referred to as the "GOVERNMENTAL AGENCY," periodically applies to the Michigan Department of Transportation, hereinafter referred to as the "DEPARTMENT," for permits, referred to as "PERMIT," to construct, operate, use and/or maintain utilities or other facilities, or to conduct other activities, on, over, and under State Highway Right of Way at various locations within and adjacent to its corporate limits;

NOW THEREFORE, in consideration of the DEPARTMENT granting such PERMIT, the GOVERNMENTAL AGENCY agrees that:

- Each party to this Agreement shall remain responsible for any claims arising out of their own acts and/or
 omissions during the performance of this Agreement, as provided by law. This Agreement is not
 intended to increase either party's liability for, or immunity from, tort claims, nor shall it be interpreted,
 as giving either party hereto a right of indemnification, either by Agreement or at law, for claims arising
 out of the performance of this Agreement.
- 2. If any of the work performed for the GOVERNMENTAL AGENCY is performed by a contractor, the GOVERNEMENTAL AGENCY shall require its contractor to hold harmless, indemnify and defend in litigation, the State of Michigan, the DEPARTMENT and their agents and employee's, against any claims for damages to public or private property and for injuries to person arising out of the performance of the work, except for claims that result from the sole negligence or willful acts of the DEPARTMENT, until the contractor achieves final acceptance of the GOVERNMENTAL AGENCY. Failure of the GOVERNMENTAL AGENCY to require its contractor to indemnify the DEPARTMENT, as set forth above, shall be considered a breach of its duties to the DEPARTMENT.
- 3. Any work performed for the GOVERNMENTAL AGENCY by a contractor or subcontractor will be solely as a contractor for the GOVERNMENTAL AGENCY and not as a contractor or agent of the DEPARTMENT. The DEPARTMENT shall not be subject to any obligations or liabilities by vendors and contractors of the GOVERNMENTAL AGENCY, or their subcontractors or any other person not a party to the PERMIT without the DEPARTMENT'S specific prior written consent and notwithstanding the issuance of the PERMIT. Any claims by any contractor or subcontractor will be the sole responsibility of the GOVERNMENTAL AGENCY.
- 4. The GOVERNMENTAL AGENCY shall take no unlawful action or conduct, which arises either directly or indirectly out of its obligations, responsibilities, and duties under the PERMIT which results in claims being asserted against or judgment being imposed against the State of Michigan, the Michigan Transportation Commission, the DEPARTMENT, and all officers, agents and employees thereof and those contracting governmental bodies performing permit activities for the DEPARTMENT and all officers, agents, and employees thereof, pursuant to a maintenance contract. In the event that the same occurs, for the purposes of the PERMIT, it will be considered as a breach of the PERMIT thereby giving the State of Michigan, the DEPARTMENT, and/or the Michigan Transportation Commission a right to seek and obtain any necessary relief or remedy, including, but not by way of limitation, a judgment for money damages.

- 5. The GOVERNMENTAL AGENCY will, by its own volition and/or request by the DEPARTMENT, promptly restore and/or correct physical or operating damages to any State Highway Right of Way resulting from the installation construction, operation and/or maintenance of the GOVERNMENTAL AGENCY'S facilities according to a PERMIT issued by the DEPARTMENT.
- 6. With respect to any activities authorized by a PERMIT, when the GOVERNMENTAL AGENCY requires insurance on its own or its contractor's behalf it shall also require that such policy include as named insured the State of Michigan, the Transportation Commission, the DEPARTMENT, and all officers, agents, and employees thereof and those governmental bodies performing permit activities for the DEPARTMENT and all officers, agents, and employees thereof, pursuant to a maintenance contract.
- 7. The incorporation by the DEPARTMENT of this resolution as part of a PERMIT does not prevent the DEPARTMENT from requiring additional performance security or insurance before issuance of a PERMIT.
- 8. This resolution shall continue in force from this date until cancelled by the GOVERNMENTAL AGENCY or the DEPARTMENT with no less than thirty (30) days prior written notice provided to the other party. It will not be cancelled or otherwise terminated by the GOVERNMENTAL AGENCY with regard to any PERMIT which has already been issued or activity which has already been undertaken.

BE IT FURTHER RESOLVED, that the following position(s) are authorized to apply to the DEPARTMENT for the necessary permit to work within State Highway Right of Way on behalf of the GOVERNMENTAL AGENCY.

Subject: Industrial Development District Establishment at 316 and 318 Cavanaugh for WG

Benjey.

As Council previously discussed in the rezone request PC 18-Z-02, WG Benjey Inc. is proposing to construct a new industrial building located at the lots they own at 316 and 318 Cavanaugh directly across from their existing industrial facility located within an industrial zoning district. WG Benjey is now requesting an Industrial Development District is established. If the Industrial Development District is established that would allow the company to request an Industrial Facility Tax (IFT) Exemption. The company would be eligible for this exemption based on the rating system established by the City of Alpena. If approved, this exemption would reduce eligible property taxes by 50%.

The proposed industrial building constructed is 13,500 square feet in size and consists of \$1,067,000 of private investment, creating 12 additional new jobs within the proposed district.

Staff would request that Council conduct a public hearing to establish the Industrial Development District and adopt the enclosed Resolution 2018-07.

WHEREAS, construction, acquisition, alteration, or installation of a proposed facility has not commenced at the time of filing the request to establish this district; and

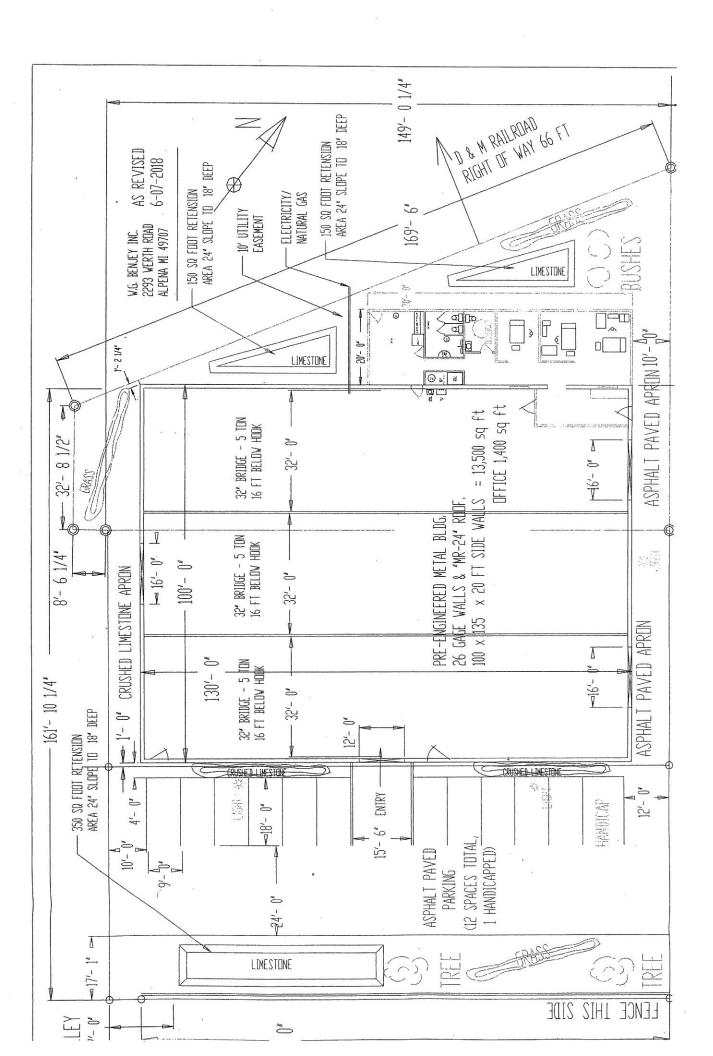

Election costs for November 6, 2018 General Election

The costs for the November 6th General Election totaled \$11,093. Last year's General Election expenses totaled \$8,783. The increased cost this year was due to training for the election workers and office staff, instituting an absentee voter counting board, and ordering more ballots.

The City had 8,201 registered voters at the time of the election, which is an increase of 88 voters since the last November Election. The voter turnout was 54% which equals 3,548 voters at the polls and 878 absentee ballots that were processed. The November 2017 election turnout was 23%, while the November 2016 Presidential Election was over 59%.
