You may require that one (1) charge be dismissed by taking a Drivers Safety Course (DSC). A phone call does not constitute an appearance.

ELIGIBILITY REQUIREMENTS:

- 1. Valid Texas Drivers License (No CDL) or Military/Dependents with an out-of-state-Drivers License
- 2. DSC not taken in the last 12 months for the dismissal of a traffic violation
- 3. Personal Liability Insurance (effective the date of the citation)
- 4. Less than 25 mph over the posted speed limit and alleged speed not 95 mph or more
- 5. Not cited for Construction Zone/Workers Present

IF YOU ARE ELIGIBLE, YOU MUST, ON OR BEFORE YOUR APPEARANCE DATE SUBMIT THE FOLLOWING TO THE COURT:

- 1. A Plea of Guilty or No Contest (see form below)
- 2. A Sworn Affidavit (see form below)
- 3. Provide proof of liability insurance (Personal Ins.-Effective the date of the citation)
- 4. Pay proper fee-\$146.00 (CASHIER'S CHECK OR MONEY ORDER PAYABLE TO BELL COUNTY IF MAILING IN)
- 5. Copy of Drivers License

If you are eligible and submit the above to the Court on or before your appearance date, you will then have ninety (90) days from the appearance date to take any State Approved DSC. The school that you attend **does not** submit the certificate to the Court; it is your responsibility to produce the certificate of completion to the Court. A fine of \$200.00 may be charged if the course is not completed within the prescribed time limit.
