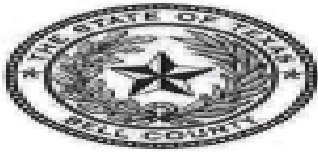
Sec. 42.031. REVIEWING PRECINCTS FOR COMPLIANCE: BOUNDARY CHANGES. (a) During March or April of each odd-numbered year, each commissioners court shall determine whether the county election precincts comply with Sections 42.005, 42.006, and 42.007. The commissioners court may make that determination during March or April of an even-numbered year. Before May 1 of the year in which the determination is made, the commissioners court shall order the boundary changes necessary for compliance.

(b) The commissioners court may order a boundary change only during March or April unless the change is necessary to:

(1) comply with Section 42.005 or 42.032;

(2) reduce the number of registered voters in a precinct so it does not exceed the maximum number permitted by Section 42.006; or

(3) include within a precinct a suitable building available for use as a polling place if no suitable building is available for that purpose within the existing precinct boundary.



Public Notice

The Bell County Commissioners Court, Pursuant to Section 42.031 of the Texas Elections Code, has reviewed the election precincts for compliance. As a result, the Bell County Commissioners Court has approved the addition of three separate election precincts. Notice is hereby given that the Bell County Commissioners Court has ordered a change of three county election precincts' boundaries as follows:

1. Precinct 101 will be divided along FM 439 until it reaches 2271. Streets North of 439 and West of 2271 will become the new Precinct 118, while streets South of 439 and East of 2271 will remain in Precinct 101.
2. Precinct 103 will be divided along West Highway 190. Streets North of W. Highway 190 will remain in Precinct 103, while streets South of W. Highway 190 will become the new Precinct 119.
3. Precinct 317 will be divided along South 31st Street. Streets West of S. 31st Street will remain in Precinct 317. Streets East of S. 31st Street will become the new Precinct 319.

The Bell County Commissioners Court's order is consistent with Section 42.006 of the Texas Elections Code in reducing the number of registered voters in election precincts that exceed the maximum permitted number of 5000. Hence, the number of registered voters is recorded as follows: Precinct 101 with 3,498, Precinct 118 with 2,446, Precinct 103 with 2,052, Precinct 119 with 2,997, 317 with 1,711 and 319 with 3,326.

By this order, the Bell County Elections Administrator shall take all required procedures consistent with Section 42.035 of the Texas Elections Code.

So, it was ordered by the Commissioners Court to be effective on January 1st, 2024.

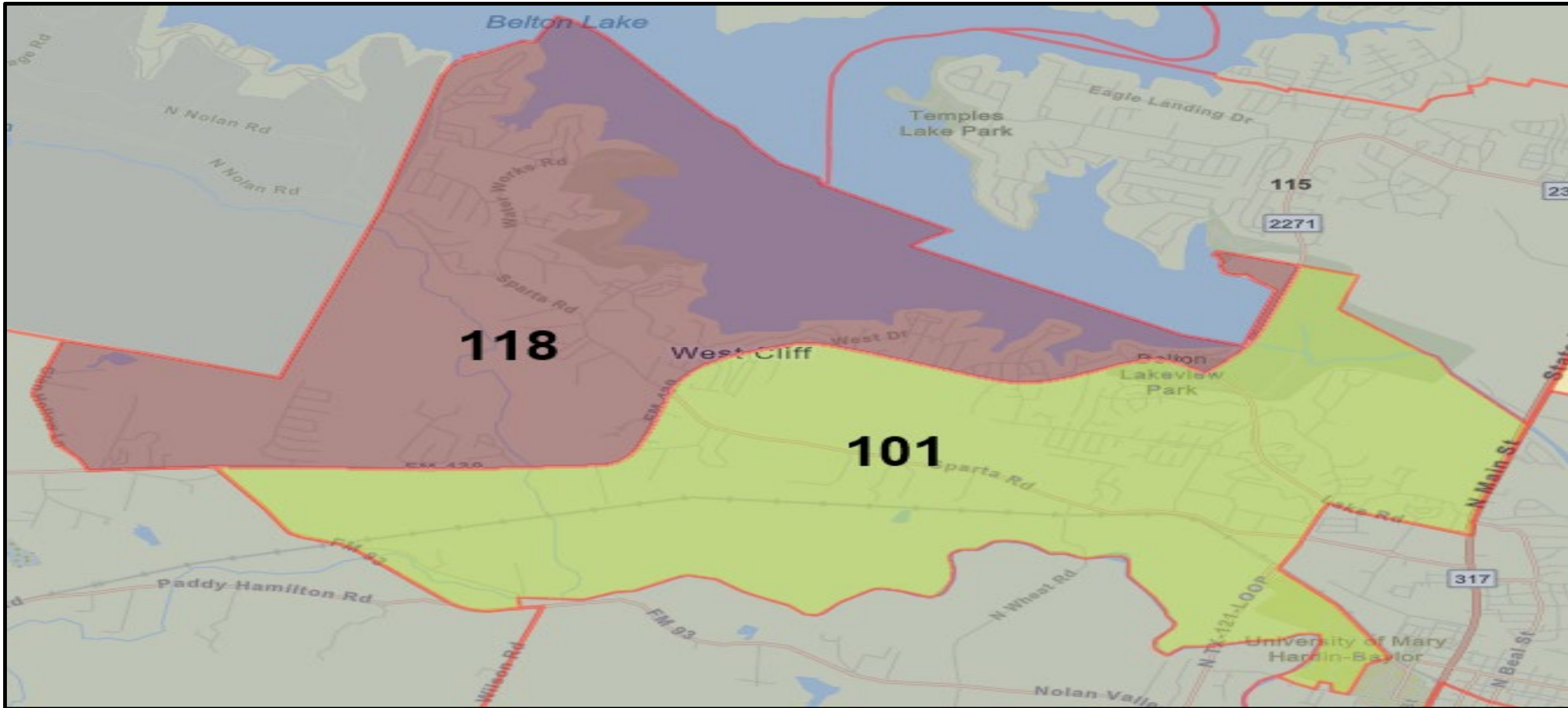

Precinct **118**: 2,446

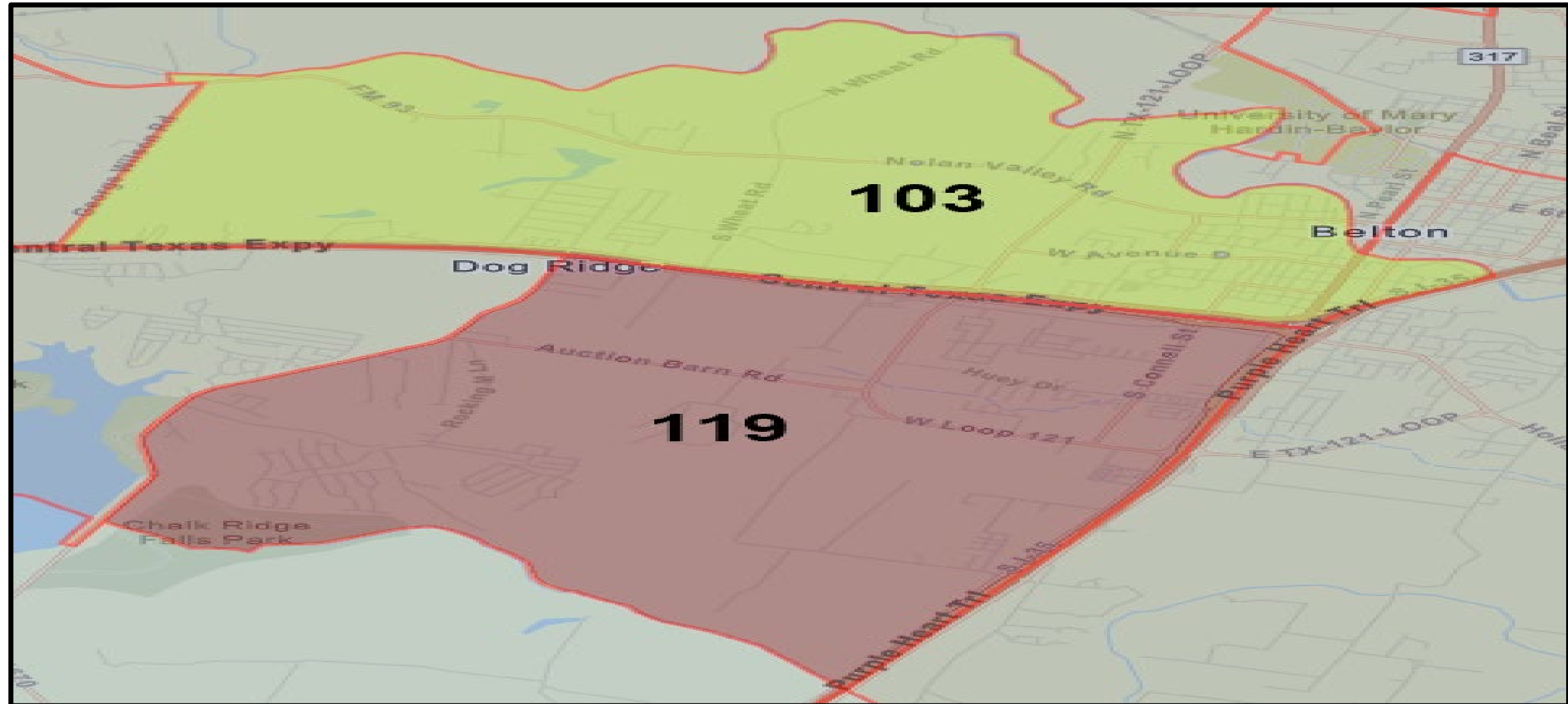




Ordered split along 190
