Once the application is approved a Certificate of Compliance shall be issued which shall remain valid until the business has changed, expanded or relocated. A new Certificate of Compliance must be obtained prior to any such changes.

The Adults Only Establishment is required to operate in compliance with all applicable development regulations and operational standards of the area. The applicant is responsible to comply with all County and State Regulations. The Adults Only Establishment Location Permit is not a Building Registration Certificate and/or Floodplain Permit, Business License, Liquor License or any other Permit or License. Building Registration Certificates and/or Floodplain Permits must be secured prior to any new construction or remodeling of an existing structure in Cabell County, West Virginia. The Adults Only Establishment Location Permit only allows the applicant to locate the business in Cabell County as an Adults Only Establishment.

I certify that no public entrance to the proposed business location is not located within 2000 feet (each of the prescribed distances in Section 4.1 to a public entrance of an Adults Only Establishment shall be measured along a straight line from the nearest property line of the tract from which the measurement is to be made) of any property on which is situated any of the following: a public or private child daycare facility, kindergarten, elementary, grade, middle, junior, senior, secondary or vocational school; a public or private institution of higher education; a public or private business school or college; a public park or recreational facility; including but not limited to a park, a playground, nature trail, swimming pool, athletic field, basketball court, tennis court, wilderness area or other similar public land within the Territorial Limits or otherwise; a public library; a church, mosque, temple or synagogue or other building used as a place of religious worship or instruction; a Federal, state, county or municipal office building; another adults only establishment; an establishment that is licensed to serve alcoholic beverages; or, a residence (as described in the Cabell County Adults Only Establishment Location and Regulation Ordinance in Article 4, Section 4.1 Location et seq.).
