BETWEEN JULY 2023 TO JUNE 2024, CVSAN ACHIEVED:

CVSan’s Wastewater Department, led by the Engineering staff, continued work on District Project 96 – CVSan Operations and Engineering (O&E) Building project over the past year. This involved the continuation of construction activities, including the site grading, underground utilities, completion of the installation of the building foundation, completing the installation of the steel structural components, and beginning to install the metal wall framing. Construction is anticipated to be complete in early 2025. This new building and its facilities will serve as CVSan’s new headquarters and will allow CVSan and its staff to execute its mission, providing solid waste and wastewater services to the residents and ratepayers of Castro Valley for decades to come. CVSan also completed the construction of the Inflow and Infiltration (I&I) Reduction Project. The pipeline repair and rehabilitation project focused on severe defects located near or at storm drain utilities. This project aimed to improve the condition of our infrastructure, where CVSan has historically seen a presence of I&I, possibly due to defects in the stormwater utilities.





Financials and Rates



CVSan is responsible for maintaining over \$400 million worth of assets. In order to maintain these assets, keep enough funding in reserves, and account for future investments, CVSan relies on long-range financial planning. CVSan uses third-party consultants to evaluate its sewer service charge (SSC) every six years. CVSan also has a third party conduct a review of solid waste rates annually to ensure our customers are not overpaying for services. Rate adjustments allow CVSan to continue improving its quality of service and maintain sufficient reserves even after major expenditures in infrastructure improvements. 
2024/25 ANNUAL SEWER SERVICE RATE

This rate funds the costs of the maintenance, operation, and replacement of the facilities necessary to collect, treat, and dispose of the wastewater generated from your home. CVSan’s annual sewer service rate is lower than the \$806 average annual sewer service rate in Alameda County.

Solid Waste Rate Information \$35.80

This is the monthly cost for a 20-gallon garbage cart for a single-family home’s solid waste service provided by CVSan’s contractor, Alameda County Industries. This rate includes garbage, recycling, and organics collection. Please note, Canyonlands area customers do not receive organics service. Zero Waste Department

Textiles

A total of 46,770 pounds of textiles were collected through the October and June Textile Collection Weeks and the summer and spring Recycles Day events.



Green Ribbon

A total of \$20,360 was awarded to 14 Green Ribbon-certified schools at the May Board Meeting.



Zabble / SB 1383

CVSan piloted artificial intelligence (A.I.)-boosted software to help identify materials in carts. Oops cards were sent to residents to explain what materials go in recycling, organics, and garbage per California’s Organics and Recycling Law, Senate Bill (SB) 1383.

Recycles Day

A total of 2,349 customers participated in CVSan’s Recycles Day events to drop off textiles, documents for shredding, and household hazardous waste. CVSan distributed 6,920 bags of compost, which was made partially by materials from CVSan customers’ organics.



Paperless Billing

When a customer switches their ACI bill to paperless billing, a tree is planted! Trees are planted in the ACI forest via Tree-Nation, whose mission is to help companies offset their carbon emissions. A total of 710 CVSan customers made the switch this year!
