DATA DISTRIBUTION

All Digital data is provided for distribution by E-MAIL unless other media is agreed upon. Data distribution shall be requested from the Champaign County Regional Planning Commission (RPC).

NO WARRANTY

The data files are provided "as is". There is no guarantee or warranty concerning the accuracy of information contained in the data. **No warranty is made, either expressed or implied, as to any other matter whatsoever, including, without limitation, the condition of the product, or its fitness for any particular purpose.** The burden for determining fitness for use lies entirely with the user.

LIMITATION OF LIABILITY

In no event shall RPC or any of its member agencies have any liability whatsoever resulting from the use of the RPC data by the Consultant with whom RPC has entered into this License Agreement for payment of any consequential, incidental, indirect, special, or tort damages of any kind, including, but not limited to, any loss of profits arising out of use of or reliance on the data or arising out of the delivery, installation, operation, or user support relating to the same.

PROTECTION OF PROPRIETARY RIGHTS

Reproduction or redistribution of the data or products derived there from outside the Consultant's organization or entity is expressly forbidden.
