- a. Local Entity Written Funding Requests for Fiscal Year 20
 - I. USDA

Requesting funding in the amount of \$24,000 to continue the USDA/Wildlife Services cooperative program in the county. These funds represent approximately 32% of the amount needed to fully fund the position. These local funds are supplemented by other county and federal money 68% to pay salaries and benefits, purchase

equipment and supplies, vehicle, fuel and other expenses. In FY18 they helped protect over \$2.5 million worth of cattle and calves in Cibola County. Services provided include Mexican Wolf monitoring and bird damage management and surveillance for wildlife diseases.

II. NMSU Cibola County Extension Service Program

Requesting funding in the amount of \$62,874 for the operation of the Cibola County

Extension Service program for the 2019-2020 Fiscal Year. They provide master
gardening services, 4-H services, ICAN program and school enrichment programs.

They will also be starting a gardening program at the CoreCivic facility in Milan.

III. Carrot Express

Requesting funding in the amount of \$51,916.69 for public transportation to the unincorporated areas of Cibola County at a more affordable rate. Right now those living outside of the Village of Milan and City of Grants are paying much higher rates. Each year ridership numbers are significantly growing.

IV. Recycle Cibola

Requesting funding in the amount of \$4000 for educational materials. They have developed Recycling plan for the region, helped obtain federal and state funding, obtained a grant from Coca Cola/ keep America Beautiful and helped the community set up Recycling bins. They have also installed recycling receptacles in outdoor venues, helped schools establish recycling programs, worked with local businesses and developed Eco-Brick plastic bottle wall and Ramada for Double Six Gallery. They have also helped the community in many more ways.

V. Economic Development

Requesting funding in the amount of \$20,000 for FY20. They need funding to hire a part time employee. They only have one employee currently to do all the workload. She is now currently working on seven projects right now. Also has six upcoming projects to work on. They will be starting the third year of the Soloworks program. They have taken in 135 people to date and employed 25 people in Cibola County from this program.
