





Hospital Management Lease Agreement

AMENDMENT TO HOSPITAL MANAGEMENT AGREEMENT

THIS AMENDMENT TO THE 2014 HOSPITAL MANAGEMENT AGREEMENT BY AND BETWEEN CIBOLA GENERAL HOSPITAL CORPORATION AND THE COUNTY OF CIBOLA (this "Amendment"), effective January 31, 2019, is by and between the County of Cibola, Board of County Commissioners ("County") and Cibola General Hospital Corporation ("Contractor"). Capitalized terms used in this Amendment and not otherwise defined shall have the meanings ascribed to such terms in the Agreement.

RECITALS

- A. County and Contractor are parties to that certain hospital management contract dated February 1, 2014, (the "Agreement"), pursuant to which Contractor is to, among other things, manage, operate and/or maintain a hospital and health care related facilities, programs and services to further its public mission of sustaining a healthy community by the provision of quality health care services.
- B. The Contract presently provides, in pertinent part, that the term of this Agreement is five years and shall continue through January 31, 2019.
- C. The Contract expressly permits the Contract to be amended by an instrument in writing executed by the parties to the agreement;
 - D. The parties desire to amend the Agreement to increase the contract term.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, the receipt and sufficiency of which are hereby acknowledged, the parties mutually agree as follows:

1. ARTICLE II of the Agreement is hereby replaced in its entirety with the following:

Term.

This Agreement shall be effective January 31, 2019, and shall terminate on March 31, 2019, unless terminated as otherwise provided herein. pursuant to paragraph 4 (Termination) or paragraph 5 (Appropriations). The Contract will not automatically renew, and shall be brought before the Board of County Commissioners for a vote before any extension.

2. Except as otherwise provided in this Amendment, all other terms and provisions of the Agreement shall remain in full force and effect.
