**APPOINTING MEMBERS TO THE COUNTY ROAD REVIEW BOARD**

**WHEREAS**, the Board of Cibola County Commissioners of Cibola County, New Mexico, met at regularly scheduled Commission Meeting on May 27, 2021, at the Cibola County Administration Building, 700 East Roosevelt, Suite 50, Grants, NM 87020; and,

**WHEREAS**, Section 4-37-1 et seq. NMSA 1978 provides that counties may adopt those resolutions and ordinances, not inconsistent with statutory or constitutional limitations placed on counties, to discharge those powers necessary and proper to provide for the safety, preserve the health, promote the prosperity and improve the morals, order, comfort and convenience of the county and its inhabitants; and,

**WHEREAS**, Cibola County Ordinance 82-1 (amended), adopted August 28, 1989, sets forth certain criteria for the County of Cibola to accept the dedication of and maintenance of public roads; and,

**WHEREAS**, Cibola County Ordinance 82-1 (amended) creates a County Road Review Board Consisting of the following individuals:

- a. County Manager
- b. County Road Superintendent
- c. Two (2) County Planning & Zoning Board Members
- d. Two (2) County Commissioners; and,

**WHEREAS**, there is not currently a planning and zoning board as it was disbanded by Ordinance 15-02, nevertheless Ordinance 82-1 (amended) remains in effect and must be read in harmony with other County Ordinances; and,

**WHEREAS**, the Commission believes it to be in the best interest of the inhabitants of the County to Appoint members to the County Road Review Board to perform the duties set forth in Ordinance 82-1 (amended).

**NOW THEREFORE BE IT RESOLVED**, that the following appointments to the Road Review Board are hereby made:
