#### Water Department Monthly Report April, 2025

### **Operations**

1. During monthly operations, the Water Plant remained in compliance with both federal and state water quality and reporting requirements.

2. Distribution systems pressures and flows met the needs of fire supression and consumer needs.

3. Our Distribution Foreman passed pesticide applicator certification and is completing required hands-on testing.

4. Water plant staff members passed entry level water treatment certification and advanced level distribution certification.

5. Cross training between water treatment and distribuion continues.

### **Maintenance and Improvements**

1. Water Plant and Distribution staff performed required maintenance tasks throughout the month.

2. Staff performed tasks at Elkhead Reservoir that included release rate changes for spring runoff.

3. Distribution staff is seeing a sharp rise in requests for utility locates.

## Monthly Report Wastewater April, 2025

## A. Treatment – Operation:

- 1. Operated treatment plant to comply with State and Federal regulations.
- 2. Performed daily, weekly, and monthly maintenance as recommended in the manufacturer's manuals.
- 3. Treated average of 909,000 gallons/day of wastewater.
- 4. Received and treated 9,250 gallons of hauled waste.

# B. Collection – Operation:

- 1. 56 man hours used to perform 112 locates.
- 2. 36 man hours used to hydraulically clean 0.75 miles of sewer main as part of routine (every 5 weeks) maintenance.
- 3. 66.5 hours used to hydraulically clean 4.1 miles of sewer main as part of an annual cleaning program.
- 4. 9 hours used for root treatment in sewer main as part of an annual tree root maintenance program.

# c. Collection – Correction

- 1 man hour used to respond to a backup complaint at 884 Taylor St. Owner said drains were slow. Operator inspected the main and found it to not be flowing well. Operator then hydraulically cleaned the main and encountered an obstruction 60 feet from the manhole. Once the obstruction was cleared, flow returned to normal. No damage was reported to home.
- 2. 1 man hour used to respond to a homeowner's requested for help in removing a tree in her yard at 870 Jeremiah St. Roots were found in her service line by a plumber, and plumber suggested that we might remove the tree for her. Operator suggested woman get in contact with a tree removal business.
- 3. 1 man hour used to respond to a backup complaint at 1400 Sequoia St. Operators inspected the main and found it to be flowing well. Determined to be homeowner's issue.

## D. Other:

- 1. Assisted other departments, local plumbers, and contractors as needed.
- 2. Analyzed Maybell's Wastewater Plant monthly samples.
