Water Department Monthly Report March, 2025

Operations

1. During monthly operations, the Water Plant remained in compliance with both federal and state water quality and reporting requirements.

2. Distribution systems pressures and flows met the needs of fire supression and consumer needs.

3. Our Distribution Foreman passed an "A" Water Treatment certification exam.

4. There was a sharp increase of non-payment shutoffs (13), up from 2 in January and 5 in February.

5. Water Treatment and Distribution staff have begun a cross training program to increase skills, knowledge and abilities.

Maintenance and Improvements

1. Water Plant and Distribution staff performed required maintenance tasks throughout the month.

2. Staff performed tasks at Elkhead Reservoir that included release rate changes for spring runoff, and continued wrap up controls upgrades.

3. Distribution staff repaired a water main break near the intersection of Moffat Drive and Crockett Drive.

Monthly Report Wastewater March, 2025

A. Treatment – Operation:

- 1. Operated treatment plant to comply with State and Federal regulations.
- 2. Performed daily, weekly, and monthly maintenance as recommended in the manufacturer's manuals.
- 3. Treated average of 989,000 gallons/day of wastewater.
- 4. Received and treated 500 gallons of hauled waste.

B. Collection – Operation:

- 1. 33 man hours used to perform 66 locates.
- 2. 36 man hours used to hydraulically clean 0.75 miles of sewer main as part of routine (every 5 weeks) maintenance.
- 3. 31.5 man hours used to hydraulically clean 2.3 miles of sewer main as part of an annual cleaning program.
- 4. 25 man hours used to apply herbicide to tree roots in sewer main as part of an annual tree root maintenance program.

c. Collection – Correction

 3 man hours used to respond to a backup complaint at 404 Taylor St. Owner said water was backing up into basement. Operators inspected the main and found it to not be flowing well. Operators then hydraulically cleaned the main and encountered an obstruction 25 feet from the manhole. Once the obstruction was cleared, flow returned to normal. Business owner was referred to the City Clerk for insurance purposes.

D. Other:

- 1. Assisted other departments, local plumbers, and contractors as needed.
- 2. Analyzed Maybell's Wastewater Plant monthly samples.
