**Subject:** Yampa Building RTU bid award.

The Community Development Department recently solicited bids to install a new rooftop unit (RTU) for the Yampa Building at 775 Yampa Ave.

We requested they quote a 2-ton 14 seer Trane (or equivalent) RTU for cooling only.

We require all contractors interested in the project to attend a mandatory pre-bid meeting. We held the pre-bid meeting on March 19, 2025, with Masterworks Mechanical and a representative from Trane both attending the meeting.

After the meeting, the representative from Trane contacted me and said that due to the smaller size of the project and the travel distance, they would not be bidding on the project.

Below is the only qualifying bid received:

Masterworks Mechanical: 2 Ton Trane RTU, total bid amount \$10,900.

The Yampa Buildings capital budget for 2025 consisted of (2) RTU units with a budgeted amount of \$30,000 for both. So, this unit comes in under the \$15,000 dollars budgeted.

I would recommend to except this bid from Masterworks Mechanical for \$10,900 for a 2 Ton Trane RTU.
