# City of Craig Projects

- ▶ As your representative on the YWG Basin Roundtable I have been able to assist Peter Brixius and Melanie Kilpatrick in obtaining funds for
  - Yampa River Diversion Park \$65,000 (July 2021)
  - The Yampa River Corridor Project \$200,000 (May 2023)
  - Fortification Creek Stage Sensor and Telemetry Project \$10,000 (September 2023)
- ▶ Assist Peter Brixius and City of Craig
  - Yampa River Dashboard Project
  - Used as a source of information on contractors

# Conflicts to meeting more with City Council

- ▶ Council meetings on second Tuesday of month
  - I cannot attend that meeting as I am a member of the Colorado First Conservation District (Treasurer) and they meet on the same day.
  - I also am a member of the Sage-grouse grant working group that meets immediately before the CFCD meeting. (\$3.26M in grant funds to distribute over 5 years)
  - Both these meetings keep me busy from 1:00 pm to nearly 7:00 pm.
