Listed below is an application summary for Dummy and Crane Cocktail Co. LLC dba Dummy and Crane Cocktail Co. LLC.

- 1. Applied for a Tavern License (City) Liquor License on August 1, 2025.
- 2. Applicants for this license are Kirstie McPherson and Tinneal Gerber.
- 3. Address of the premises to be licensed is 406 Yampa Avenue, Craig, CO, 81625. This location is in the same building as another liquor license, however, all requirements for separation of the two licenses have been met.
- 4. All application documents are in order and fees have been paid.
- 5. The Public Notice was posted on site on October 1, 2025, and a Notice of Public Hearing was published in the newspaper on October 1, 2025.
- 6. The sale of liquor on the proposed premises is not a violation of the City of Craig, zoning, building and fire laws or regulations.
- 7. The City of Craig designated the Neighborhood to be within the city limits plus a six-hundred-foot radius and the applicants have satisfactorily presented adequate signatures on the petition to meet the needs of the Neighborhood and the desires of the adult inhabitants of the Neighborhood.
- 8. The background investigation results from the Colorado Bureau of Investigation (CBI) and the Federal Bureau of Investigation (FBI) produced no results which would cause character of the applicants to be part of this hearing.
- 9. The proposed location does not appear to be within 500 feet, as defined in Regulation 47-326 of the Code of Colorado Regulations Liquor and Tobacco Enforcement Division 1CCR 203-2, from any public or private school or the principal campus of any college, university or seminary.
- 10. One of the applicants, Kirstie McPhearson, owns another local liquor license within the City of Craig. Although it is permissible for one individual to own multiple licenses within the State of Colorado, the investigation process to transfer that license to another individual is currently underway.
- 11. Unless the Public Hearing provides evidence to the contrary, there is no reason for denying this application.

Dear Ms. Kirstie McPherson and Ms. Tinneal Gerber,

You are hereby advised that an investigation has been made with regard to your application for a Tavern License (City). Based on the results thereof, the following has been determined:

- 1. The location of the premises for which the license is sought is 406 Yampa Avenue, in Craig, Colorado. The completed application was received on August 1, 2025. This location is in the same building as another liquor license, however, all requirements for separation of the two licenses have been met.
- 2. In the two years preceding the date of the application, there has not been a denial of any liquor license application for the reason that the reasonable requirements of the neighborhood were satisfied by the existing outlets.
- 3. It appears from the application documents that you are entitled to possession of the premises where you propose to exercise the license applied for, and that the possession will continue throughout the initial term of the license, if granted.
- 4. The sale of liquor on the proposed premises is not a violation of the City of Craig zoning, building and fire laws or regulations.
- 5. The proposed location does not appear to be within 500 feet, as defined in Regulation 47-326 of the Code of Colorado Regulations Liquor and Tobacco Enforcement Division 1CCR 203-2, from any public or private school or the principal campus of any college, university or seminary.
- 6. The City of Craig has designated the Neighborhood to be within the city limits plus a six-hundred-foot radius. You, as the applicants, may accept that designation or present alternative evidence to the contrary. You have satisfactorily presented adequate signatures on your petition to meet the needs of the Neighborhood and the desires of the adult inhabitants of the Neighborhood.

- 7. The background investigation results from the Colorado Bureau of Investigation (CBI) and the Federal Bureau of Investigation (FBI) have produced no results which would cause character of the applicants to be part of this investigatory process.
- 8. The Notice of Public Hearing was physically posted at the location on October 1, 2025, and published in the Craig Press on October 1, 2025.
- 9. If the application is approved and license is granted, the State and City licenses will be held in the City Clerk's Office until the building has successfully passed all the necessary City of Craig related inspections for any renovations or improvements currently underway. Verification will be made that all inspections have occurred prior to release of the licenses.

The public hearing on your application has been set for Tuesday, October 14, 2025, beginning at 6:30 or shortly thereafter. The hearing will take place in the City of Craig Council Chambers located at 300 West 4th Street in Craig. At said hearing, you shall have an opportunity to be heard regarding all matters of consideration of your application. Be advised that you, as the applicant, are burdened with persuading City Council, who is the Local Liquor Licensing Authority, that the granting of this license will meet the needs of the Neighborhood and the desires of the adult inhabitants of the Neighborhood.



Bad Alibi Distillery & Dummy and Crane Cocktail Lounge Internal Door Separation and Operating Procedures

September 17, 2025

1. Separation of Licensed Premises

- The interior doors connecting Bad Alibi Distillery and Dummy and Crane Cocktail Lounge will remain unlocked during operating hours as required for ADA access to restrooms and egress/emergency exit doors.
- To ensure clear boundaries, each door will display permanent signage stating:
 - "Licensed Premises Boundary No Alcohol Beyond This Point"
- These signs will be prominently displayed at eye level on both sides of each door with the company name indicating the separated licenses.

2. Staff Training

- Staff at both Bad Alibi Distillery and Dummy and Crane Cocktail Lounge will receive mandatory training covering:
 - The exact licensed boundaries of each business.
 - Rules prohibiting alcohol transfer across license lines.
 - Procedures for preventing patron crossover.
 - Enforcement responsibilities and how to handle violations.
- Training will be completed at onboarding and refreshed annually. Documentation will be maintained.

3. Enforcement of Boundaries

- Patrons found attempting to cross between businesses via the interior doors will be immediately redirected and, if necessary, removed from the premises.
- Employees who violate boundary rules (e.g., transferring alcohol across businesses or allowing unauthorized crossover) will face disciplinary action, up to and including termination.
- · Each business is responsible for monitoring its side of the door during operating hours.

4. Tours and Visitor Entry

- · All distillery tours will begin at the 4th Street entrance to Bad Alibi Distillery.
- Visitors will check in at the 4th Street entrance, not through Dummy and Crane Cocktail Lounge.
- Tours will remain staff-accompanied at all times, with routes restricted to approved areas within the distillery.
- No part of a tour will include access through the cocktail lounge or interior doors.

5. Compliance & Oversight

- Management will ensure interior doors remain unlocked during operating hours, with clear signage posted at all times.
- State and local licensing authorities may inspect the premises and signage to verify compliance.
- Any adjustments required by the inspector will be implemented in a timely fashion.

Statement of Commitment

Bad Alibi Distillery and Dummy and Crane Cocktail Lounge are committed to maintaining strict compliance with Colorado liquor laws while meeting the requirement for unlocked interior doors. Through signage, staff training, and enforcement procedures, we ensure clear separation between licensed premises and protect the integrity of both licenses.




