2. Address of the premises to be licensed is 1111 West Victory Way, Ste. 135, Craig, CO, 81625.
3. All application documents are in order and fees have been paid.
4. The Public Notice was posted on site on July 25, 2025, and a Notice of Public Hearing was published in the newspaper on July 30, 2025.
5. The sale of liquor on the proposed premises is not a violation of the City of Craig, zoning, building and fire laws or regulations.
6. The City of Craig designated the Neighborhood to be within the city limits plus a six-hundred-foot radius and the applicant has satisfactorily presented adequate signatures on the petition to meet the need of the Neighborhood and the desires of the adult inhabitants of the Neighborhood.
7. The background investigation results from the Colorado Bureau of Investigation (CBI) and the Federal Bureau of Investigation (FBI) produced no results which would cause character of the applicant to be part of this hearing.

You are hereby advised that an investigation has been made with regard to your application for a Retail Liquor Store License. Based on the results thereof, the following has been determined:

1. The location of the premises for which the license is sought is 1111 West Victory Way STE. 135 in Craig, Colorado. Completed application was received on June 16, 2025.
2. In the two years preceding the date of the application, there has not been a denial of any liquor license application for the reason that the reasonable requirements of the neighborhood were satisfied by the existing outlets.
3. It appears from the application documents that you are entitled to possession of the premises where you propose to exercise the license applied for, and that the possession will continue throughout the initial term of the license, if granted.
4. The sale of liquor on the proposed premises is not a violation of the City of Craig zoning, building and fire laws or regulations.
5. The proposed location does not appear to be within 500 feet from any public or private school or the principal campus of any college, university or seminary.
6. The City of Craig has designated the Neighborhood to be the city limits plus a six-hundred-foot radius. You, as the applicant, may accept that designation or present alternative evidence. You have satisfactorily presented adequate signatures on your petition to meet the needs of the Neighborhood and the desires of the adult inhabitants of the Neighborhood.
7. The background investigation results from CBI and FBI has produced no results which would cause character of the applicant to be part of this hearing.
8. The Notice of Public Hearing was physically posted at the location on July 25, 2025 and published in the Craig Press on July 30, 2025.

If the application is approved and license is granted, the State and City licenses will be held in the City Clerk's Office until the building has successfully passed all the necessary City of Craig related inspections for any renovations or improvements currently underway. Verification will be made that all inspections have occurred prior to release of the licenses.

The public hearing on your application has been set for Tuesday, August 12, 2025, beginning at 6:30 or shortly thereafter. The hearing will take place in the City of Craig Council Chambers located at 300 West 4th Street in Craig. At said hearing, you shall have an opportunity to be heard regarding all matters of consideration of your application. Be advised that you, as the applicant, are burdened with persuading City Council, who is the Local Liquor Licensing Authority, that the granting of this license will meet the needs of the Neighborhood and the desires of the adult inhabitants of the Neighborhood.
