

**ORDINANCE NO. 1164 (2025)**

**AN ORDINANCE OF THE CITY COUNCIL FOR THE CITY OF CRAIG, COLORADO AMENDING A PORTION OF CHAPTER 3.16 OF THE CRAIG MUNICIPAL CODE CONCERNING SALES TAX TO CHANGE REPORTING PERIOD THRESHOLD AMOUNTS**

WHEREAS, Colorado HB-24-1041 authorized the department of revenue to permit taxpayers that remit sales and use tax to increased filing thresholds;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CRAIG, COLORADO AS FOLLOWS:**

Title 3, Chapters/sections 3.16.070 and noted subsections of those chapters/sections are hereby amended to read as follows:

**3.16.070 Collection, administration and enforcement:**

**D. Reporting Periods**

1. Unless otherwise approved by the city council by resolution, taxpayers must file returns and pay taxes as follows:
  - a. Upon approval of the finance director, a taxpayer whose ~~yearly~~ monthly tax is ~~three hundred dollars (\$300.00)~~ fifteen dollars (\$15.00) or less ~~per month~~ may file returns and pay tax annually. ~~or monthly.~~
  - b. A taxpayer whose tax is less than six hundred dollars (\$600.00) per month may file returns and pay tax quarterly.
  - c. A taxpayer whose ~~yearly~~ monthly tax is ~~more than three hundred dollars (\$300.00)~~ six hundred dollars (\$600.00) or more ~~per month~~ shall file returns and pay tax monthly.
