

Date: February 4th, 2025 To: City Council and Administration From: Carl R. Ray, Water and Wastewater Director Re: Award Recommendation for 2025 Raw Water Control Valve

The Yampa River Corridor Project replaced the original diversion structure with three new instream structures. Structure #1 is over 1.5 feet higher in elevation that the previous structure. The vertical elevation increase affected the surface water elevation under all conditions. The new structures are beneficial during late summer and into fall and provide increased surface water elevation of approximately 6" according to the hydraulic model. We did not see a hydraulic model for high flow conditions, but physical observations in the Spring of 2024 showed a large increase in surface water elevation.

The increased surface water elevation led to the following three issues at the Water Treatment Plant: 1. Localized Flooding 2. Increased pressure in the raw water pipeline which in turn effectively decrease the system head and could lead to damage of the raw water pumps 3. The backwash ponds, which are connected to the raw water pipeline, would fill with river water unless isolated by valves which in turn prevented filter backwash or created difficulty performing the backwash without flooding. In a high snowpack year, it may be impossible to backwash filters which would effectively prevent us from operating the Water Treatment Plant.

We entertained several solutions to the increased surface water elevation and determined the be approach to be installation of a raw water control valve in the pipeline coming from the river. We asked council for an appropriation to install a raw water control valve in November of 2024 in the amount of \$270,020 and the resolution was passed. We applied for and are receiving an award in the amount of \$50,000 from the Department of Local Affairs (DOLA) Energy Impact and Mineral Assistance Fund (EIAF).

Advertisement for bids was published started on February 17th, 2025. We conducted a mandatory pre-bid meeting was held on February 24th, 2025 to review the project and answer questions. Questions and concerns were addressed in addenda. The bid was broken up into four items. Bids were opened at 14:00 on March 5th, 2025. Bids were received from X-Field Services, Fones Construction, and Anson Excavating and Pipe.

The bids were reviewed and recommendation made by SGM for Anson Excavating and Pipe in the \$239,700.00. Our recommendation is in agreement with SGM's recommendation. The following bid tab summarizes the bids received:

The City received three bids on March 5, 2025, for the *Raw Water Control Vault* project. This project will create critical operational control of the raw water feed to the water plant that doesn't presently exist during runoff. The bids received were:

Xfield Services	\$ 254,600

Anson Excavating	\$ 239,700

The low bid received is within the construction estimate. We consequently recommend award to the low bidder, Anson Excavating.

Bid Qualifications: :

As simple as this project sound, just installing a manhole & valve, we would like to explain our bid & price.

Due to the location of the project and its proximity to the running river & the depth of the hole, we are anticipating increase ground water and unsuitable soils. We have in our bid to rent a special trench box to not only help with the ground situation but also stay within the timeframe of a 48-hour window to install the valve with the water to the City turned off. We also feel that our rented trench box will help ensure a sturdy foundation for the Crane that must be used to set the large manhole & manhole. This rented Trench Box is going to raise our bid amount but ensures safety and completion of the project in a timely manner.

We would like to state that delivery of the exact specified valve & fitting (24" Dezurik PEC plug valve with IP68 rated 480V ROTORK 1QTM500FAID modulating Electric Actuator with MODBUS 110/1/60. For Modulating service, OAE) needed for the project is projected to be a 30 week delivery period & cannot fit into substantial completion of May 1st, 2025. There is no acceptable alternatives for theses parts that can be obtained within the contract parameters. (ho actuator for 5000 valve) To ensure that we get the exact specified valve and fittings, we would expect that after being awarded the bid, we would need no less than a 30 week delivery time before starting the project. We would also like to stage all materials on site 2 days prior to the project beginning to ensure that we can move through the project smoothly & within time parameters.

Anson Excavating is able to do this project with proposed material delivery specified. Please see attached bid and delivery proposal. And proposed construction schedule based on delivery of Dezurick value.

 - i. At this point in time, the Substantial Completion Date will remain as May 1st, due the plant's issues in operating during the Yampa River's high water period. Historically, the high water period starts late April to late May. Flooding of the access road to the influent manholes will occur during the high water period.
 - ii. If any construction critical to valve/vault installation, is hindered by material delivery dates with procurement within 48 hrs of contract execution, so that work can not be completed prior to the highwater period, immediate coordination with the Engineer and City is required.
- 16. What waterproofing is necessary?
 - i. At minimum the Contractor is to provide double ram neck. The City and Engineer are discussing potential for additional external waterproofing around manhole joints. Further clarification to be provided in Addendum #2.

- 6. When are questions due by?
 - i. All questions are due by 2/28/2025,
- 7. Is there Geotech information available for this project area?
 - i. No.
- 8. Can spoils be disposed of onsite?
 - i. Yes, project spoils can be disposed of onsite. Contractor shall coordinate location of spoils pile with City staff.
