Dear Members of the City Council,

On January 8th, 2025, we opened bids for the Hybrid Cloud Security System Upgrade project. Unfortunately, we only received one bid, submitted by **Colorado Doorways**, in the amount of **\$58,142**. This bid exceeds our original budget allocation for the project, which was set at **\$55,000**.

Despite the bid exceeding the budget by \$3,142, Colorado Doorways is a reputable vendor and their bid may reflect the necessary cost to meet our project requirements.

The system quoted in this bid is the same system that is installed at Water and Wastewater plants. There is potential for integration. The security camera portion has features that would benefit the city such as cloud access and AI smart search.

6. Excludes 120VAC hook up.

7. Includes up to a two-hour training of personnel for software/programming/operation of this system upon completion of job.

8. Includes basic programming of up to (50) users, creation of user/access groups, bulk enrollment of credentials, auto unlock/lock schedules, and event notifications. Any programming above and beyond will require a change order and/or factory services.

9. Excludes through-structure wire pathways (pre-cast, drywall, concrete, brick, floors/subfloors, and underground).
