1. *Crime and Patrol Summary*

See attachments. The department responded to 882 requests for service during the month of November. Community Service responded to 85 requests for service.

This month we saw a change in weather. The snow we received made the roads and parking lots slick. We saw an increase of traffic crashes that we investigated. Two of the accidents we handled were hit and runs involving pedestrians. Both of the pedestrians were injured. Both of these cases are still under investigation.

Several arrests were made for narcotics violations, thefts and DUIs. We also arrested several people for warrants. Most of these arrests were for individuals that did not show up for court or did not comply with the orders of the court. While arresting some of the individuals, they were found to have illegal items on their person and received additional charges.


