CITY COUNCIL MEETING JANUARY 08, 2019 MINUTES

Mayor John Ponikvar brought to order at 6:30 p.m. the first regular meeting of the Craig City Council for the month of January 2019. In addition to Mayor Ponikvar, those present were Councilmembers Chris Nichols, Andrea Camp, Derek Duran, Jarrod Ogden and Tony Bohrer. Joe Bird was absent.
