Dear Mr. Aylor,

You are hereby advised that an investigation has been made with regard to your application for a Brewpub liquor license. Based on the results thereof, the following has been determined:

1. The location of the premises for which the license is sought is 576 Yampa Avenue in Craig, Colorado. Application was received on December 6, 2018.
2. In the two years preceding the date of the application, there has not been a denial of any liquor license application for the reason that the reasonable requirements of the neighborhood were satisfied by the existing outlets.
3. It appears from the application documents that you are entitled to possession of the premises where you propose to exercise the license applied for, and that the possession will continue throughout the initial term of the license, if granted.
4. The sale of liquor on the proposed premises is not a violation of the City of Craig zoning, building and fire laws or regulations.
5. The proposed location does not appear to be within 500 feet from any public or private school or the principal campus of any college, university or seminary.
6. The City of Craig has designated the Neighborhood to be the city limits plus a six hundred foot radius. You, as the applicant, may accept that designation or present alternative evidence.
7. The background investigation results from CBI and FBI has produced no results which would cause character of the applicant to be part of this hearing.

The public hearing on your application has been set for Tuesday, January 8, 2019 beginning at 6:30 or shortly thereafter. The hearing will take place in the City of Craig council chambers located at 300 West 4th Street in Craig. At said hearing, you shall have an opportunity to be heard regarding all

matters of consideration of your application. Be advised that you, as the applicant, are burdened with persuading City Council, who is the Local Liquor Licensing Authority, that the granting of this license will meet the need of the neighborhoods and the desires of the adult inhabitants of the neighborhood.
