Re: Process Turbidimeters Phase 2 Bid/Quote Award Recommendation

This memo is to recommend that the city council award "phase 2" of the water plant's process turbidimeters replacement program to Ambient H2O for \$4,689.50/turbidimeter, which includes some accessories and startup costs, for a total cost of \$37,516.00. The city council approved \$45,000.00 in the 2019 O&M budget to complete phase 2 of the process turbidimeters replacement program. There are a total of 14 process turbidimeters that needed replaced, and the staff replaced 6 turbidimeters at the end of 2018 (phase 1), and the remaining 8 turbidimeters (phase 2) are scheduled to be replaced in 2019. Ambient H2O agreed to hold the price per turbidimeter from their 2018 quote until January 31, 2019. The staff feels that since they were the low bidder that met our specifications in November 2018, and are holding their pricing at the same level, it would be in the city's best interest to purchase the remaining 8 (Lovibond PTV 2000) process turbidimeters from them. This way the city has the same consistency of equipment, and would only need spare parts and calibration equipment from one manufacturer.

My recommendation is to award phase 2 of the "process turbidimeters replacement program" to Ambient H2O with the bid/quote of \$ 37,516.00 for eight (8) Red LED Lovibond PTV 2000 process turbidimeters. I have included below the quote we received in 2018, and an updated comparison bid tab for your review. Thank you in advance for considering this request.
