- 1. Crime and Patrol Summary

See attachments. The department responded to 944 requests for service during the month of January. Community Service responded to 94 requests for service.

Most of the thefts from vehicles can be classified as crimes of opportunity. All most all of the reported thefts were from vehicles that were not locked and valuable items were left inside the vehicle. In one case, there was a small amount of cash taken and another case a firearm was taken from an unlocked vehicle. There were other vehicles that were entered, but nothing was taken.

On a side note, 18 individuals were arrested for warrants this month alone.

One day this month, officers responded to three assists with ambulance calls for service. Normally, we are able to arrive before the ambulance to provide aid. The three calls were for people who slipped on an icy or snow covered surface. The officers were able to provide aid prior to the arrival of medical care.
