- 4. **Cherry Hills Village**-Installing TeamViewer on laptops to be able to work remotely if needed. Haven't shut down city hall yet. Cancelled municipal court until mid-April and all march council meetings.
- 5. **Town of Mount Crested Butte**-Closed down to the public but staff will be at town hall conducting business via telephone or email.
