ORDINANCE NO. 1109 (2020)

A SUPPLEMENTAL APPROPRIATION ORDINANCE TO APPROPRIATE FUNDS FOR THE OPERATIONS AND MAINTENANCE OF THE YAMPA BUILDING IN THE GENERAL FUND FOR THE 2020 BUDGET YEAR

WHEREAS, the City Council has adopted the 2020 Annual Appropriation Ordinance #1107and a Supplemental Appropriation Ordinance #1107; and

WHEREAS, the Moffat County School District RE-1 Board of Education passed a Resolution approving a Quitclaim Deed to the City of Craig for the "Yampa Property" located at 775 Yampa Avenue in Craig; and

WHEREAS, the City Council approved Resolution #6 to move forward toward the acquisition of the Yampa Building from the Moffat County School District RE-1; and

WHEREAS, the City Council approved Resolution #9 to enter into an IGA concerning the acquisition of the Yampa Building with the Moffat County School District RE-1; and

WHEREAS, the City Council approved Resolution #10 for a Master Lease Agreement with the Chamber of Commerce for the Yampa Building; and

WHEREAS, the City Council is desirous to modify and amend the 2020 Budget to provide appropriated funds for the operations and maintenance of the Yampa Property.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CRAIG, COLORADO, AS FOLLOWS:

Section 1. <u>RECOGNITION OF ADDITIONAL REVENUES</u>. There will be collections of rents and donations in the amount of \$57,250 that will be appropriated and be made available for said purposes.

Section 2. <u>SPECIFIC ACCOUNT MODIFICATIONS</u>. That the Budget, as adopted in the 2020 Annual Appropriation Ordinance and the 2020 Supplemental Appropriation Ordinance, shall be amended as follows:
