1. *Crime and Patrol Summary*

See attachments. The department responded to 1,145 requests for service during the month of May. Community Service responded to 138 requests for service.

As you are all aware, the graduation ceremony for the Class of 2020 was totally different than in years past. I want to thank the following entities that made this a successful and safe event for the Senior Class: City of Craig Road and Bridge crew, Moffat County Sheriff's Office, Colorado State Patrol, Moffat County School District employees and members of the Craig Police Department.

Officer Bobby Adler successfully completed his Field Training Program in the middle of May. He is currently assigned to the patrol division. We are hoping to send him to training during the summer months so he will be ready to start his duties as a School Resource Officer in the fall.

"Bane" our new K-9, has been transferred to Officer Laehr. Bane has been riding with Officer Laehr the last couple of weeks to become accustomed to Officer Laehr and his patrol vehicle. Bane will be state certified in the detection of illegal narcotics in the near future and will soon start his new role for our department.

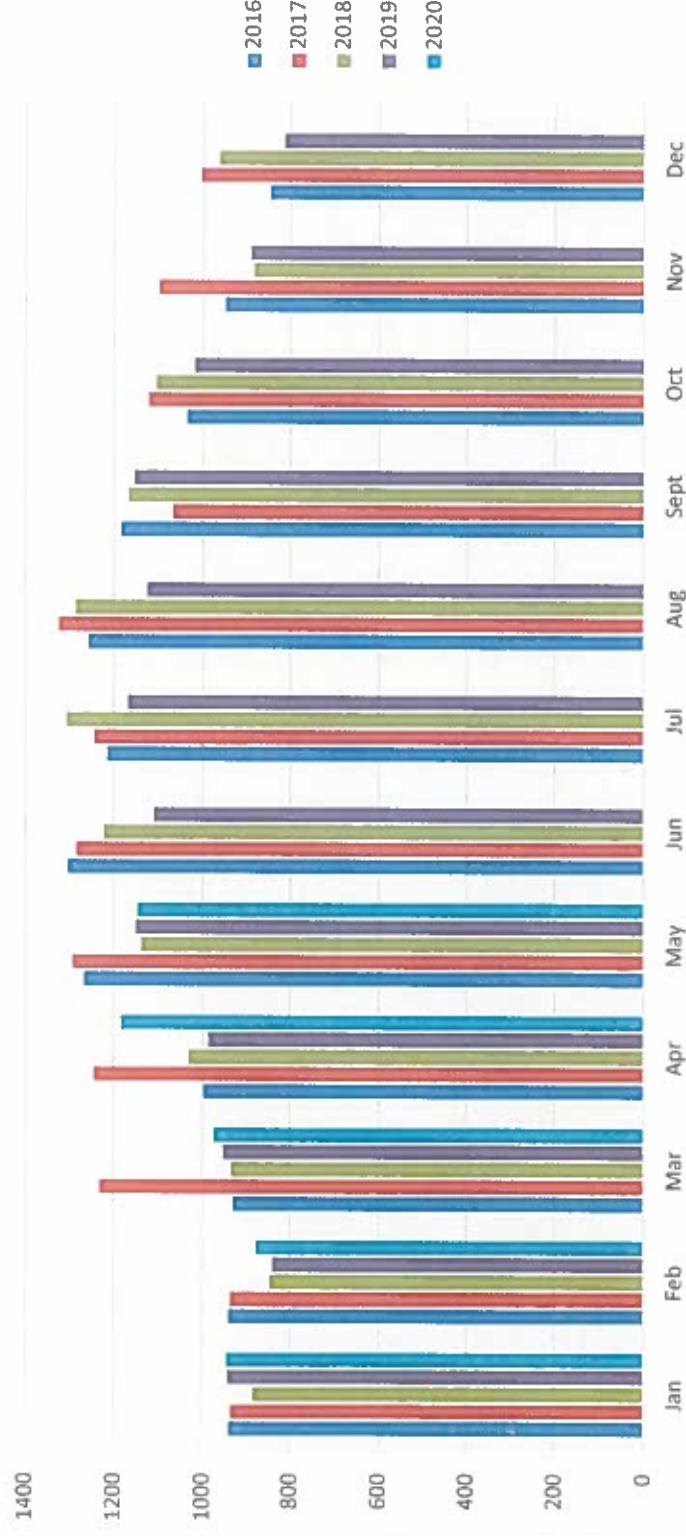
